2. Item 4.1 - Councillor Robert Simms - Motion on Notice - Park Lands Foundation [2019/00464] [APLA]

Moved by Councillor Robert Simms, Seconded by Councillor Anne Moran - That the Adelaide Park Lands Authority:

Requests the Executive Officer to explore the feasibility of establishing a Park Lands foundation to secure philanthropic and other funds to support the:

- Research, understanding and purpose of the Park Lands
- Enhancement of the Park Lands

Noting and addressing:

- The requirements and process regarding establishment and achieving tax deductibility status
- Required set-up costs
- The need for a high-profile patron and foundation membership
- Means for generating donations
- The need for continuity and a long-term plan
- What makes a successful Foundation
- The benefit of pursuing a separate foundation and tax-deductibility compared with the available mechanism of the Adelaide Park Lands Fund.

Discussion ensued during which with the consent of the mover, seconder and Board meeting the first line of the motion was varied to include the words 'or other mechanisms' after the word 'foundation'.

Questions without Notice / Motions without Notice

3. Item 5 – Councillor Phillip Martin – Motion without Notice – February 2019 Request for Legal Implications Advice [2007/00341] [APLA]

Moved by Councillor Phillip Martin, Seconded by Councillor Anne Moran -

That APLA:

Conveys to the CEO its disappointment that the City of Adelaide denied the legal advice the Authority requested in relation to the proposed Adelaide Oval Hotel development on the Park Lands in order to perform its role and requests;

- i) Council reconsiders its position in the context of the Park Lands Act 2005 which sets the obligations to fund investigations by the Authority
- ii) Provides to members before the Authority's next meeting the legal advice Council has received and which may also assist the Authority

Councillor Phillip Martin tabled correspondence from the City of Adelaide Chief Executive Officer to the Executive Officer of the Board responding to the Adelaide Park Lands Authority request for funding to engage legal counsel in relation to the proposed Adelaide Oval hotel redevelopment.

Ms Kirsteen Mackay disclosed a material conflict of interest in Item 5, pursuant to Section 4.3 of the *Adelaide Park Lands Authority Charter* and Sections 73 & 74 of the *Local Government Act 1999 (SA)*, arising from having been involved in the matter through the provision of advice in relation to the Adelaide Oval Hotel, left the meeting room at 5.48 pm and did not participate or contribute to the deliberations of the Adelaide Park Lands Authority on this matter.

Discussion ensued during which:

• With the consent of the mover, seconder and Board meeting the motion was varied to read as follows:

'That APLA:

Notes the letter from the CEO in relation to the legal advice that the Authority requested in relation to the proposed Adelaide Oval Hotel development on the Park Lands in order to perform its role and requests;

- i) Council reconsiders its position in the context of the Park Lands Act 2005 to fund investigations by the Authority; and
- ii) Provides to members before the Authority's next meeting the legal advice Council has received and which may also assist the Authority.'

 The Board noted that the Executive Officer would liaise with Council to investigate the release of legal advice from Council.

- Reject the Whitmore Square Master Plan and identify reasons for the Authority to reject the Master Plan including the vision, principles, Actions and Overall Plan.
- Request funding available in 2018-2019 be expended on the extremely high priority North-East Zebra
 Crossing and display an Australian Road Rules diagram in support of a zebra crossing over two lanes of
 vehicle traffic.

RE Adelaide Park Lands Authority - Request for Funding

Thank you for your letter of 12 March 2019 requesting the provision of funds by the City of Adelaide for the Adelaide Park Lands Authority ("Authority") to engage legal counsel in relation to the proposed Adelaide Oval hotel redevelopment.

The City of Adelaide has many concerns with the project to develop a hotel at Adelaide Oval and has obtained legal advice to understand the implications of the proposed development. The legal advice obtained is confidential and subject to legal professional privilege. In the context of managing resources effectively and efficiently, the City of Adelaide currently does not support incurring additional legal expenditure through the Authority and possible duplication of legal work for this matter.

The City of Adelaide wishes to reassure the Authority that it has considered different streams of legal advice and arrived at an informed decision in relation to this matter and possible legal avenues.


Australian Road Rules-8.12.2016

Part 7—Giving way


Division 5—Crossings and shared zones

Examples—

Example 1
Giving way to a pedestrian on a pedestrian



Example 2
Giving way to a pedestrian on a pedestrian crossing at a slip lane



In each of these examples, the driver must give way to the pedestrian on the crossing.

82—Overtaking or passing a vehicle at a children's crossing or pedestrian crossing

A driver approaching a children's crossing, or pedestrian crossing, must not overtake or pass a vehicle that is travelling in the same direction as the driver and is stopping, or has stopped, to give way to a pedestrian at the crossing.


Offence provision.

Note-

Children's crossing is defined in rule 80, overtake is defined in the dictionary, and pedestrian crossing is defined in rule 81.

Example---

Driver not passing a vehicle that has stopped to give way to a pedestrian at a pedestrian crossing



In the example, vehicle A has stopped to give way to a pedestrian on the crossing. Vehicle B must not overtake or pass vehicle A.
