The Presiding Member, Lord Mayor Sandy Verschoor, invited Mr Damien Mugavin to address the Board and confirmed receipt of the content of his address prior to the meeting.

Mr Damien Mugavin addressed the Board:

• Regarding the Board's statutory functions and the unacceptable situation, considering the legislated function of APLA and the requirements of the Local Government Act, that APLA has not had an opportunity to see or comment on the substance of the Denise Norton Park / Pardinpardinyilla (Park 2) proposal by the Adelaide Football Club.

• Seeking examination of the Denise Norton Park / Pardinpardinyilla (Park 2) proposal of the Adelaide Football Club by APLA on its own initiative as a matter of urgency.

The Presiding Member, Lord Mayor Sandy Verschoor, thanked Mr Damien Mugavin for his Deputation and clarified for the Board that:

3. Item 6 – Ms Stephanie Johnston – Motion without Notice – Adelaide Football Club's Unsolicited Proposal [2019/01387] [APLA]

Moved by Ms Stephanie Johnston, Seconded by Ms Allison Bretones -

In the light of media coverage and community concern around the council administration's ongoing process for consideration of the Adelaide Football Club's unsolicited proposal to build its administration headquarters on public park land, that APLA request a full briefing from the administration on the nature of any AFC concept proposals received to date, the process that was undertaken for the establishment of the current 'guiding principles' that appear on council's website, and the relationships between the council's decision to accept the unsolicited proposal without consulting APLA, and the statutory requirements of the Adelaide Park Lands Act and the Local Government Act.

Discussion ensued during which with the consent of the mover, seconder and the meeting the motion was varied to read as follows:

'That APLA request a full briefing from the administration on the nature of any AFC concept proposals received to date, the process that was undertaken for the establishment of the current 'guiding principles' that appear on council's website, and the relationships between the council's decision to accept the unsolicited proposal without consulting APLA, and the statutory requirements of the Adelaide Park Lands Act and the Local Government Act.'

Presiding Member Verbal Reports

4. Item 4 - Presiding Member Verbal Report – Adelaide Park Lands and City Layout World Heritage Nomination Committee - Progress Report [2018/02875] [APLA]

The Presiding Member, Lord Mayor Sandy Verschoor, addressed the Board to table and provide an update on the progress made by the committee established by the Board to explore the possibility of World Heritage Listing for the Adelaide Park Lands and City Layout, as follows:

- The committee has met twice, most recently, on Monday this week.
- In the Board's 19/20 Business Plan and Budget \$100k in funding was sought from Council to support the work of this committee. A proviso was added that the State Government would be approached for a \$50k contribution and that if this was forthcoming, Council's contribution could be reduced to \$50k.
- In the absence of a response from the State, staff met with officers from the Department of Environment & Water to determine whether the Government were supportive of a bid for World Heritage for the Adelaide Park Lands and City Layout. We were advised that:
 - The State has been co-operating with the current bid by the consortium of Adelaide Hills Councils exploring the viability of World Heritage listing for the settlement landscapes of the Mt Lofty Ranges
 - That bid has changed over the last seven years from one focussed on the agrarian landscapes of the Ranges to one focussed on the legacy of the systematic colonisation of South Australia
 - The State sees an overlap between the proposed nominations for Mt Lofty Ranges and the Adelaide Park Lands & City Layout

- In light of that, it is not prepared to support two related World Heritage nominations and would like the relationship between them explored and reconciled.
- The overlap stems from the foundation of South Australia through the South Australia Act of 1834, which was based on the Systematic Colonisation model developed by Edward Gibbon Wakefield. The colonisation process began with the establishment of the City (including the sale of Town Acres tied to the sale of rural acres) and then progressed to the settlement of the hinterland areas. It was all part of one continuous process and so there is indeed an inextricable link between the two bids.
- A recent expert review of the Mt Lofty bid concluded that there is a solid basis or rationale for the nomination but that a lot more detailed work needs undertaking around the justification and site identification.
- An officer level meeting was also recently held with the Adelaide Hills Council who indicated that based on the conclusions of the expert review and the interest shown by Adelaide in a nomination based on the City Plan, that they were prepared to work with us to explore the potential synergies between the two possible bids.
- On Monday, the Committee agreed that a worthwhile next step, to inform future discussions with the Mt Lofty Ranges consortium, would be to engage the assistance of the same two experts who undertook the assessment of the Mt Lofty Ranges bid.
- This assessment would explore the:
 - Rationale and justification for a World Heritage listing bid based around the systematic colonisation of South Australia either as a
 - City Plan based bid alone, or
 - A more broadly-based bid which <u>either references or includes</u> the settlement landscapes of the Mt Lofty Ranges
 - Strengths (and weaknesses) of a City only nomination (ie a better understanding of the stand-alone Values of the Adelaide Plan
 - Synergies between the two possible bids
 - The cost estimate for this body of work is in the vicinity of \$10 to \$15k.

Thank you for the opportunity to address APLA regarding its statutory functions.

So far, APLA is 'unaware' of the proposed takeover of Denise Norton Park / Pardinpardinyilla (Park 2) by Adelaide Football Club: APLA has not had an opportunity to see the substance of the proposal nor to comment on it.

This situation is unacceptable, considering the legislated functions of APLA and the requirements of the Local Government Act.

1. Functions of APLA as listed in the Adelaide Park Lands Act

The functions of APLA are laid out in the Act. They include:

to undertake a <u>key policy role with respect to the management and</u> protection of the Adelaide Park Lands;

Other functions are mentioned below however I won't read out all of them, except as highlighted below:

to prepare and to revise and provide comments on the the Adelaide Park Lands Management Strategy and to monitor its implementation; to provide comments or advice in relation to the operation of any lease, licence or other form of grant; on the basis of any request or <u>on its own initiative</u>, to provide advice to the Adelaide City Council or to the Minister on policy, development, heritage or management issues affecting the Adelaide Park Lands; to <u>promote</u> <u>public awareness</u> of the importance of the Adelaide Park Lands and the need to ensure that they are managed and used responsibly; <u>to ensure that the</u> <u>interests of South Australians are taken into account, and that community</u> <u>consultation processes are established, in relation to the strategic</u> <u>management of the Adelaide Park Lands</u>; to administer the Adelaide Park Lands Fund; to undertake or support other <u>activities that will protect or</u> <u>enhance the Adelaide Park Lands</u>, or in any other way promote or advance the objects of this Act.

It should also be noted that the ACC 'Unsolicited Proposals' policy which is being used by Council as a stalking horse to progress this proposal, includes a provision that the Adelaide Park Lands Authority (APLA) must scrutinise any proposal.

2. Local Government Act and the Park Lands

May I also ask APLA to note that under the Local Government Act, the classification of the Adelaide Park Lands as community land cannot be revoked unless the revocation is by force of a provision of another Act. The Adelaide City Council must

(i) provide information on any arrangements or restrictions on public use of any part of the park lands, or on movement through the park lands;

Other provisions of the Act are mentioned below however I won't read out all of them, except as highlighted below:

(ii) provide specific information on the council's policies for the granting of leases or licences over any part of the park lands.

(2) A council may only adopt a proposal for amendment to, or revocation of, a management plan after the council has carried out the public consultation that would be required if the proposal were for a new management plan.

(2) Before the council grants a lease or licence relating to community land, it must follow the relevant steps set out in its public consultation policy.

(6) A lease or licence must be consistent with any relevant management plan

3. None of these provisions have been met.

The proposal by the Adelaide Crows Football Club to take over Denise Norton Park / Pardinpardinyilla (Park 2) needs to be examined by APLA on its own initiative as a matter of urgency so that any decision by council is not *Ultra Vires*. Almost certainly as individuals, each of you has heard about this proposal however this issue has not been brought before APLA for consideration.

Project Background


Quentin Kenihan was a disability advocate, actor, film maker and writer born with the bone disease osteogenesis imperfecta.



Key reasons for the playspace's location and planning:

- Orientated to reduce slope profiles (works with the contours) and increases access pathways
- Highly visible to the north, south and west
- Activity zones set outside root zones of existing trees (shown in green on plan)
- Capitalises on the natural shade of existing trees
- Provides dual entry points to the north and south (response to event overlays)
- Provides opportunities for 'accessible parking' and coaster bus drop off to Rundle and Bartels', as well as the existing accessible parks in the off-street car park
- Potential to locate active play near to the blank wall of the bowling club (reducing conflicts with the greens)
- A gradient of play (north-south) that capitalises on existing trees to the north and open space to the south
- Potential for passive open space edge to the west with seating and picnic areas (boundary to the playspace)
- Potential for a secure boundary to the natural play area/low challenge with a more permeable boundary to the south (capitalising on separation distances to Bartels and the lake)
- Potential for internalised seating and observation points to increase surveillance

OPPORTUNTIES

- (1) A gradient of play, challenge and risk across the playspace
 - Nature play capitalising on treed setting and shade with a focus on younger, quieter play
- (\mathbf{s}) Defined edge with play nodes and viewing offering prospect and refuge and clear surveillance across the playspace
- (4) Water play providing a strong experiential environment with visual connections to the lake and potential Kaurna narratives
- (**5**) Active play with greater challenge and physical activity
- (6) Entrance and active play creating a unique sense of arrival with strong connections to the existing footpath network
 - Picnic area, shaded seating and open space creating informal breakout spaces to entire edge of playspace (somewhere for everyone)
- (8) Secure boundary with fencing and gated or maze entrances
 - Open boundary using distance as separation to roads and lake and deterrent
- (10) Potential access points to Bowling Club





QKIP considerations

Key project considerations:

- Budget
- Ensuring DDA compliant paths
- On-street parking changes
- Off-street parking changes
- Bus drop off area.

Fencing/boundary treatment:

- Full perimter fencing is strongly recommended for inclusive playspaces
- Fencing/boundary treatment to minimise the impact on Rymill Park look and feel
- Design alternatives to traditional playspace fencing being considered such as integrated plantings, level changes and materiality of boundary treatment to add to play value and complement the park setting.




QKIP considerations

Toilet block renewal:

- Current building is structurally unsound
- Existing interior difficult to retrofit to accommodate DDA compliant toilet facilities, including an accredited Changing Places (adult change facility)
- Existing path access to current location is not DDA compliant
- Existing building location could impact design of new playspace
- Could incoprorate stone from existing toilet building into new structure (eg cladding) or playspace
- Will work with proposed Park Lands Building Design Guidelines for new toilet building likely Exeloo facility similar to Mashmallow Playspace.



Renewal SA, on behalf of the South Australian Government, has undertaken extensive investigations and master planning processes to determine key development directions for Lot Fourteen.

The Lot Fourteen (old Royal Adelaide Hospital) Innovation Area Development Plan Amendment (DPA) has now been drafted to provide the planning policy framework that will guide the development of the site, in alignment with the core directions of The 30-Year Plan for Greater Adelaide.

What is a Development Plan Amendment?

Development plans contain the planning controls that guide what can and cannot be developed in council areas. Planning authorities use these planning controls to assess new development proposals.

The Adelaide (City) Development Plan, which provides the policy framework for development in the area, limits development on the site to hospital-related activities, thereby restricting other land uses.

A Development Plan Amendment (DPA) process is therefore

The 30-Year Plan for Greater Adelaide seeks to:

- strengthen the primacy of the Adelaide city centre as the cultural, entertainment, tourism and economic focus of Greater Adelaide

- preserve and adapt heritage and character for its long term value
- enhance the street network to support the movement of people, business and community activity
- introduce appropriate zoning for the old Royal Adelaide Hospital site that stimulates investment in the east end of Adelaide and ensures appropriate interface with the Adelaide Botanic Gardens.

required to change the policy framework to enable a diversification of activities. As this DPA is being prepared by the Minister for Planning it is known as a Ministerial DPA.

Proposed Amendments

The DPA describes the proposed changes to the Adelaide (City) Development Plan development plan.

This DPA proposes to introduce a new *Mixed Use (Innovation) Zone* to reflect the specialist nature of the proposed developments and unique characteristics of the site.

The proposed policy framework includes:

- primary focus on innovative education, science, research and technology-based businesses that can take link with the adjacent education and commercial precincts
- cultural facilities, including a major Aboriginal art and cultures centre that extends the role of North Terrace as Adelaide's 'cultural boulevard'

ommunity information

- a diversity of landscaped open space and public realm opportunities, connected by a network of pedestrian and bicycle pathways that link to the adjacent Adelaide Botanic Garden, Park Lands and other off-site destinations
- a range of secondary activities including tourist accommodation, hospitality, entertainment and some retail that complement the role of Lot Fourteen as an outstanding destination.

The DPA proposes high intensity development that reflects the adjacent established developments but transitions down to lower scale buildings that incorporates increasing amounts of open space and appropriately interfaces with the Adelaide Botanic Garden and Park Lands.


