#### 6. Item 9.1 – Response to Park 2 AFC Proposal [APLA]

Moved by Professor Emeritus Damien Mugavin, Seconded by Mr Stephen Forbes -

#### THAT THE ADELAIDE PARK LANDS AUTHORITY ADVISES COUNCIL

That the Adelaide Park Lands Authority provides the following-input on the Adelaide Football Club (AFC) proposal released for consultation in December 2019 for a combined training, administrative, community and aquatic facility in Denise Norton Park / Pardipardinyilla (Park 2), in accordance with the Adelaide Parklands Act 2005:

- 1. The extent of the proposed AFC training, administrative and commercial components appears potentially inconsistent with the Statutory Principles in the Adelaide Park Lands Act 2005 (SA) (particularly that the Park Lands exist for the public benefit of the people of South Australia) and the provisions of the Adelaide Park Lands Management Strategy that support use of the Park Lands for community outdoor recreation and ancillary infrastructure, but not large-scale commercial facilities. Council might seek specific legal advice about this.
- 2. Recommends an Environment Protection and Biodiversity Conservation (EBPC) Act self-assessment and referral process in regard to any possible effect on the values which underpin the National Heritage Listing of the Adelaide Park Lands and City Layout.
- 3. Recommends that the Guiding Principles established by City of Adelaide to assess the AFC proposal need amendment to specifically incorporate and fully reflect the Statutory Principles in the Adelaide Park Lands Act 2005 (SA) and requirements of the Local Government Act 1999 (SA) along with the policy provisions in the Adelaide Park Lands Management Strategy, the Community Land Management Plan and the relevant provisions of the existing City of Adelaide Development Plan.
- 4. Recommends Council consider alternative options for Denise Norton Park/ Pardipardinyilla (Park 2) that might align better with its own policies, statutory obligations and community expectations for a fit-for-purpose aquatic centre.
- 5. Recommends that Council consider its general rights to withdraw from the unsolicited proposals process.

- 3. Recommends an Environment Protection and Biodiversity Conservation (EBPC) Act self-assessment and referral process in regard to any possible effect on the values which underpin the National Heritage Listing of the Adelaide Park Lands and City Layout.
- 4. Recommends that the Guiding Principles established by City of Adelaide to assess the AFC proposal need amendment to specifically incorporate and fully reflect the Statutory Principles in the Adelaide Park Lands Act 2005 (SA) and requirements of the Local Government Act 1999 (SA) along with the policy provisions in the Adelaide Park Lands Management Strategy, the Community Land Management Plan and the relevant provisions of the existing City of Adelaide Development Plan.
- 5. Recommends Council consider alternative options for Denise Norton Park/ Pardipardinyilla (Park 2) that might align better with its own policies, statutory obligations and community expectations for a fit-for-purpose aquatic centre.

#### 7. Item 9.2 - Submission to the Planning and Design Code consultation [2019/00626] [APLA]

Deputy Presiding Member, Ms Kirsteen Mackay disclosed an actual conflict of interest in the Submission to the Planning and Design Code consultation, pursuant to Section 4.7 of the *Adelaide Park Lands Authority Charter* and Sections 75 & 75A of the *Local Government Act 1999 (SA)*, arising from sitting on the Governance Committee for the entire planning reform program within the Department of Planning Transport & Infrastructure, left the meeting room at 7.12 pm and did not participate or contribute to the deliberations of the Adelaide Park Lands Authority on this matter.

Discussion ensued during which the Board noted that Mr Rick Hutchins Manager Spatial Planning & Heritage would discuss the matter further with Professor Emeritus Damien Mugavin to clarify the information on page 14 of the report.

#### THAT THE ADELAIDE PARK LANDS AUTHORITY ADVISES THE STATE GOVERNMENT AND COUNCIL

That the Adelaide Park Lands Authority:

- Recommends that a self-assessment and referral process is undertaken regarding any possible effect the P&D Code may have on the values which underpin the National Heritage Listing of the Adelaide Park Lands and City Layout.
- 2. Provides the following comments on the draft P& D Code as Attachment A: Summary of Changes and Proposed Amendments to Item 9.2 on the Agenda for the meeting of the Board of the Adelaide Park Lands Authority held on 6 February 2020:
  - 2.1. Supports the recognition of the special attributes of the Adelaide Park Lands through inclusion of a dedicated Zone in the P&D Code.
  - 2.2. Suggests renaming City Park Lands Zone to Adelaide Park Lands Zone.
  - 2.3. Suggests that the boundary of the Adelaide Park Lands Zone should include the six squares which are a part of the Adelaide Park Lands.
  - 2.4. Suggest the deletion of the proposed Subzones in favour of comprehensive Zone wide policies.
  - 2.5. Strengthens policies to prevent inappropriate development (land uses and built form) in the Adelaide Park Lands Zone noting the removal of the current non-complying pathway.

- 2.6. Includes within the 'Desired Outcomes' of the Zone more descriptive policies to protect and enhance the unique features of the Adelaide Park Lands.
- 2.7. Revises the 'Built-form and Character' provisions to provide greater clarity regarding new buildings in the Adelaide Park Lands, including the incorporation of the City of Adelaide's Park Lands Building Design Guidelines (under development) into the P&D Code; or being adopted as a Design Standard to further support high quality Park Lands building design.
- 2.8. The unique planning considerations for the zone warrant zone specific policy content on matters including movement and parking, advertising and fencing (rather than the general policy that applies across other zones that does not adequately recognise the unique qualities of the Adelaide Park Lands).
- 2.9. Supports public notification where it involves all other code assessed development assessments; however, suggest minor types of development that are currently not subject to notification be exempt from public notification.
- 2.10. Suggests reinstatement and addition of mapping and / or concept plans to support a clearer statutory planning framework.
- 2.11. Suggests educational establishment, hotel and public infrastructure should be Code Assessed (Performance Assessed) Development rather than Restricted Development.
- 3. Supports further updates to the P&D Code following introduction of the initial version in July 2020 to reflect current strategies that relate to the Adelaide Park Lands (as already identified by Council).

Ms Jessica Davies-Huynh disclosed an actual conflict of interest in the Kaurna Community Hub in the Adelaide Park Lands, pursuant to Section 4.7 of the *Adelaide Park Lands Authority Charter* and Sections 75 & 75A of the *Local Government Act 1999 (SA)*, arising from being on the Board of the Kaurna Yerta Aboriginal Corporation Incorporated (KYAC) and advised the Adelaide Park Lands Authority of her intention to remain in the Colonel Light Room, participate to provide relevant unbiased information if sought to contribute but as a result of the actual conflict not participate in the vote on this matter.

#### THAT THE ADELAIDE PARK LANDS AUTHORITY ADVISES COUNCIL

That the Adelaide Park Lands Authority:

- Supports the Kaurna Yerta Aboriginal Corporation Incorporated (KYAC) using the North Adelaide Railway Station Building as a Kaurna Community Hub to provide a base from which to deliver cultural, economic and social development activities.
- 2. Requests the administration to coordinate preparation of a detailed scope of works and plans to inform further decision-making.
- 3. Supports administration commencing lease negotiations with KYAC for the use and occupation of the North Adelaide Railway Station Building in accordance with the Park Lands Leasing and Licensing Policy.

Ms Jessica Davies-Huynh was not requested to contribute information during discussion.

The motion was then put and carried Ms Jessica Davies-Huynh having disclosed an actual conflict of interest did not participate in the vote

#### **Executive Officer Verbal Report**

#### 9. Item 10 - Executive Officer Verbal Report - Site Visits & World Heritage Listing Project [APLA]

The Executive Officer Mr Martin Cook addressed the Board to:

- Indicate site visits are to be planned in the Park Lands Botanic Park to look at the grey flying fox population to see how that is being managed and what the implications are of that colony and visit the South Park Lands in April.
- Advise that in relation to the World Heritage listing project the group are currently seeking two experts in regard to the strengths and weakness of a stand-alone bid for the City and Park Lands and also the possible synergies that might be found from a combined bid with the Mt Lofty Ranges. An important step to undertake as these people have a strong connection with UNESCO and ICIMOS and understand the complexities.

#### THAT THE ADELAIDE PARK LANDS AUTHORITY

1. Having taken into account the relevant considerations contained in Clause 4.8.21 of the *Adelaide Park Lands Authority Charter* and s 90(3) (d) & (j) and 90(4) & (7) of the *Local Government Act 1999 (SA)*, this meeting of the Board of the Adelaide Park Lands Authority dated 6/2/2020 resolves that it is necessary and appropriate to act in a meeting closed to the public as the consideration of Item 12.1 [Adelaide High School – expansion of teaching facilities] listed on the Agenda in a meeting open to the public would on balance be contrary to the public interest.

#### **Grounds and Basis**

This Item contains commercial information of a confidential nature which the State Government has requested be considered in confidence on the grounds that the details and budget for the project are still being resolved and the release of this information prematurely may be misleading. The disclosure of the draft project details could reasonably be expected to prejudice the commercial position and negotiations of the State Government with external parties.

#### **Public Interest**

The Board is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of this information may result in the release of information prior to the finalisation commercial negotiations. The disclosure of this commercial information may materially and adversely affect the negotiations and the ability to discuss/participate or influence a proposal for the benefit of the Council and the community in this matter which on balance would be contrary to the public interest.

Pursuant to Clause 4.8.21 of the *Adelaide Park Lands Authority Charter* this meeting of the Board of the Adelaide Park Lands Authority dated 6/2/2020 orders that the public (with the exception of members of Council staff who are hereby permitted to remain) be excluded from this meeting to enable the Board to consider in confidence Item 12.1 [Adelaide High School – expansion of teaching facilities] listed in the Agenda, as the matter is of a kind referred to in s 90(3) (d) & (j) of the *Local Government Act 1999 (SA)*.




# Friends and Residents of North Adelaide's Submission for 6th Feb 2020 APLA Meeting re Crows HQ

Our feedback, questions and suggestions for the way forward – collated from North Adelaide residents and businesses

History with Adelaide Oval, Next Gen, etc has shown over and over that original promises made to the community are 'forgotten' over time ...

Can we ensure that in future the HQ won't be as big as the Crows have now, plus later fenced off ovals, liquor licences, maybe a hotel later, plus more floors, etc?

Recommendation that safer for Council to focus on restoring lost funding from State Government, plus not be afraid to ask for funds from Federal Government and neighbouring councils; others have shown the money is available.

### Friends and Residents of North Adelaide's Submission for 6th Feb 2020 APLA Meeting re Crows HQ

Our feedback, questions and suggestions for the way forward – collated from North Adelaide residents and businesses North Adelaide Feedback:

- Community is grateful to City of Adelaide current council members to seriously consider the next steps for the Aquatic Centre, instead of pushing it off again
- Community is also pleased to see a good focus on community needs setting up guidelines, forming a Needs Analysis, and being open as much as possible with local citizens and businesses about what is happening with the Crows proposal
- Sadly the feedback methods have proven to be hard to navigate online, offline as has been acknowledged by Council.
- Also, sadly there is miscommunication with some Council staff prohibiting discussions and information sharing at the Aquatic Centre, etc arousing suspicion and fear of "done deals", etc
- Community is pleased that the Crows have listened to many of the community concerns about height, liquor licensing, fencing off large parts of Park 2, parking, noise and crowd issues, not expanding beyond current footprint, etc; Crows current strawman images are clearly meant to ally many of the concerns
- However, the most major concern remains a large private company focused first on its shareholders (and not community) with proven lobbying skills and fund-raising abilities being given a large part of public parklands creating many issues now, and future risks this has on the parklands, and local residents and businesses.
- Parkland risks include later 'creep' of the footprint size, increasing restrictions for public access, new licenses granted, and Council being able to later say "no" to other clubs, schools, tourism ventures also asking to take over other large parts of the parklands offering to part-fund council operations
- Experience so far with Adelaide Oval is that local businesses have suffered instead of helped by Oval expansion of food and drink venues and hours; Crows HQ too far for most to walk will result in many expecting mini buses ferrying from oval direct to HQ bypassing North Adelaide businesses more

### Friends and Residents of North Adelaide's Submission for 6th Feb 2020 APLA Meeting re Crows HQ

Our feedback, questions and suggestions for the way forward – collated from North Adelaide residents and businesses

#### North Adelaide Questions:

- Fundamental one: given experience with Adelaide Oval, Next Gen, etc can we really be assured that there won't be changes in future?
- Examples are:
  - 1. Will Crows later insist their training has to be done in secret after all (like they do now) to "be competitive", etc, and add view-blocking fences around ovals to stop the public entering or viewing the open areas?
  - 2. Will their professional players be risked playing on open ground with potentially accidentally broken glass (or worse) left by the public or their competitors? Will this also force the grounds to be permanently fenced off from the public?
  - 3. Will they really stay an alcohol-free venue, when others don't have this restriction?
  - 4. Will they really not add more catering and entertainment options on site?
  - 5. Underground car parking touted is often a "Trojan Horse" of creating bigger foundations allowing later adding of 2-3 more floors on top
  - 6. What hours will swim centre be open, what fees will they charge, who will run it, what happens if not run well, etc? After all, it is not the Crows business objective or skills to be running any public community venues, and would prefer it fundamentally to be just for their own use to simplify things. Will they steadily price people out of using it, or have increasingly restrictive hours —pushing away the public small changes at a time, "salami-style", quietly slicing away the community benefits
  - 7. Hosting events (with alcohol especially) is a good money earner and loyalty generator for all clubs; why would they be willing to share with the local community, when they could put on mini buses to quickly take people from Adelaide Oval to the Park 2 building instead of having them walk past North Adelaide local venues?
  - 8. We have seen the Crows now willing to walk away from their current brand-new looking HQ building in West Lakes thanks to their good fund-raising skills. What is to stop them in a few years time walking awat again to a new site when more money raised (especially when they will find neighbours will continue to monitor them negatively with eagle eyes, etc). If they walk, what will Adelaide City Council do then with an even larger and more costly building to maintain?

# Friends and Residents of North Adelaide's Submission for 6<sup>th</sup> Feb 2020 APLA Meeting re Crows HQ Our feedback, questions and suggestions for the way forward – collated from North Adelaide residents and businesses

North Adelaide Recommendations:

- Views of the next steps are, of course, as varied as people in the local nearby community of Park 2.
- Consensus is forming though:
  - 1. Council to continue doing its community consultation to gather as many views as possible and what the majority think and want, including possibly doing independent polling as some community groups have already done ... to work out as democratically as possible what the majority desire
  - 2. Change the consultation/feedback process to become user-friendly, and extend the date to allow the many frustrated businesses and residents to input their views.
  - 3. As part of the changed feedback process, highlight also the new alternatives being expressed by Council adding in the alternatives ranging from the "gold-plated \$60 million proposal, more modest rebuilds or updates, the Crows proposal through to demolition of the Centre (and costs, benefits/downsides of each described)
  - 4. Since the core reason for today's financial issues is a change of funding from the State Government, many say the Council should first lobby for a restoration of this funding, because all the Centre has Adelaide-wide benefits
  - 5. Also there is a great deal of Sports Facility funding available now Federally that Council should actively lobby for funds for upgrades, running costs, etc.
  - 6. Since only 10% of Aquatic Centre users are Adelaide City Council residents, Council should not be shy from insisting that Prospect, Charles Sturt and other nearby Councils should contribute to the costs for running and upgrades say in proportion to location of users.
  - 7. These steps are much more safe for the Council and the community versus the risk of a large private enterprise with proven strong lobbying and fund-raising skills been handed a part of our parklands for effectively perpetuity with minimal (in reality) ability to halt future expansions on the site.
  - 8. Finally, agreeing to the Crows, will open the door for other similar strong corporations (other clubs, schools, developers, etc) offering to part-fund Council operations in return for getting large parts of our park lands. How could Council fairly say no them, when Council has said yes to the Crows?
