Sturt Street Primary School did a huge display along fences to also celebrate Flower Day.

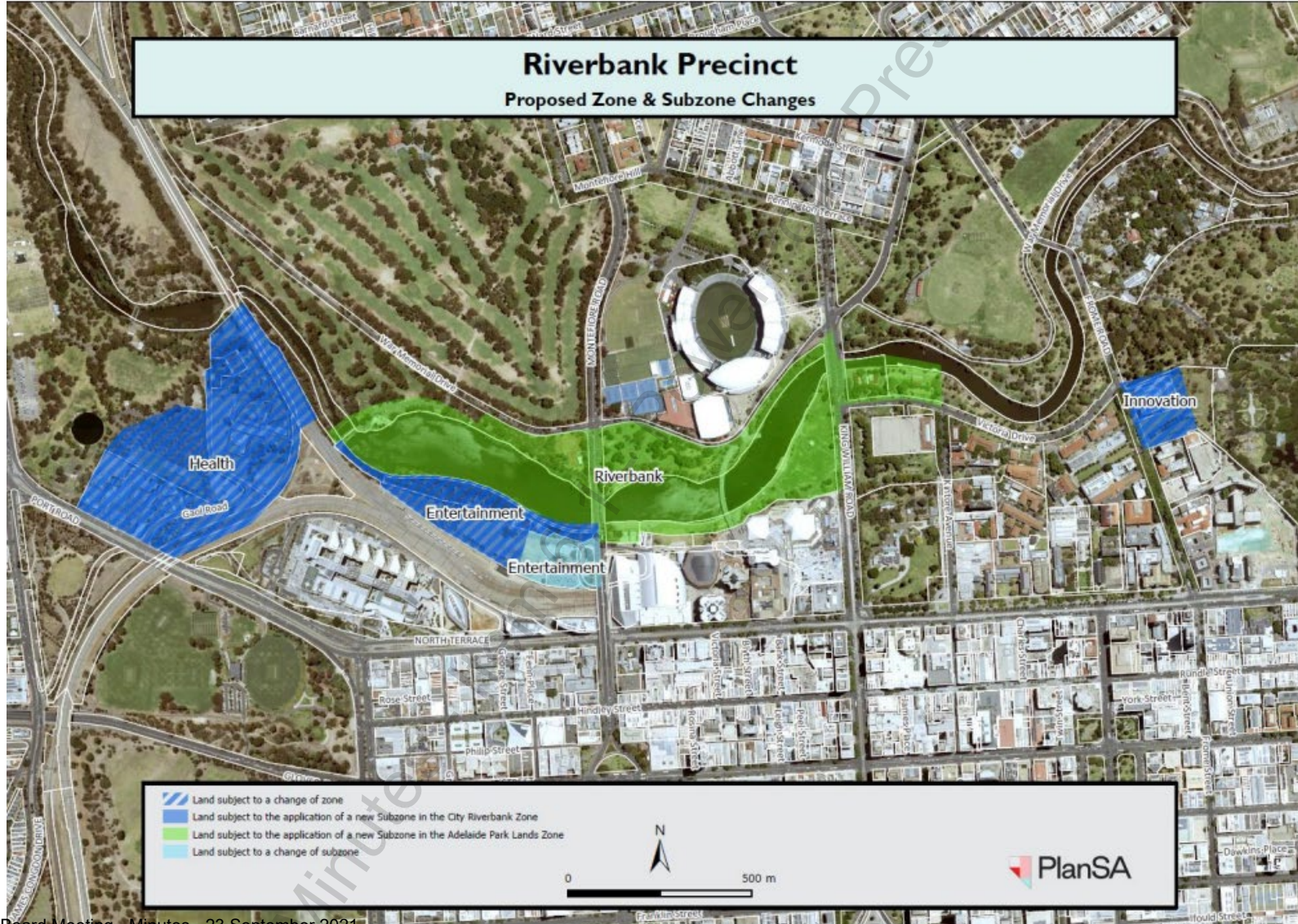

- Innovation Precinct

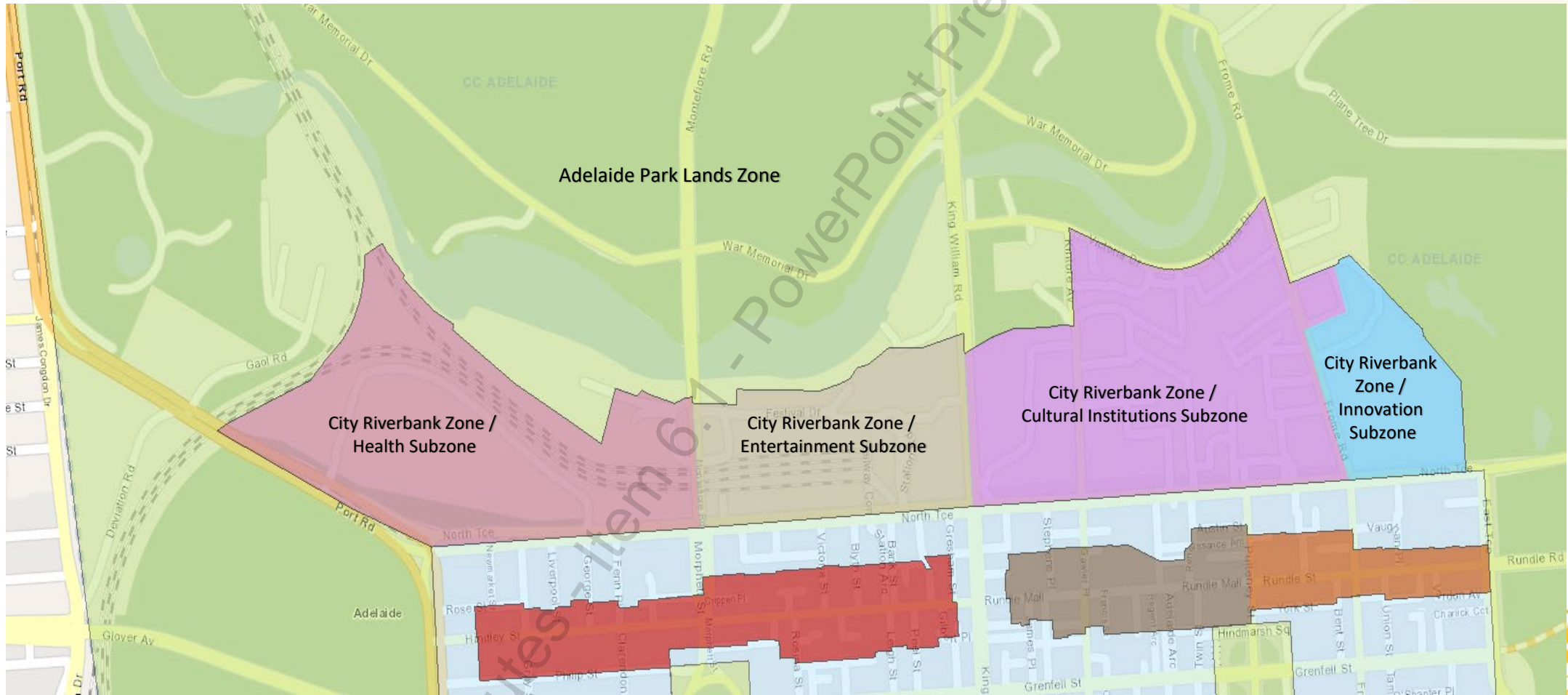


# Riverbank Precinct Code Amendment



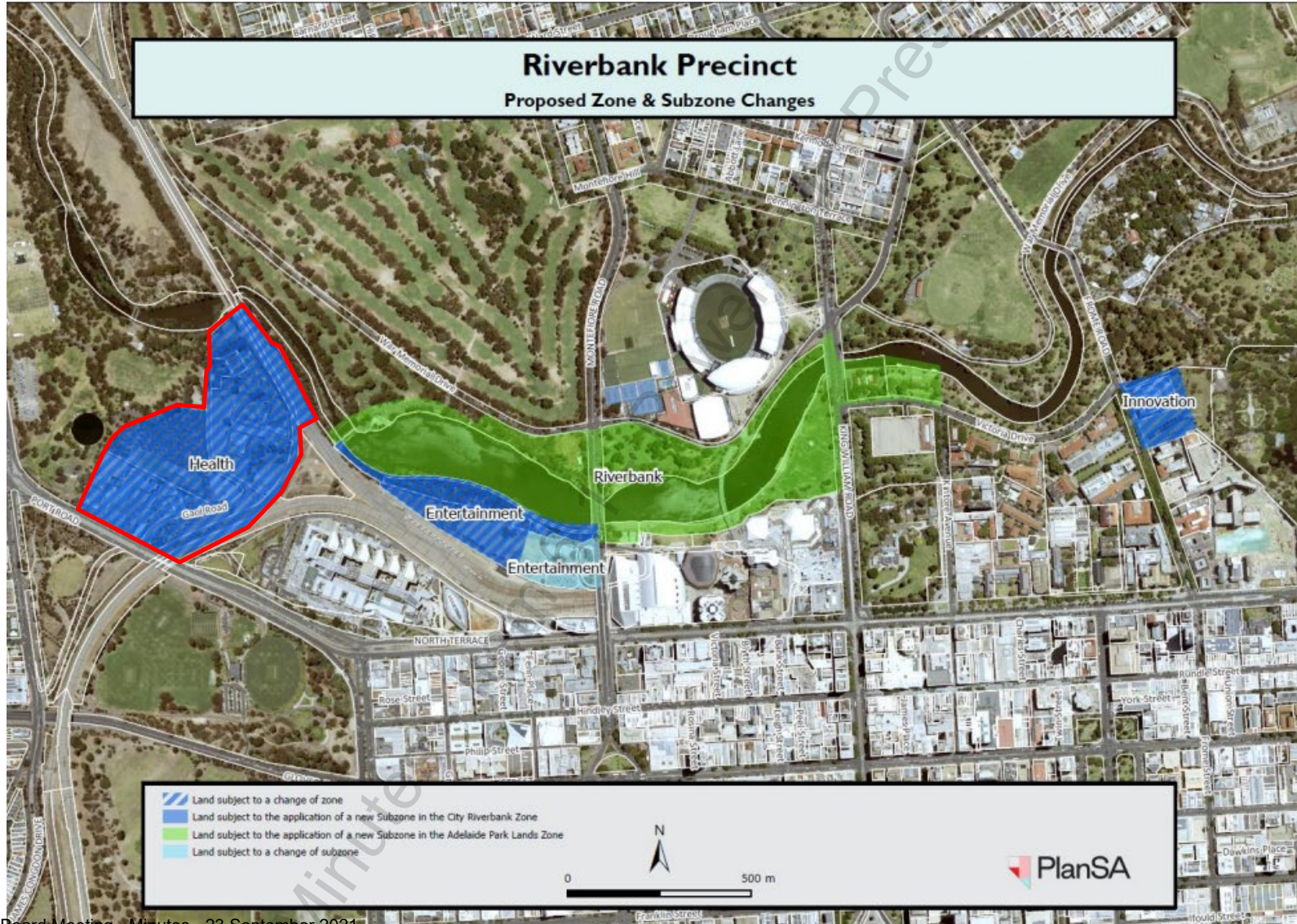


# Current P&D Code Zoning

# New Health and Biomedical Precinct

## Proposed zone changes:

- Rezone from “Adelaide Park Lands Zone” to “City Riverbank Zone / Health Subzone”

## Observations:

- Enables construction of transit hub and bridge connection to new Women’s and Children’s Hospital development
- A land area of around 22 hectares
- Removal of key policies of relevance to Park Lands
- Possible height of 15 building levels / 53m in building height
- Opportunities for substantial connection from City via hospital site to Park Lands not envisaged
- Assessment tables have not been provided for any of the proposed development types
- Public notification not required for any development except demolition of State or Local Heritage Place.



# New: envisaged land uses for SAPOL/Horse/Compound/Old Adelaide Gaol

## **Current envisaged Land Uses in Park Lands Zone**

A diverse range of open space, recreation and sporting activities, including:

- Advertisement
- Conservation work
- Outbuilding associated with open space maintenance
- Recreation area
- Shop
- Special events
- Sporting field or club facility
- Structures associated with a public facility such as bike and vehicle parking, picnic/barbeque area, shelter and toilet.

The proposed new policies do not envisage these land uses, other than shop and advertisement.

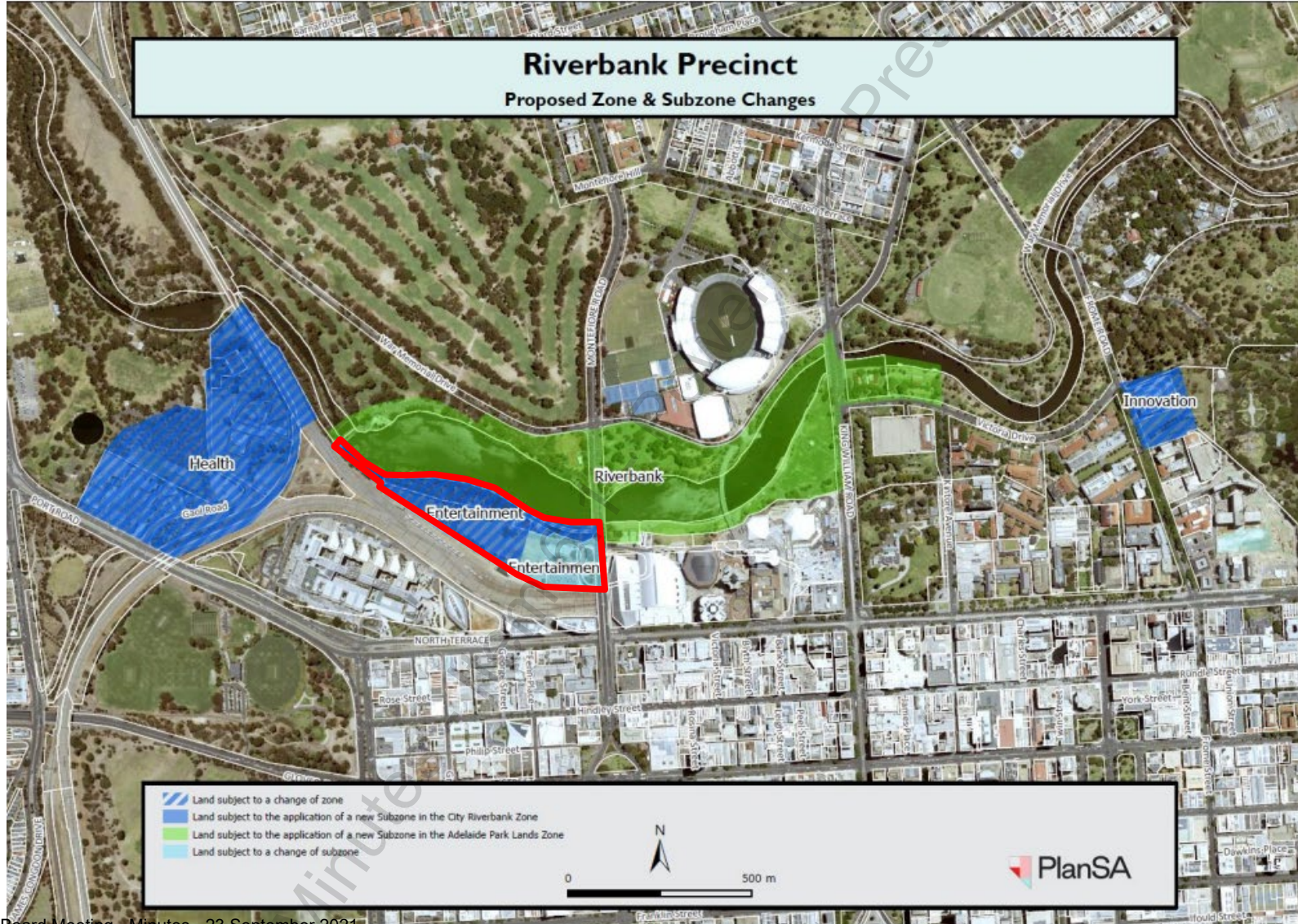
## What are your views on the proposed changes to:

1. Expand the City Riverbank Zone to the west (currently Park Lands Zone) and apply the Health Subzone.
2. Remove existing envisaged land uses such as recreation, sport and public facilities such as picnic and BBQ areas.
3. Allow for adaptive reuse of heritage items on the SAPOL Barracks and Old Adelaide Gaol site.
4. Create new policies to support walking and cycling connections to the park lands.





# Proposed Entertainment Precinct





# Entertainment Precinct

## Proposed zone changes:

- Most of this land changes from “Adelaide Park Lands Zone” to “City Riverbank Zone – Entertainment Subzone”
- The eastern portion of this land will change from “City Riverbank Zone (Health Subzone)” to “City Riverbank Zone (Entertainment Subzone)”
- Requires development in forecourt west of Adelaide Railway Station to connect between North Terrace and Riverbank

## Observations:

- Enables Riverbank Arena in this location, and enables more potential land uses
- A land area of around 9 hectares
- Removal of key policies of relevance to Park Lands
- Introduces policies to improve pedestrian and cycle access from eastern and western sides of Montefiore road but doesn't update concept Plan 79 – Primary Pedestrian Access
- Possible height of 20 building levels / 71m in building height, provides a transition in scale down to river.
- Allows for health related development and residential – may not be compatible with a Riverbank Arena?
- Assessment tables have not been provided for any of the proposed development types
- Public notification not required for any development except demolition of State or Local Heritage Place.



# New: envisaged land uses for Entertainment Precinct

## **Current envisaged Land Uses in Health Subzone**

A range of significant health, education and research facilities that support the establishment of a significant health and biomedical precinct.

## **Current envisaged Land Uses in Park Lands Zone**

A diverse range of open space, recreation and sporting activities, including:

- Advertisement
- Conservation work
- Outbuilding associated with open space maintenance
- Recreation area
- Shop
- Special events
- Sporting field or club facility
- Structures associated with a public facility such as bike and vehicle parking, picnic/barbeque area, shelter and toilet.

Note: These existing anticipated land uses in the Park Lands are not proposed to be included in the new City Riverbank Zone, other than shop and advertisement.

## **Rezoning to City Riverbank Zone (Entertainment Subzone) would allow the following new land uses currently not envisaged in this location:**

- Arena
- Community centre
- Consulting room
- Convention centre
- Entertainment venue
- Helicopter landing facility
- Hospital
- Hotel
- Licensed premises
- Land division
- Light industry
- Office
- Pre-school
- Residential (only where it can be demonstrated that impacts on residential amenity from mix of uses can be adequately addressed)
- Serviced apartments
- Shop
- Tourist accommodation

Also provides for a range of health, education and research facilities west of Montefiore Road to complement existing and emerging health-related activities in adjacent Health Subzone.

# Entertainment Precinct

## What are your views on the proposed changes to:

1. Apply City Riverbank, Entertainment Subzone to the area north of RAH, west of Morphett Street Bridge
2. New policy in the Entertainment subzone to support entertainment and biomedical uses, ensuring such development provides an active frontage to the river while maintaining a pedestrian and cycle path
3. New policy in the Entertainment subzone to provide connections between North Terrace and the Riverbank in the InterContinental forecourt





# Proposed Innovation Precinct



# Innovation Precinct<sup>23</sup> (Botanic High School and surrounds)

## Proposed zone changes:

- Botanic High Land would be taken out of Park Lands Zone and the City Riverbank Zone (Innovation Subzone) policies would apply
- Updated concept plan would seek retention to the open space south of school and linkages to Adelaide Botanic Garden
- Updated policy in City Riverbank Zone to reinforce linkages via Adelaide Park Lands Trail through the Innovation Subzone

## Observations:

- A zone change is not needed to enable continuation of Botanic High.
- An area of 2-3 hectares
- Removal of key policies of relevance to Park Lands
- The Concept Plan 85 update should still occur, but linked to the Park Lands preserve open space and connections as intended
- Assessment tables have not been provided for any of the proposed development types

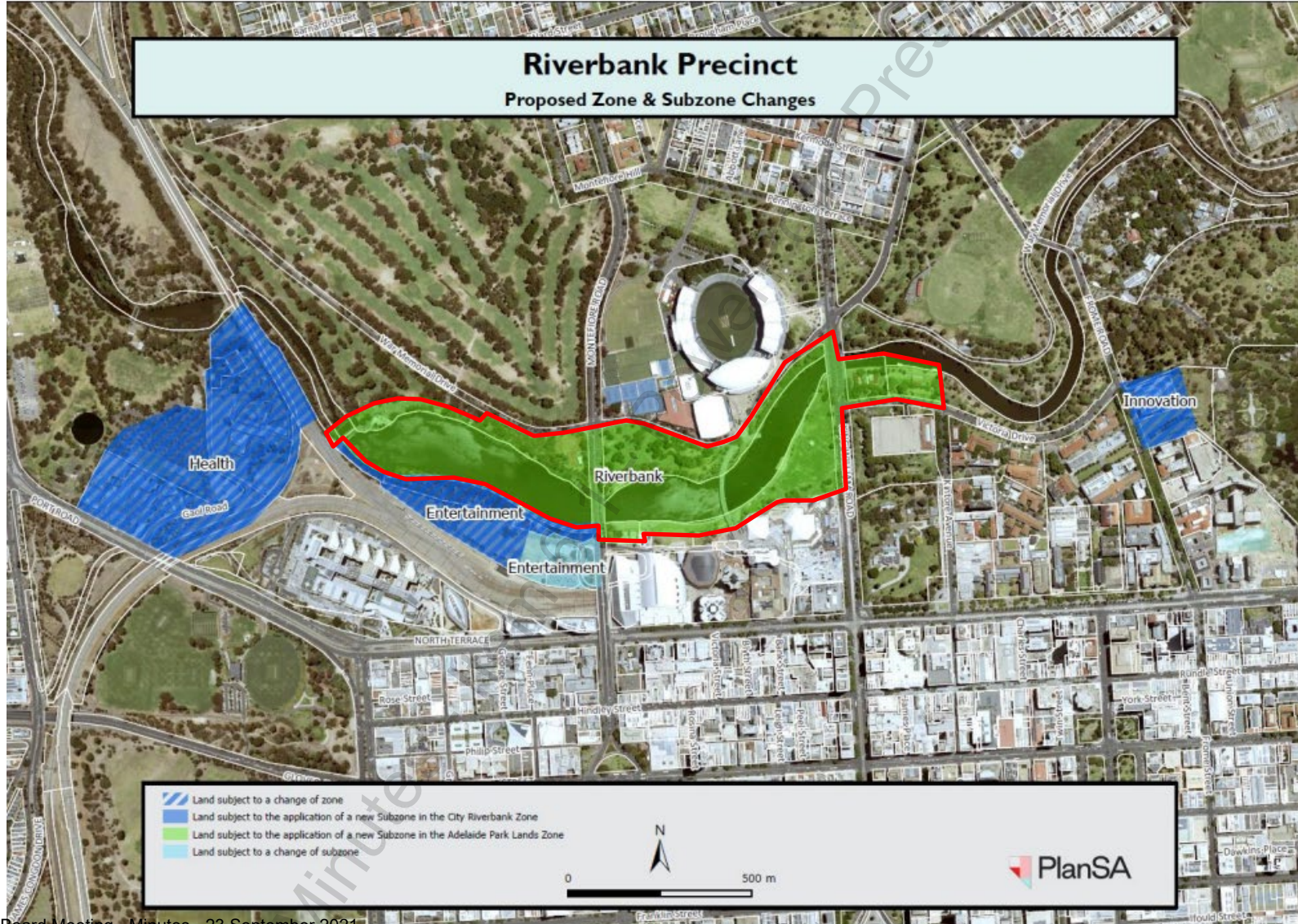

# New Active Waterfront Precinct (Torrens Lake including land on both sides)

## Proposed zone changes:

- Retain “Adelaide Park Lands Zone”
- Introduce new subzone “Riverbank Subzone”
- Encourages both on-water and off-water development

## Observations:

- Key policies of the Adelaide Park Lands Zone remain applicable.
- An area of around 37 hectares
- Clarification is needed regarding anticipated on-water development
- Up to 200m<sup>2</sup> gross leasable area deemed-to-satisfy provision for community, cultural, tourism, shop or licenced premises that complement role and function of the riverbank
  - The Zone seeks to minimise building footprint
  - No height guidance
- Assessment tables and Procedural Matters table have not been provided for any of the proposed development types



# New: envisaged land uses for Active Waterfront Precinct

## **Current envisaged Land Uses in Park Lands Zone**

A diverse range of open space, recreation and sporting activities, including:

- Advertisement
- Conservation work
- Outbuilding associated with open space maintenance
- Recreation area
- Shop
- Special events
- Sporting field or club facility

These existing anticipated land uses in the Park Lands would be kept in the proposed policy.

## **Introducing a new Riverbank Sub-Zone to the Park Lands Zone would allow the following land uses (currently not envisaged in this location):**

- A diverse range of community, cultural, tourism, shops and licensed premises located adjacent to the River Torrens
- Small scale development compatible with existing buildings along the Torrens riverbank and complements the area's open space setting (gross leasable area up to 200m<sup>2</sup> each)

# New Active Waterfront Precinct

## What are your views on the proposed changes to:

1. Create a new subzone within the Adelaide Park Lands Zone that provides opportunities for small, low-scale shops, cafes, community, cultural and tourism activities, located adjacent to the River Torrens to provide for greater activation of the Park Lands
2. Protect pedestrian and bicycle movement along the riverbank and ensure high quality design that complements the landscaped setting
3. Protect Elder Park as open space and an events space consistent with the Park Lands setting
4. Provide for small scale development compatible with existing structures along the riverbank and complements the area's open space setting

# Community Land Management Plan Update

## Draft CLMP General Provisions

- The community engagement for the draft CLMP General Provisions closed on 10 September 2021 after seven weeks, including a successful 'day in the park'. In total 131 submissions were received. The Park Lands Planning team is working through the feedback and will present the consultation report together with any proposed changes to the General Provisions to the APLA Board on 25 November 2021.
- The results of the consultation will be presented to APLA at its November meeting



# Cycling Infrastructure Projects Update

The City of Adelaide, in partnership with the State Government of South Australia, is progressing bikeways through the City and Park Lands including:

- The North-South Bikeway which will build on the existing Frome Bikeway and will connect the existing Rugby/Porter Bikeway in Unley to the Braund Road Bike Boulevard in Prospect.
- A series of projects to improve links from suburban bikeways into the CBD. The projects include new shared use paths on South Terrace and in Kadlitpina / Rundle Park, lighting upgrades and four projects that improve the Outer Harbour Greenway for bike riders to access the city.
