# 11. Item 13.1 - Councillor Martin - Question on Notice - Confidential Orders [C]

The following Question and Answer were taken as read:

#### Question

On October 23rd 2018 Council reviewed confidentiality orders (Agenda Item 12.1, '2018 Review of Confidentiality Orders'). However, the information provided did not appear to distinguish the application of in-confidence orders by the Adelaide Park Lands Authority.

Has APLA ever publicly released a summary of matters about which it made 'in-confidence' orders since first meeting in early 2007?

Could the Authority provide Council with a breakdown of matters declared confidential;

- a) he total number per calendar year, each topic/subject, and number of pages per subject.
- b) The grounds under the Local Government Act, s90(3) cited for each topic/subject declared as confidential
- c) Whether each in-confidence order related to a whole or part document (including any document that formed part of a presentation or workshop or other briefing session).
- c) The period of confidentiality to apply for each.
- d) Whether the Authority has ever released whole or part documents from confidential status, and the date of each release (each identified by subject matter) and the agenda or minute reference (date and item) which contained that release.
- e) Whether any APLA matters or APLA documents or advices remain subject to in-confidence orders and, if so, what were the topics, original dates of application of confidentiality status and the review dates that determined continuation of order).

#### Answer

- The purpose of the annual review of confidentiality orders is to present the outcome of an assessment of each
  order and the need for retention in confidence of the topic within the order. The report presented to Council for the
  annual review of Confidentiality Orders included a review of 'in-confidence' matters of the Adelaide Park Lands
  Authority.
- 2. A report by the Authority to release a summary of matters or breakdown of matters for which it made 'inconfidence' orders has not done. This form of reporting is not required in the subsidiary's obligations to report on its operations, financial position and other relevant issues.
- 3. In relation to the operation of the Authority for 'in-confidence' matters:
  - 3.1 It is a requirement for Authority meetings to be held in public except in special circumstance, observing s90 of the *Local Government Act 1999 (SA)*.
  - 3.2 There is no obligation or requirement for the Authority to publicly release or report to Council a summary of matters about which it made 'in-confidence' orders.
  - 3.3 The Board may order that a document be kept confidential provided that the Board specifies the duration of the order or the circumstances in which it will cease to apply or a period after which it must be reviewed.
  - 3.4 The agenda and minutes for the Authority are published to the City of Adelaide website.
  - 3.5 The publicly available minutes of a Board meeting identify any order made for a document to be kept confidential.
- The Council provides administrative support for the Authority for the day to day management of its powers and duties and the preparation for and attendance at meetings of the Board and implementation of the decisions of the Board.
- In recognition of the local government environment in which the Authority operates and to provide transparency of decision making, Council has in the provision of administrative support, incorporated Board 'in-confidence' decisions into its mandatory annual review.
- The topic of an 'in-confidence' order made by the Authority has been reviewed annually and information released in part or full has been published to the City of Adelaide website with the agenda for the authority.
  - The July 2003 December 2018 Register of <u>active</u> Confidentiality Orders available on the City of Adelaide website
  - (https://dmzweb.cityofadelaide.com.au/agendasminutes/files08/Agendas/CORDERS/2018/2018 12 21CORDER S Register with Information Available to the Public 2003 2017 as at 21 December 2018.pdf.) identifies:
  - 6.1 the date,

- 6.2 meeting which made an 'in-confidence' order,
- 6.3 the subject matter and reason,
- 6.4 the duration of the order,
- 6.5 what the 'in-confidence' order covers and what information is available to the public
- A subsidiary must, at the request of the council, report to the council on any matter, and on any basis, specified by the council. Should council resolve to request the break-down of the material sought in the question it will be provided.

# **EXECUTIVE SUMMARY:**

The Adelaide Park Lands Authority (APLA) is the principal advisor to both the Council and the State Government on the protection, management, enhancement and promotion of the Adelaide Park Lands.

The deliberations of APLA resulting in an advice are to inform future considerations of the Council.

The subject matter of an advice from APLA requiring the consideration and determination of Council will be presented in a separate report.

# Councillor Martin will ask the following Question on Notice:

'On October 23rd 2018 Council reviewed confidentiality orders (Agenda Item 12.1, '2018 Review of Confidentiality Orders'). However, the information provided did not appear to distinguish the application of in-confidence orders by the Adelaide Park Lands Authority.

Has APLA ever publicly released a summary of matters about which it made 'in-confidence' orders since first meeting in early 2007?

Could the Authority provide Council with a breakdown of matters declared confidential;

- a) the total number per calendar year, each topic/subject, and number of pages per subject.
- b) The grounds under the Local Government Act, s90(3) cited for each topic/subject declared as confidential
- c) Whether each in-confidence order related to a whole or part document (including any document that formed part of a presentation or workshop or other briefing session).
- c) The period of confidentiality to apply for each.
- d) Whether the Authority has ever released whole or part documents from confidential status, and the date of each release (each identified by subject matter) and the agenda or minute reference (date and item) which contained that release.
- e) Whether any APLA matters or APLA documents or advices remain subject to in-confidence orders and, if so, what were the topics, original dates of application of confidentiality status and the review dates that determined continuation of order).

# DRAFT REPLY:

- The purpose of the annual review of confidentiality orders is to present the outcome of an assessment of
  each order and the need for retention in confidence of the topic within the order. The report presented to
  Council for the annual review of Confidentiality Orders included a review of 'in-confidence' matters of the
  Adelaide Park Lands Authority.
- 2. A report by the Authority to release a summary of matters or breakdown of matters for which it made 'inconfidence' orders has not done. This form of reporting is not required in the subsidiary's obligations to report on its operations, financial position and other relevant issues.
- 3. In relation to the operation of the Authority for 'in-confidence' matters:
  - It is a requirement for Authority meetings to be held in public except in special circumstance, observing s90 of the *Local Government Act 1999 (SA)*.

- 3.2 There is no obligation or requirement for the Authority to publicly release or report to Council a summary of matters about which it made 'in-confidence' orders.
- 3.3 The Board may order that a document be kept confidential provided that the Board specifies the duration of the order or the circumstances in which it will cease to apply or a period after which it must be reviewed.
- 3.4 The agenda and minutes for the Authority are published to the City of Adelaide website.
- 3.5 The publicly available minutes of a Board meeting identify any order made for a document to be kept confidential.
- The Council provides administrative support for the Authority for the day to day management of its powers and duties and the preparation for and attendance at meetings of the Board and implementation of the decisions of the Board.
- In recognition of the local government environment in which the Authority operates and to provide transparency of decision making, Council has in the provision of administrative support, incorporated Board 'in-confidence' decisions into its mandatory annual review.
- The topic of an 'in-confidence' order made by the Authority has been reviewed annually and information released in part or full has been published to the City of Adelaide website with the agenda for the authority.
