

The establishment of a group to represent, advocate, research and advise on matters relating to movement and transport across the state enables broader and expansive approaches to the challenges facing all local governments as well as those facing the City of Adelaide as a growing city with changing and competing demands on its movement network.
- 2. An integrated, safe and accessible transport network is essential to achieve a liveable city that people want to visit, work, study and live in. Learnings from others will provide essential input on transport and movement priorities.
- 3. There would be clear benefits in sharing research and analysis on impacts of new and disruptive modes of transport (for example, driverless cars, trackless trams, private e-scooters and bike share systems etc.).

1. In August 2014, the City of Adelaide was declared a Refugee Welcome Zone, welcoming refugees and asylum seekers and acknowledging the difficult journey men, women and children make to Australia to seek our protection.

.....

- 2. On 27 February 2018, the City of Adelaide became the first capital city in Australia to become a Welcoming City building on our status as a Refugee Welcome Zone to commit to welcoming all ethnically diverse communities.
- 3. These actions are consistent with Council's joint status as a Refugee Welcome Zone and as a Welcoming City.
