Item 4.1 – Adelaide Archery Club Community Building Extension

The Lord Mayor will seek a motion for the recommendation presented by The Committee below for determination by Council.

RECOMMENDATION:

Recommendation 1 - Adelaide Archery Club Community Building Extension

That Council:

- 1. Approves the request made by the Adelaide Archery Club to undertake a building extension to their leased premises in Bullrush Park/Warnpangga (Park 10), subject to Development approval.
- 2. Approves the proposed building extension concept design as per Attachment A to Item 4.1 on the Agenda for the meeting of The Committee held on 21 May 2019 incorporating additional storage and upgraded amenities, and enhancements to the appearance of the existing facility as per Option 1.
- 3. Approves Administration to deal directly with the Adelaide Archery Club in relation to this project and notes that the Club will not be subjected to an Expression of Interest (EOI) process.
- 4. Authorises the CEO to enter into lease negotiations with the Adelaide Archery Club in accordance with the Park Lands Leasing and Licensing Policy and Guidelines and for a term of up to (15) years, noting that the agreement would be subject to community consultation (*Local Government Act (SA) 1999*) and being placed before both Houses of Parliament (*Adelaide Park Lands Act (SA) 2005*).

- 1. The Local Government Association of South Australia (LGA) is seeking nominations for three local government representatives on the Libraries Board of South Australia.
- 2. The functions of the Libraries Board of South Australia are as follows:
 - 2.1. to formulate policies and guidelines for the provision of public library services
 - 2.2. to establish, maintain and expand collections of library materials and, in particular, collections of such materials that are of South Australian origin, or have a particular relevance to this State
 - 2.3. to administer the State Library
 - 2.4. to establish and maintain such other public libraries and public library services as may best conduce to the public interest
 - 2.5. to promote, encourage and assist in the establishment, operation and expansion of public libraries and public library services by councils and others
 - 2.6. to collaborate with Public Library Services in the provision of library and information services
 - 2.7. to make recommendations to the Minister upon the allocation of funds that are available for the purposes of public libraries and public library services
 - 2.8. to initiate and monitor research and experimental projects in relation to public libraries and public library services
 - 2.9. to keep library services provided in the State under continuing evaluation and review
 - 2.10. to carry out any other functions assigned to the Board under this or any other Act or by the Minister.
- 3. Nominations for the board member positions should be current council members or council staff.
- 4. Council may put forward a maximum of two nominations for consideration by the LGA Board of Directors.
- 5. It is essential that nominees have experience in the operation of a library or setting the policy framework for a library and in intergovernmental relations.
- 6. Appointments are for a period of three years, up to a maximum of nine years.
- 7. Board members are entitled to \$590 per meeting up to a maximum of \$7,067 per annum.
- 8. Meetings are held on the third Monday of every month at the Morgan Thomas Boardroom at State Library SA in the Institute Building, except January and the month in which Easter falls. Meetings commence at 12.00pm and run for approximately two hours. Regional and metropolitan tours also occur.
- 9. Nominations must be forwarded to the LGA by close of business Thursday, 6 June 2019.
- 10. The LGA Board of Directors will consider nominations at its meeting on Thursday, 20 June 2019.

Council requests that administration investigate options for atmospheric lighting (similarly to that on Rundle Street) for O'Connell Street and Melbourne Street in North Adelaide, with prioritisation given to solar options.'

ADMINISTRATION COMMENT:

- 1. The atmospheric lighting on Rundle Street is festoon lighting, which is suspended between buildings across the street.
- 2. Master plans for O'Connell Street and Melbourne Street are proposed in the City of Adelaide's draft Integrated Business Plan 2019-20 (IBP). Subject to community consultation and Council's endorsement of the IBP, creative lighting design approaches will be investigated as part of these projects which will include engagement with the local community on atmospheric and decorative lighting to enhance the street.
- 3. A City of Adelaide draft Lighting Strategy is under way, which sets guiding principles and actions to advocate for quality lighting within our city streets, parks, and public spaces to enhance the liveability and night-time economy of the city. Sustainable lighting, which includes solar and other energy efficient lighting, is one of the key considerations of the draft Lighting Strategy. The draft Lighting Strategy is scheduled as a presentation to APLA in August and to Committee in September 2019 for discussion and feedback.
