EXECUTIVE SUMMARY:

ADMINISTRATION COMMENT:

- 1. The following Acts provide mechanisms for Council to identify and address what might constitute a neglected and/or derelict property.
- 2. The Local Nuisance and Litter Control Act 2016 (SA) (LNLC Act) gives Council provisions to act on unsightly conditions on premises. Unsightly conditions on premises are defined under Section 17 (1) (c)) of the LNLC Act. For Council to determine that a site is unsightly, it must be considered a 'local nuisance' under the LNLC Act.
 - 2.1. The aim of the LNLC Act is to provide improved community outcomes relating to local nuisance, litter control and illegal dumping. Since the Act came into effect (2016) there have been two justified unsightly conditions on premises complaints received, investigated and resolved by Council.
 - 2.2. When a complaint is received, parties are encouraged to work together to resolve their concerns. If negotiations between concerned parties are not successful, formal action such as an Abatement Notice may be taken. When proceeding with formal action, our employees (who are "Authorised Persons" as defined in the LNLC Act) are required to determine if the property is unsightly based on the definition under the LNLC Act.
 - 2.3. Unsightly conditions on premises are defined under the Act to include excessive rubbish, waste, vegetation or stockpiled items that a reasonable person would consider rubbish. Also included is graffiti and buildings in a state of disrepair, dilapidation and damage where these conditions have an adverse effect of the amenity value or are significantly out of conformity with the general appearance of neighbouring premises.
 - 2.4. A review of the LNLC Act is currently being undertaken by State Government. We will review the relevant sections and provide feedback to the State Government for possible improvements.
- 3. The South Australian Public Health Act 2011 (SA) may also be used for certain situations where the condition on premises is causing or likely to cause a risk to public health.

- 2. s 90(2) of the *Local Government Act 1999 (SA)*, states that a Council may order that the public be excluded from attendance at a meeting if Council considers it to be necessary and appropriate to act in a meeting closed to the public to receive, discuss or consider in confidence any information or matter listed in s 90(3).
- 3. s 90(3) prescribes the information and matters that a Council may order that the public be excluded from.
- 4. s 90(4) of the *Local Government Act 1999 (SA)*, advises that in considering whether an order should be made under s 90(2), it is irrelevant that discussion of a matter in public may:
 - 4.1 cause embarrassment to the council or council committee concerned, or to members or employees of the council; or
 - 4.2 cause a loss of confidence in the council or council committee.'
 - 4.3 involve discussion of a matter that is controversial within the council area; or
 - 4.4 make the council susceptible to adverse criticism.
- 5. s 90(7) of the Local Government Act 1999 (SA) requires that an order to exclude the public:
 - 5.1 Identify the information and matters (grounds) from s 90(3) of the *Local Government Act 1999 (SA)* utilised to request consideration in confidence;
 - 5.2 Identify the basis how the information falls within the grounds identified and why it is necessary and appropriate to act in a meeting closed to the public; and
 - In addition identify for the following grounds s 90(3) (b), (d) or (j) how information open to the public would be contrary to the public interest.
- 6. s 83(5) of the *Local Government Act 1999 (SA)* has been utilised to identify in the Agenda and on the Report for the meeting, that the following reports are submitted seeking consideration in confidence.
 - 6.1 Information contained in Item 18.1.1 Recommendation of The Committee in Confidence 23/7/2019:
 - 6.1.1 Is subject to an Existing Confidentiality Order dated 23/7/2019.
 - 6.1.2 The grounds utilised to request consideration in confidence is s 90(3) (d) & (j)
 - (d) commercial information of a confidential nature (not being a trade secret) the disclosure of which—
 - (i) could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party; and
 - (ii) would, on balance, be contrary to the public interest;
 - (j) information the disclosure of which
 - (i) would divulge information provided on a confidential basis by or to a Minister of the Crown, or another public authority or official (not being an employee of the council, or a person engaged by the council); and
 - (ii) would, on balance, be contrary to the public interest.
 - 6.2 Information contained in Item 18.1.2 Advice of the Adelaide Park Lands Authority in Confidence 25/7/2019
 - 6.2.1 Is subject to Existing Confidentiality Orders dated 25/7/2019.
 - 6.2.2 The grounds utilised to request consideration in confidence is s 90(3) (d)
 - (d) commercial information of a confidential nature (not being a trade secret) the disclosure of which—
 - could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party; and

- (ii) would, on balance, be contrary to the public interest;
- 6.3 Information contained in Item 18.1.3 Recommendation of the Audit Committee in Confidence 19/7/2019
 - 6.3.1 Is subject to an Existing Confidentiality Order dated 19/7/2019.
 - 6.3.2 The grounds utilised to request consideration in confidence is s 90(3) (b), (d) & (i)
 - (b) information the disclosure of which -
 - could reasonably be expected to confer a commercial advantage on a person with whom the council is conducting, or proposing to conduct, business, or to prejudice the commercial position of the council; and
 - (ii) would, on balance, be contrary to the public interest;
 - (d) commercial information of a confidential nature (not being a trade secret) the disclosure of which—
 - could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party; and
 - (ii) would, on balance, be contrary to the public interest;
 - information relating to actual litigation, or litigation that the council or council committee believes on reasonable grounds will take place, involving the council or an employee of the council;
- 6.4 Information contained in Item 18.1.2 Appointment of Board Members to Adelaide Central Market Authority
 - 6.4.1 Is not subject to an Existing Confidentiality Order.
 - 6.4.2 The grounds utilised to request consideration in confidence is s 90(3) (a)
 - (a) information the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead);
- 6.5 Information contained in Item 18.2.2 Appointment of Board Members to Rundle Mall Management Authority
 - 6.5.1 Is not subject to an Existing Confidentiality Order.
 - 6.5.2 The grounds utilised to request consideration in confidence is s 90(3) (a)
 - (a) information the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead);
