 - i) the issue of one on street parking permit for a period of one year to a nominated vehicle registered to a dwelling which has only one off street parking space. Such permits will be made available on application and will be strictly limited to one for each address except in special circumstances as may be determined by the Administration.
 - ii) on street permits (as described in i)) allowing parking in designated areas for a period of up to 24 hours
 - iii) permits (as described in i)) will initially be limited to 1, 200

 - v) the identification of areas with alterations to existing signage where permits (described in i)) can be used
 - vi) immediate planning for the introduction no later than the end of 2019 of a scheme to allow business ratepayers access to on street permits in designated areas currently utilised by commuter parking

VISUAL MERCHANDISING OPPORTUNITY

30 participating businesses across the City and North Adelaide precinct mainstreets will have their windows
visually merchandised by a professional merchandiser in time for the Christmas pageant and dismantled first
week of January.

CHRISTMAS IN THE PRECINCTS GRANT

North Adelaide Precinct Association, Hutt Street Traders Association, Gouger & Grote Street Traders Associations, East End Coordination Group and Adelaide West End Association are provided \$8,000 to implement a Christmas activation, marketing or decorative element of their choice. These initiatives have previously included and will likely be repeated in 2019:

- Ebenezer Night Markets (Christmas themed) in the East End
- Christmas lollipops and fortune cookie giveaways with shoppers receiving trader shopping vouchers to spend in those precincts.
- Christmas lighting elements and Christmas yarn bombing in City South.
- Hutt Street collected shopper statistics for future communication opportunities by offering free entry with purchase, to be in a draw to win shopping vouchers in local businesses.
- Melbourne Street had 'Elfie Selfies', lucky dips and craft activities with gift giveaways for shoppers.

EIGHTY EIGHT O'CONNELL

 As part of the Eighty Eight O'Connell event and activity program there will be a focus on Christmas for November and December. The activities will commence with a festive Christmas display onsite (Illuminated Giant Christmas presents) and other proposed activities include; Christmas Markets, community choir performances, outdoor movies and school holiday activities. 
