Could the Administration advise if the Council's Unsolicited Proposal policy allows the City of Adelaide to withdraw from the process associated with any unsolicited bid and, if so, at what stage/s in the process?

The Lord Mayor read the following Reply:

Reply

- City of Adelaide's Unsolicited Proposals Guideline (Guideline) sets out the process by which the Council will
 receive and consider unsolicited proposals. In accordance with the Guideline's submission terms and conditions,
 the City of Adelaide may, at any stage of the process of receiving, considering and negotiating any unsolicited
 proposal:
 - 1.1. accept or reject any unsolicited proposal;
 - 1.2. discontinue negotiations with any proponent.
- 2. The process by which City of Adelaide will receive and consider proposals is three staged. In addition to the above general rights, at the end of each stage, Council may resolve that all or part of a proposal is not suitable for further consideration and its consideration under the Guideline will come to an end.
- 3. In accordance with the Guideline's submissions terms and conditions, where City of Adelaide resolves to withdraw from a process associated with any unsolicited proposal, City of Adelaide will not be liable for any expenses or losses incurred by a proponent.
- 4. While there may be no legal or financial consequences for City of Adelaide in deciding to withdraw from any unsolicited proposal process, at any time, consideration should be given to reputational implications.
- 5. It may be arguable that in certain circumstances a party has not acted in good faith where discretion is exercised to unilaterally terminate an unsolicited proposal process based on a change of mind. Careful consideration should be given to withdrawal of any unsolicited proposal process in its specific circumstances to ensure City of Adelaide exercises its powers reasonably, so not to deter future proposals being submitted.

QUESTION ON NOTICE

Councillor Martin will ask the following Question on Notice:

'Could the Administration advise if the Council's Unsolicited Proposal policy allows the City of Adelaide to withdraw from the process associated with any unsolicited bid and, if so, at what stage/s in the process?'

REPLY

- 1. City of Adelaide's Unsolicited Proposals Guideline (**Guideline**) sets out the process by which the Council will receive and consider unsolicited proposals. In accordance with the Guideline's submission terms and conditions, the City of Adelaide may, at any stage of the process of receiving, considering and negotiating any unsolicited proposal:
 - 1.1. accept or reject any unsolicited proposal;
 - 1.2. discontinue negotiations with any proponent.
- 2. The process by which City of Adelaide will receive and consider proposals is three staged. In addition to the above general rights, at the end of each stage, Council may resolve that all or part of a proposal is not suitable for further consideration and its consideration under the Guideline will come to an end.
- 3. In accordance with the Guideline's submissions terms and conditions, where City of Adelaide resolves to withdraw from a process associated with any unsolicited proposal, City of Adelaide will not be liable for any expenses or losses incurred by a proponent.
- 4. While there may be no legal or financial consequences for City of Adelaide in deciding to withdraw from any unsolicited proposal process, at any time, consideration should be given to reputational implications.
- 5. It may be arguable that in certain circumstances a party has not acted in good faith where discretion is exercised to unilaterally terminate an unsolicited proposal process based on a change of mind. Careful consideration should be given to withdrawal of any unsolicited proposal process in its specific circumstances to ensure City of Adelaide exercises its powers reasonably, so not to deter future proposals being submitted.
