The release of such information may severely prejudice the Council's ability to secure a developer to undertake development of the land for the benefit of the City of Adelaide, Council and the community in this matter.

1. The current progress of the tree planting targets outlined in the 2016-2020 Strategic Plan:

- 1.1. Council is on track to achieve its new Strategic Plan Greening target of 1,500 trees within the city build-up area. The new target was set after achieving the original target (1000 trees) in September 2018.
- 1.2. Works have continued to incorporate new street tree planting within the capital works program by including street trees where there previously was none. These include streetscape upgrades to Boulton Street (4 trees) St Helena Place (16 trees), Gray Street (7 trees) and Gawler Place (14 Trees).
- 1.3. Providing context and background to the greening priorities for the City of Adelaide. This included highlighting some of the constraints encountered in planting trees in constrained City environments.
- 1.4. Since adoption of the 2016-2020 Strategic Plan, Council has invested significant funding to reach its greening targets. This has included an extensive program to investigate, design and then implement greening and has included \$2.4million in the 2016/17 Greening Street program, up to 200 trees in the 2017/18 Street Tree Planting program, and delivering designs for small-scale residential streetscape improvements for residential streets Claxton's Street and Strangways Terrace in the 2018/19 Residential Streets Improvement Program.
- 1.5. In addition, Public Realm tree planting program has increased the street trees as per the table below. Note: Figures in the table do not include the number of trees being delivered as part of Capital Works projects.

Year	Tree Increase
2016/17	353
2017/18	367
2018/19	217
2019/20 (YTD)	Tree Planting season will start in May 2020

- 2. 2019/20 Greening North West and South West: Project is to increase greening and the tree canopy cover to 20% in the City's South West and North West. \$800,000 was committed as part of the 2019/20 Integrated Business Plan and Budget. This project will deliver the following:
 - 2.1. Widened median with trees along Grote Street Stage1, between Morphett Street and Blenheim Street (\$600,000). The funding will enable planting of 30 trees. This is an estimated 280 square meters of canopy cover at tree maturity. The project will also deliver an estimated 450 square meters of new garden beds.
 - 2.1.1. \$200,000 is committed for undertaking the planning, feasibility and survey investigations required to incorporate additional street tree planting including the West End.
 - 2.1.2. These investigations include liaising with third party service providers and are progressing to understand the constraints and opportunities for tree planting.
 - 2.1.3. The planning and feasibility works will identify a forward program of greening works for 2020/21 to be undertaken in the north and south west corners of the City.

In the context of the publication of the Planning Design Code - Phase Three Code Amendment on the State Government Yoursay website under the heading City Park Lands Zone - Class of Development, Accepted Development Classification Criteria, it's noted that the following Classes of Development are classified as Accepted Development subject to meeting the 'Accepted Development Classification Criteria';

Specifically, at page 284, PO 1.6 New buildings should seek to minimise the building footprint on the landscaped and open setting of the Park Lands and should only be considered where:(a) the development is the replacement of an existing building; (b) the building design is contextual and of high-quality so that it complements its setting when viewed from all perspectives; (c) provides complementary recreation, sporting or tourism facilities that could not otherwise have been provided in the zone; and (d) the building is designed to be multi-purpose and can be used by more than one user group.

And, at page 285, PO 1.8 Development at the Adelaide Aquatic Centre site to consolidate and replace existing buildings with recreational sporting clubrooms, facilities and associated administrative functions.

Could the Administration comment on and provide answers to the following;

1. whether it was consulted on or provided with any input, formal or informal, to the State Government draft?

- 2. the concern of ratepayers and community groups that these parts of the draft planning code would allow a development application in regard to the Aquatic Centre, including the only proposal under active (and public) discussion at this time which concerns Adelaide Football Club Ltd (the Crows)?
- 3. is there any similarity between what the Administration knows to be the draft outline of the Crows' proposal and the proposed code, as above?
- 4. the concern of ratepayers and community groups that the proposed Crows takeover of the Aquatic Centre is a done deal?
- 5. when the application to redevelop the Aquatic Centre site is lodged, given the indicated draft wording of the planning code (Park Lands Zone, as above at pages 284 and 285), would the application be classified Cat 1 meaning that no public consultation regarding the application would be required at law?
- 6. if d) is correct, then would council even consider any public consultation about the future redevelopment of the site?
- 7. whether it would follow that even if significant public opposition emerges from any consultation, if it occurred, the subsequent delivery to SCAP of a Crows development application under the draft code would NOT be legally required to take into consideration such opposition?

Reply

- 1. The below are responses to the questions asked:
 - 1.1. Question 1 Administration received the Planning Design Code Phase Three Code Amendment (the draft Code) when it was released for consultation on 1 October 2019. No input from Council was provided prior to this.
 - 1.2. Question 2 We have not received a development application from the Adelaide Football Club (AFC) so are unable to make comment on whether the draft Code would facilitate a development application.
 - 1.3. Question 3 Council is yet to receive the Adelaide Football Club's (AFC) 'Detailed Proposal'; however, there are similarities between the 'Guiding Principles', to which the proposal must be consistent with, and the draft Code for the City Park Lands Zone. Both the 'Guiding Principles' and draft Code seek new development that reduces / minimises building footprint and is complementary / sympathetic to the Park Lands setting.
 - 1.4. Question 4 As outlined in the Unsolicited Proposal Guideline, the process by which the Council will receive and consider unsolicited proposals is a three stage process. During Stage 2 the AFC must prepare and submit a 'Detailed Proposal' which must then be presented to Council for its consideration. Under the terms of the Participation Framework Agreement (PFA), either party can terminate the process at any time during Stage 2 of the process.
 - If Council endorses the Detailed Proposal, Stage 3 becomes relevant at which time the final legal and commercial terms are negotiated. Under the terms of the PFA, no legally binding contract exists or is to be implied between the Council and the Proponent (AFC) unless and until a formal contract document is signed by both parties.
 - In addition to the above, any exclusive negotiation that originates from an unsolicited proposal is conditional upon requisite approvals and compliance with relevant legislation such as the *Local Government Act* 1999, *Development Act* 1993 and / or *Planning, Development and Infrastructure Act* 2016 and *Adelaide Park Lands Act* 2005 and any other legislation Council is responsible for enforcing.
 - 1.5. Question 5 Once the Code becomes operative, the existing categorisation of development applications for public notification purposes, as Category 1, 2 or 3, will cease to apply. Based on a preliminary review of the draft Code, it is likely a proposal would fall under the performance assessed pathway and require public notification.
 - 1.6. Question 6 The PFA sets out an iterative process, controlled by the Council, for the AFC to develop a Detailed Proposal for consideration by the Council. The Council has flexibility to vary those rules at any time.
 - Given the flexibility for Council to vary the rules, it would be up to the Council to determine if it wishes to undertake public consultation solely on the AFC's Detailed Proposal or seek the community's views more broadly about the future redevelopment of the site.
 - 1.7. Question 7 The State Government's Code will set out the circumstances in which public comment will be invited on a development application. This will determine the extent to which public comments can be considered as part of the development application process.

The following Question and Reply were taken as read and circulated to the public:

Question

At a public meeting at North Adelaide on October 30th, a senior member of the Administration announced that a developer had been selected by the City of Adelaide to construct the new Central Market Arcade Project.

Could the Administration;

- 1. Advise the date on which it will reveal the name of that developer and the dollar value of their proposal?
- 2. Outline when it will publish any detailed development plans which may or may not exist and which may or may not be confidential?
- 3. Confirm if and when it plans to communicate with tenants of the Central Market Arcade (six of whom have vacated the premises with further departures likely) the date the developer expects to begin construction so that our tenants can reasonably plan their exit?

Reply

- The Central Market Arcade Redevelopment has been the subject of a two (2) stage expression of interest process.
- 2. The Administration has been engaging regularly with stakeholders and will continue to engage in advance of any redevelopment of the Central Market Arcade.
- 3. On 8 May 2019 and 30 October 2019 precinct forums were held at the Adelaide Central Market and North Adelaide respectively to provide an update on the Central Market Arcade Redevelopment.
- 4. The Administration noted at the above forums that the selection of a project development partner for the Central Market Arcade Redevelopment is subject to Council consideration. The Administration is unable to talk to specifics of proposals given that the stage three (3) negotiation process is commercial in confidence.
- 5. The City of Adelaide has a dedicated website for the redevelopment and has been providing ongoing marketing and promotional support to Central Market Arcade traders since September 2018.
- 6. The selection of a project development partner for the Central Market Arcade Redevelopment is subject to Council consideration which is expected in December 2019.
- 7. Once Council has made a decision with regard to the selection of the project development partner and contracts are signed the Administration will be in a position to further discuss the design scheme and project timing with stakeholders and the broader community. This will include (but not be limited to) engagement with Central Market Arcade and Central Market traders.

- 2. To ensure appropriate representation the City of Adelaide Audit Committee ("the Audit Committee") consists of the Lord Mayor (ex officio), one (1) Councillor and three (3) External Independent Members, one of whom is selected as the Presiding Member.
- 3. Audit Committees provide an important independent role between Council and its management and between Council and its community. Audit Committees have no authority to act independently of Council and can only act in areas covered by its Terms of Reference.
- 4. The Audit Committee does not have executive powers or authority to implement actions in areas which management has responsibility and does not have any delegated financial responsibilities. The Audit Committee does not have any management functions and it is therefore independent from management.

- 8. At the closing date, fifty-four Expressions of Interest were received.
- 9. The Expressions of Interest were assessed by the evaluation panel against the following criteria:
 - 9.1. Broad knowledge of Risk Management
 - 9.2. Experience in governance issues
 - 9.3. Extensive accounting, auditing or legal skills
 - 9.4. Relevant experience in large multi-functional or local government organisation
 - 9.5. Level of independence
- 10. Applicants David Powell, Ross Haslam and Paula Davies were evaluated to have the strongest alignment to each of the evaluation criteria, and are considered to have the relevant range of experience, skills and attributes to contribute to the effectiveness of the Audit Committee, as outlined in **Attachment A**.

Councillor Simms will ask the following Question on Notice:

- 1. Could administration please provide an update on the progress of tree planting targets as outlined in the 2016-2020 Strategic Plan, as well as an update on the targets outlined in the approved Green City Plan?
- 2. In particular, what is the status of the greening promised for residential areas in the West End of the City?'

REPLY

- 1. The current progress of the tree planting targets outlined in the 2016-2020 Strategic Plan:
 - 1.1. Council is on track to achieve its new Strategic Plan Greening target of 1,500 trees within the city build-up area. The new target was set after achieving the original target (1000 trees) in September 2018.
 - 1.2. Works have continued to incorporate new street tree planting within the capital works program by including street trees where there previously was none. These include streetscape upgrades to Boulton Street (4 trees) St Helena Place (16 trees), Gray Street (7 trees) and Gawler Place (14 Trees).
 - 1.3. Providing context and background to the greening priorities for the City of Adelaide. This included highlighting some of the constraints encountered in planting trees in constrained City environments.
 - 1.4. Since adoption of the 2016-2020 Strategic Plan, Council has invested significant funding to reach its greening targets. This has included an extensive program to investigate, design and then implement greening and has included \$2.4million in the 2016/17 Greening Street program, up to 200 trees in the 2017/18 Street Tree Planting program, and delivering designs for small-scale residential streetscape improvements for residential streets Claxton's Street and Strangways Terrace in the 2018/19 Residential Streets Improvement Program.
 - 1.5. In addition, Public Realm tree planting program has increased the street trees as per the table below. Note: Figures in the table do not include the number of trees being delivered as part of Capital Works projects.

Year	Tree Increase
2016/17	353
2017/18	367
2018/19	217
2019/20 (YTD)	Tree Planting season will start in May 2020

2. 2019/20 Greening - North West and South West: Project is to increase greening and the tree canopy cover to 20% in the City's South West and North West. \$800,000 was committed as part of the 2019/20 Integrated Business Plan and Budget. This project will deliver the following:

- 2.1. Widened median with trees along Grote Street Stage1, between Morphett Street and Blenheim Street (\$600,000). The funding will enable planting of 30 trees. This is an estimated 280 square meters of canopy cover at tree maturity. The project will also deliver an estimated 450 square meters of new garden beds.
 - 2.1.1. \$200,000 is committed for undertaking the planning, feasibility and survey investigations required to incorporate additional street tree planting including the West End.
 - 2.1.2. These investigations include liaising with third party service providers and are progressing to understand the constraints and opportunities for tree planting.
 - 2.1.3. The planning and feasibility works will identify a forward program of greening works for 2020/21 to be undertaken in the north and south west corners of the City.

Councillor Martin will ask the following Question on Notice:

'In the context of the publication of the Planning Design Code - Phase Three Code Amendment on the State Government Yoursay website under the heading City Park Lands Zone - Class of Development, Accepted Development Classification Criteria, it's noted that the following Classes of Development are classified as Accepted Development subject to meeting the 'Accepted Development Classification Criteria';

Specifically, at page 284, PO 1.6 New buildings should seek to minimise the building footprint on the landscaped and open setting of the Park Lands and should only be considered where:(a) the development is the replacement of an existing building; (b) the building design is contextual and of high-quality so that it complements its setting when viewed from all perspectives; (c) provides complementary recreation, sporting or tourism facilities that could not otherwise have been provided in the zone; and (d) the building is designed to be multi-purpose and can be used by more than one user group.

And, at page 285, PO 1.8 Development at the Adelaide Aquatic Centre site to consolidate and replace existing buildings with recreational sporting clubrooms, facilities and associated administrative functions.

Could the Administration comment on and provide answers to the following;

- 1. whether it was consulted on or provided with any input, formal or informal, to the State Government draft?
- 2. the concern of ratepayers and community groups that these parts of the draft planning code would allow a development application in regard to the Aquatic Centre, including the only proposal under active (and public) discussion at this time which concerns Adelaide Football Club Ltd (the Crows)?
- 3. is there any similarity between what the Administration knows to be the draft outline of the Crows' proposal and the proposed code, as above?
- 4. the concern of ratepayers and community groups that the proposed Crows takeover of the Aquatic Centre is a done deal?
- 5. when the application to redevelop the Aquatic Centre site is lodged, given the indicated draft wording of the planning code (Park Lands Zone, as above at pages 284 and 285), would the application be classified Cat 1 meaning that no public consultation regarding the application would be required at law?
- 6. if d) is correct, then would council even consider any public consultation about the future redevelopment of the site?
- 7. whether it would follow that even if significant public opposition emerges from any consultation, if it occurred, the subsequent delivery to SCAP of a Crows development application under the draft code would NOT be legally required to take into consideration such opposition?'

The Lord Mayor will provide a reply at the meeting, the reply and question will be included in the Minutes of the meeting.

REPLY

- 1. The below are responses to the questions asked:
 - 1.1. Question 1 Administration received the Planning Design Code Phase Three Code Amendment (the draft Code) when it was released for consultation on 1 October 2019. No input from Council was provided prior to this.
 - 1.2. Question 2 We have not received a development application from the Adelaide Football Club (AFC) so are unable to make comment on whether the draft Code would facilitate a development application.
 - 1.3. Question 3 Council is yet to receive the Adelaide Football Club's (AFC) 'Detailed Proposal'; however, there are similarities between the 'Guiding Principles', to which the proposal must be consistent with, and the draft Code for the City Park Lands Zone. Both the 'Guiding Principles' and draft Code seek new development that reduces / minimises building footprint and is complementary / sympathetic to the Park Lands setting.
 - 1.4. Question 4 As outlined in the Unsolicited Proposal Guideline, the process by which the Council will receive and consider unsolicited proposals is a three stage process. During Stage 2 the AFC must prepare and submit a 'Detailed Proposal' which must then be presented to Council for its consideration. Under the terms of the Participation Framework Agreement (PFA), either party can terminate the process at any time during Stage 2 of the process.
 - If Council endorses the Detailed Proposal, Stage 3 becomes relevant at which time the final legal and commercial terms are negotiated. Under the terms of the PFA, no legally binding contract exists or is to be implied between the Council and the Proponent (AFC) unless and until a formal contract document is signed by both parties.
 - In addition to the above, any exclusive negotiation that originates from an unsolicited proposal is conditional upon requisite approvals and compliance with relevant legislation such as the *Local Government Act* 1999, *Development Act* 1993 and / or *Planning, Development and Infrastructure Act* 2016 and *Adelaide Park Lands Act* 2005 and any other legislation Council is responsible for enforcing.
 - 1.5. Question 5 Once the Code becomes operative, the existing categorisation of development applications for public notification purposes, as Category 1, 2 or 3, will cease to apply. Based on a preliminary review of the draft Code, it is likely a proposal would fall under the performance assessed pathway and require public notification.
 - 1.6. Question 6 The PFA sets out an iterative process, controlled by the Council, for the AFC to develop a Detailed Proposal for consideration by the Council. The Council has flexibility to vary those rules at any time.
 - Given the flexibility for Council to vary the rules, it would be up to the Council to determine if it wishes to undertake public consultation solely on the AFC's Detailed Proposal or seek the community's views more broadly about the future redevelopment of the site.
 - 1.7. Question 7 The State Government's Code will set out the circumstances in which public comment will be invited on a development application. This will determine the extent to which public comments can be considered as part of the development application process.

QUESTION ON NOTICE

Councillor Martin will ask the following Question on Notice:

'At a public meeting at North Adelaide on October 30th, a senior member of the Administration announced that a developer had been selected by the City of Adelaide to construct the new Central Market Arcade Project.

Could the Administration;

- 1. Advise the date on which it will reveal the name of that developer and the dollar value of their proposal?
- 2. Outline when it will publish any detailed development plans which may or may not exist and which may or may not be confidential?
- 3. Confirm if and when it plans to communicate with tenants of the Central Market Arcade (six of whom have vacated the premises with further departures likely) the date the developer expects to begin construction so that our tenants can reasonably plan their exit?'

REPLY

- 1. The Central Market Arcade Redevelopment has been the subject of a two (2) stage expression of interest process.
- 2. The Administration has been engaging regularly with stakeholders and will continue to engage in advance of any redevelopment of the Central Market Arcade.
- 3. On 8 May 2019 and 30 October 2019 precinct forums were held at the Adelaide Central Market and North Adelaide respectively to provide an update on the Central Market Arcade Redevelopment.
- 4. The Administration noted at the above forums that the selection of a project development partner for the Central Market Arcade Redevelopment is subject to Council consideration. The Administration is unable to talk to specifics of proposals given that the stage three (3) negotiation process is commercial in confidence.
- 5. The City of Adelaide has a dedicated website for the redevelopment and has been providing ongoing marketing and promotional support to Central Market Arcade traders since September 2018.
- 6. The selection of a project development partner for the Central Market Arcade Redevelopment is subject to Council consideration which is expected in December 2019.
- 7. Once Council has made a decision with regard to the selection of the project development partner and contracts are signed the Administration will be in a position to further discuss the design scheme and project timing with stakeholders and the broader community. This will include (but not be limited to) engagement with Central Market Arcade and Central Market traders.
