#### Lord Mayor's Reports

#### Item 10.1 – Lord Mayor's Report [2018/04064] [C]

The Lord Mayor addressed the Council Chamber as follows:

'If ever there was a stark reminder that life can change in the blink of an eye, this is it. These are truly unprecedented and challenging times for us all as we adjust and adapt to the challenges COVID-19 presents.

This is the first Council meeting of the pandemic using this technology, which will be a new experience and will take some time to adapt to. By working together, we can continue with our job to serve the community.

This pandemic is first and foremost a health crisis, and the City has worked hard and quickly to ensure the safety of our workers, residents and visitors. We also know the economic impacts are extensive – with so many workers and businesses facing such an uncertain future, it's just awful.

Thank you members for your leadership in endorsing Council's four million dollar support package. It will assist vulnerable community members and our local businesses. Council's package is working in tandem with significant Federal and State government support, for which I am thankful.

Vulnerable people in our community are a high priority. Council has been working closely with, and assisting, Government and non-government services to support vulnerable people during this time. The State Government's response is providing a way for people who are rough sleeping to be safe during this crisis, with 241 people provided with temporary motel accommodation. Our customer service centre is also connecting people in need of extra support with relevant service providers.

The Council of Capital City Lord Mayor recently met via zoom. This was a useful opportunity for Lord Mayors and CEOs to share what each of the capital cities are doing to support communities.

I would like to congratulate the traders and staff at the Adelaide Central Market on their agility in moving to their preorder and collect model which has proved highly popular with regular market shoppers who want to support local traders - my family included. Many City and North Adelaide businesses have also had to rapidly adjust their business plans, and my thoughts are with them during this challenging and uncertain time.

Like you, my Easter was very different from previous years. What I did notice was that our city's park lands are active with people enjoying exercising in the fresh air with their families and pets or chatting away to friends on the phone, and I encourage local people, within the guidelines, to continue to take advantage of Adelaide's greatest community asset.

Finally, I would like to recognise that the 27th of April will be the birthday anniversary for Colonel William Light. I would like to acknowledge Light's vision and the legacy his design for the City of Adelaide has created. The Adelaide Park Lands are playing an important role in supporting the physical and mental health and wellbeing of our communities, now more than ever.

- 1. The City of Adelaide's (CoA) Community Engagement Strategy principles are based on the International Association for Public Participation's core values, the principles within the strategy are used to determine ethical and good practice throughout the engagement process from planning through to reporting.
- The Policy states that when engaging the community in a decision-making process (of which legislated public
  consultation is a part) Council will provide relevant, timely and balanced information so people can contribute in a
  meaningful way.
- 3. There is no definition of bias defined in the Policy or Strategy. We use these principles as a guide to determine ethical and good practice throughout the engagement process from planning through to reporting.
- 4. The APPA brochure was prepopulated and:
  - 4.1. did not provide all information that was available on the YourSay site to enable people to provide a fully informed response to the questions being asked in the consultation and;
  - 4.2. did not give the complete range of response options and to the contrary, it pre-selected and pre-populated a limited range of response options. If community members had no context regarding the project, they would have been limited in their ability to make an informed submission to the questions being asked as this was not a poll.
- 5. The Property Council and the Adelaide Football Club directed their membership bases to participate via 'Your Say Adelaide', where they could access all of the relevant information to inform their submission.



'In a number of documents subsequent to a Motion on Notice in open Council, the Administration has publicly advised it has been conducting a Strategic Review of Council Property Assets. It (at a recent City of Adelaide Audit Committee meeting) was proposed that the sale of such assets is one of the levers available to Council to manage the City's burgeoning debt. Could the Administration assure ratepayers;

- 1. That in the current economic circumstances created by the COVID 19 pandemic which is putting downward pressure on property prices there will no sale of property assets at less than pre pandemic market valuations?
- 2. That any Council property asset sale will take place on the open market rather than through private negotiation?
- 3. That any proposed sale of property assets acquired as a result of the financial acumen of previous Councils will be preceded by community consultation?'

## **REPLY**

- 1. The Strategic Property Review responds to the legislative, strategy and policy context set out below:
  - 1.1. Local Government Act 1999 (SA) requirements to use resources fairly, effectively and efficiently;
  - 1.2. Acquisition and Disposal of Land and Infrastructure Assets Policy which requires a regular review of land and asset performance with appropriate actions to improve public value or disposal where public value cannot be improved;
  - 1.3. City of Adelaide Strategic Plan 2016-2020 action to "Explore opportunities in Council's current property holdings and pursue strategic opportunities to lead or partner in future property developments";
  - 1.4. City of Adelaide 2020-2024 Strategic Plan incorporating the action to "Implement the Strategic Property Review":
- 2. The review and action plan aim to optimise the performance of the City's property portfolio ensuring the effective use of its assets with improved alignment to Council's strategic, community and financial objectives and has been communicated to Council with increasing detail over the past twenty-four months.
- 3. Sale of Council owned property will be undertaken in accordance with Council's Acquisition and Disposal of Land and Infrastructure Assets Policy (as per # 1 in the Administration response).
- 4. Any property which is recommended for sale would be released on a strategic basis and would consider market conditions. The decisions on the sale of assets and the process for the sale would be considered by Council prior to release to market.

'Using the QF 2 financial reports as a base line, could the Administration advise in the light of the disastrous economic outlook as a result of the COVID 19 pandemic;

- 1. If it has estimated the amount by which the approximate operating deficit of \$20 million revealed earlier this year will be exceeded and what is that amount?
- 2. The impact of any deterioration in the operating deficit on Council's debt and whether its earlier advice that the City of Adelaide will breach the Council's prudential borrowing limit in the second half of the 2020/21 financial year will be revised to the first or second quarter of the year?'

## **REPLY**

- 1. The impacts of this unforeseen financial situation are unfolding in real-time. As our communities comply with the advice and restrictions progressively announced by the Federal and State Governments for social distancing, self-isolation and quarantine, the pressure on our income and cash-flow is immediate, significant and anticipated to be long-term.
- 2. Council is presently experiencing a significant reduction in income from on street parking and expiations, Business Operations including UParks, Aquatic Centre, Golf Links, the property portfolio, Town Hall, Park Lands events, and other fees and charges. Preliminary scenario modelling indicates that the reduction in net income will be between \$10-20 million for Quarter 4 2019-20.
- 3. Action is being taken to reduce and defer non-essential expenditure, including operational expenditure, projects and capital works. Innovative measures such as the introduction of UPark Plus Card have been introduced to minimise the loss in net income.
- 4. We have provided regular updates to Council on the impact of the COVID-19 pandemic. Council members will continue to be briefed; including a Discussion on COVID-19 Future Critical Decisions on Wednesday 15 April 2020 to discuss and workshop in detail all aspects of Council's financial position, including Council's operating position, funding position, anticipated borrowings for the year ending 30 June 2020, and prudential borrowing limits.
- 5. The QF3 Finance Report will be presented to Committee on 5 May 2020 and will enable Council to make informed decisions about its response to the COVID-19 pandemic including any future borrowings and investment in recovery stimulus packages.

- 4. What is the definition of "biased" used by the Council Administration and how is bias discerned when assessing submissions influenced by, say, the Property Council or the Adelaide Football Club versus the Adelaide Park Lands Preservation Association?'

## **REPLY**

- 1. The City of Adelaide's (CoA) Community Engagement Strategy principles are based on the International Association for Public Participation's core values, the principles within the strategy are used to determine ethical and good practice throughout the engagement process from planning through to reporting.
- 2. The Policy states that when engaging the community in a decision-making process (of which legislated public consultation is a part) Council will provide relevant, timely and balanced information so people can contribute in a meaningful way.
- 3. There is no definition of bias defined in the Policy or Strategy. We use these principles as a guide to determine ethical and good practice throughout the engagement process from planning through to reporting.
- 4. The APPA brochure was prepopulated and:
  - 4.1. did not provide all information that was available on the YourSay site to enable people to provide a fully informed response to the questions being asked in the consultation and;
  - 4.2. did not give the complete range of response options and to the contrary, it pre-selected and prepopulated a limited range of response options. If community members had no context regarding the project, they would have been limited in their ability to make an informed submission to the questions being asked as this was not a poll.

5. The Property Council and the Adelaide Football Club directed their membership bases to participate via 'Your Say Adelaide', where they could access all of the relevant information to inform their submission.

'That Council:

Investigate and implement free parking for critical health workers and staff during the COVID-19 crisis within the City of Adelaide.'

## **ADMINISTRATION COMMENT**

- 1. We acknowledge the work of all health care professionals along with the many other essential service providers working under increased pressure and demands during this time.
- 2. Council has provided parking support in a variety of ways since the covid-19 outbreak.
- 3. On Monday 23 March 2020 Council adopted a more flexible approach to monitoring on-street parking. Since then our Parking & Information Officers have focused on parking controls in place for safety and accessibility reasons, allowing more flexibility in ticketed and time limit zones.
- 4. In addition, Council's UPark team recently launched capped \$8 all day parking through UPark Plus, available to any city user.
- 5. As part of the North Adelaide Parking Review, we have recently converted 60 parking spaces back to unrestricted access around North Adelaide, bringing the total of unrestricted parking bays in North Adelaide to approximately 950.
- 6. Since the outbreak of covid-19 we have been in contact with the major City of Adelaide based hospitals including the Royal Adelaide, Women's & Children's and Memorial Hospitals, regarding approaches to parking for their staff. Discussions have been constructive and to date the organisations have plans in place for their staff should they be required. Some hospitals have indicated a preference not to manage their own on-street permit systems for staff and/or patients/visitors.
- 7. We also note the decision at the 7 April 2020 Special Council Meeting regarding SACA and Royal Adelaide Hospital's proposal for temporary parking for hospital staff in Park 25.
- 8. It is also worth noting there is a 128-bay permit zone already in place on McKinnon Parade for exclusive use by the Women's & Children's Hospital. This permit zone is managed by the Women's & Children's Hospital and provides subsidised paid parking for hospital staff.
- 9. We can contact each hospital again to offer and negotiate suitable free parking options for their staff and visitors. The final outcome may differ between hospitals depending on their situation.

10. We have also been approached by a number of other essential services including SAPOL, SA Health, SA Fire and Emergency Dept and a number of others providing critical services with increased demands. Each organisation has sought a level of parking support which to date we have managed by encouraging the use of the UPark discount or a negotiated rate with UPark for their staff, as opposed to free parking on the street.

Requests Administration to investigate opportunities to increase local food security for city residents by planting seeds for fruit trees, vegetables and other edible plants in public gardens and parks, as part of its response to the coronavirus pandemic.'

## **ADMINISTRATION COMMENT**

### 1. Current City of Adelaide (CoA) Food Security Initiatives

- 1.1. Veale Park/Walyu Yarta (Park 21) and Park Terrace (Park 27b) are volunteer-run community gardens located in the Park Lands. These gardens are publicly accessible, have existing community support and are always welcoming of new members or volunteers. CoA also maintains the olive groves in The Olive Groves/Pakapakanthi (Park 16) and The Olive Groves/Kuntingga (Park 7), as well as the pocket orchard in Bundey's Paddock/Tidlangga (Park 9), which includes approximately 8 fruit producing trees for the community to use.
- 1.2. CoA also provides support for food production at Common Ground Community Garden at the Joinery site, Secateurs Community Garden Group at St Andrews Hospital, North Adelaide Community Garden located behind the North Adelaide Community Centre and Library and the Whitmore Square Community Verge Garden located on the western side of Morphett Street.

#### 2. Considerations

- 2.1. There are several identified barriers that hinder more food production activities in the city:
  - a. Environmental Protection Authority requirements regarding contaminated land across the city;
  - b. On-going maintenance of assets Council v Community responsibilities;
  - c. Lack of information available and clarity on process to assist community members on how they can progress their ideas;
  - d. Funding options for projects are minimal; and
  - e. Difficulty for the community in negotiating and then securing tenure over available (and affordable) land/locations for projects.

#### 3. Opportunities

- 3.1. CoA understands that there is desire from the community to drive these activities within the city and as such, staff from a variety of programs provide ongoing support to enable the visions of local communities within the existing policies and systems. Council can also provide community with funding through its Community Development Grants Programs for small-scale projects. This funding is available for Incorporated groups and also individuals.
- 3.2. Further to this, if this motion is supported by Council, we will investigate opportunities within current Council programs and projects that have identified community support to be able to include food producing landscapes with a mix of Council and community responsibilities. These include but not limited to the Nature Strip program, Assets Renewal program and other Capital Works projects.
