19. Item 10.13 - COVID 19 Small Business Assistance [2020/00150] [C]

Moved by Councillor Martin, Seconded by Councillor Knoll,

That Council:

- Notes the City of Adelaide's current package of measures introduced for COVID-19 City recovery, including the \$4 million City Support package, and considers these in the context of those measures offered by Federal, State and Local Governments, including Capital City Councils and the City of Prospect.
- 2. Notes that, if passed, the financial impact of the Draft Bill *Local Government (Public Health Emergency) (Rate Relief) Amendment Bill 2020* is estimated at approximately \$9.7 million per quarter.
- Notes the existing measures adopted by Council to assist small business and residents, including freezing the
 rate in the dollar for the past six years resulting in a loss of rate income of \$15 million and a significant benefit to
 ratepayers.
- 4. Notes that the \$9.4 million reduction in income as a result of COVID-19 provided in the Q3 revised forecast is consistent with actual income received to date.
- 5. Notes the decision of Council at the Special Council meeting on 22 April 2020 that the CEO report to Council outlining options on how Council can achieve a \$20m reduction in operating expenditure during the 2020/2021 financial year.
- 6. Considers the adoption of any potential package of measures to further assist small business and residents as part the Special Committee Meeting workshops and Council meetings scheduled in June.
- 7. - Professor Robert Hill, Director, Environment Institute University of Adelaide: about the impact of extreme heat on trees within the greater Adelaide area.

I spoke at the Speech Pathology Australia's online awards where the City of Adelaide was presented with the Community Contribution Award for our Communication Access Accreditation project – where all staff at the Council Customer Centre, Libraries and Community Centres have been trained in ways to better support people who don't use speech or have speech that is difficult to understand.

The City of Adelaide was announced as one of three finalists in the LGA Leadership Excellence Awards in the category of Excellence in Environmental Leadership and Sustainability for the City of Adelaide's long-term Renewable Electricity Power Purchase Agreement.

Since the last Council meeting, the State Government COVID-19 restrictions have continued to be relaxed. In light of this, several Council services have returned to limited operation and many of the city's businesses reopening for trade.

All three of Council's libraries have reopened, as have our community centres. The Adelaide Town Hall has also reopened, celebrated with a performance of the Adelaide High School band on the balcony at lunch time on Friday last week.

The Recover and Reimagine portal has had more than 100 ideas submitted by the community, and we're encouraging visitors back to the city with the My Adelaide campaign.

Council is already implementing ideas, including the green heart mowed into Victoria Square/Tarntanyangga, an idea of a staff member, and the delivery of 20 outdoor heaters has begun to local cafes and restaurants to support local traders provide comfortable outdoor dining experiences which will attract more patrons to their business.'

'Thank you, Lord Mayor.

Fellow Elected Members, it is an honour to return to service as a Councillor for Central Ward, but I do so, mindful that voter participation in city elections - and in local government through much of South Australia - is disturbingly, and unacceptably, low. Each Local Government Area shares with the Electoral Commission of South Australia the responsibility for engaging voters. We must do better.

So, what are my personal policy priorities for the remaining 2.5 years of this term of Council?

Many of my thoughts about future roles and opportunities for our City Council were outlined during my election campaign, plus blogs and audio interviews available on my personal website, and there are others too that will become apparent over time.

The major challenge facing Council and ratepayers is the sustainability and value proposition of our existing operations. While we face a sharp contraction in revenue on the back of depopulating our office towers and pandemic inspired self-isolation, we are also a capital city council, with capital city responsibilities. We have a balance sheet and asset base to leverage, and clearly have been doing so with some verve in recent years.

In this context, I am convinced of the value and future power of our *cultural economy* as a driver of economic prosperity for our capital city. My accumulated experiences over 40 years: as merchant; as shop-keeper; as an arts and cultural entrepreneur; as a city precinct and public sector leader – all point in this direction.

If we can come to better understand, and leverage, the demand drivers for culture, which is not only the arts, applied arts and entertainment - but also sport and recreation, education and learning, and even as consumers and members of social interest groups and faith communities - we can turbo-charge our city economy across all three cultural economy time zones daytime, evenings, and night-times.

To paraphrase from the classic Aussie movie, The Castle - 'it's about the vibe'...

During the election campaign I advocated for a 'Adelaide City-State Summit' to bring together thought leaders and experts across a range of spheres of city life - to consider how best to focus our economic recovery interventions and concessions. Such a summit would ensure that Elected Members can hear from a range of subject experts, so as to more fully flesh-out the feedback from online engagement and outreach that Council has commendably been undertaking. This summit would best be mounted under the auspice of the Capital City Committee - a symbol of the vital relationship between the two tiers.

Summits can also have a strategic communication dividend. An up-side from such a summit is that it could help us inspire new confidence and hope among our constituents and stakeholders.

On the planning front, I am very clear that we need to embark upon the development of a new *City Plan*. It is a quarter century since the last City Plan was promulgated.

At a time when wholesale reforms to state planning are well advanced and attracting a high level of community concern, we must be ready, as a capital city, to be in the driver's seat to develop our own plan - both *for* the community and for the state government - underpinned by effective consultation effort.

And I believe that we must redouble our efforts in master planning - especially for the Greater Central West Precinct: from Tarntanyangga / Victoria Square in the east through to West Terrace, and bounded by Waymouth Street to the north and Wright Street to the south.

I also aim to practice a standard of 'in-chamber' civility toward fellow Elected Members that befits capital city governance, and that lifts community confidence and respect for their elected body.

In turn this will engender interest rather than cynicism, in what the Council is doing. And who knows, maybe this will encourage more constituents to exercise their vote.

We don't need to love each other, and nor to entrench factions that can bitterly divide us, to provide our fair City of Adelaide with sound advocacy and inspired leadership.

Each Elected Member has a role to play in modelling leadership, and to that end I foreshadow that, as an Elected Member, I will not be accepting the free tickets to our city arts and entertainments that are offered to Council as part of old-mode negotiated sponsorship arrangements. We are a tier of government - not a private corporation - and I believe we should pay our own way as individuals.

It is time to end the 'gravy train' perception that undermines our legitimacy in the eyes of electors and artists - and to model values that can be better respected by citizens and ratepayers. As a cultural advocate, I believe this is the proper course. And so if - on occasion – diplomatic courtesy requires that I accept complimentary tickets - I commit to making an equivalent-value donation to that presenting organisation.

I have deliberately chosen NOT to place motions or questions on notice on this - my first Council meeting agenda.

I look forward to making a constructive contribution to our deliberations - and I look forward to a return to the Council chamber from July. Thank you.'

- 4. Investigates a soundproofing subsidy scheme so that residents and hotels may be supported in soundproofing their premises to allow for increased night time activation around them that does not impinge upon their rights.

EXECUTIVE SUMMARY

The purpose of this report is to summarise the City of Adelaide's current package of measures to assist small business and residents and contextualise these with those packages offered by Federal, State and Local Governments, including Capital City Councils and the City of Prospect.

This will assist members with their deliberations about the adoption of any potential package of measures to further assist small business and residents in the context of the draft 2020-21 Business Plan and Budget, including its financial recovery principles, expenditure framework, fees and charges, and prudential borrowing limit at the Special Committee Meeting workshop scheduled for 15 June.

Should the Draft Bill *Local Government (Public Health Emergency) (Rate Relief) Amendment Bill 2020* be passed, the estimated cost to the City of Adelaide of providing rate remissions to eligible businesses is approximately \$9.7 million per quarter.

The report also identifies some potential packages of measures to further assist small business and residents. Should Council wish to explore the adoption of any of these measures, costings will be provided for consideration.

RECOMMENDATION

That Council:

- Notes the City of Adelaide's current package of measures introduced for COVID-19 City recovery, including the \$4 million City Support package, and considers these in the context of those measures offered by Federal, State and Local Governments, including Capital City Councils and the City of Prospect.
- 2. Notes that, if passed, the financial impact of the Draft Bill *Local Government (Public Health Emergency)* (Rate Relief) Amendment Bill 2020 is estimated at approximately \$9.7 million per quarter.
- 3. Notes the existing measures adopted by Council to assist small business and residents, including freezing the rate in the dollar for the past six years resulting in a loss of rate income of \$15 million and a significant benefit to ratepayers.
- 4. Notes that the \$9.4 million reduction in income as a result of COVID-19 provided in the Q3 revised forecast is consistent with actual income received to date.
- 5. Notes the decision of Council at the Special Council meeting on 22 April 2020 that the CEO report to Council outlining options on how Council can achieve a \$20m reduction in operating expenditure during the 2020/2021 financial year.
- 6. Considers the adoption of any potential package of measures to further assist small business and residents as part the Special Committee Meeting workshops and Council meetings scheduled in June.
- 7. Notes the easing of COVID-19 restrictions in South Australia from 11 May 2020 and that funds will be required to support demand driving initiatives directed by Council to encourage people to return to the City and to support local businesses throughout the Winter months and into Spring and Summer.

DISCUSSION

1. At its meeting on 12 May 2020, Council resolved that it:

Acknowledges the leadership of the Prospect Council and asks the Administration to prepare for consideration at the meeting of Council on June 9th a package of measures like that adopted by the neighbouring LGA to assist small business and residents that;

- 1. Allows businesses employing 100 people or fewer forced to close by Federal or State Government direction to apply to have their rates waived (or refunded, if previously paid) for the duration of their full closure. Tenants of the City of Adelaide who have received rental relief will not be eligible for the rate relief while also receiving free rent.
- 2. Extends to businesses employing 100 people or fewer, which have continued to trade and can demonstrate a decline in trade of 30% or more, a waiving of 50% of rates (or refund, if previously paid) for the duration of the decline and/or up to September 30th, 2020. Tenants of the City of Adelaide who have received rental relief will not be eligible for the rate relief while also receiving free rent.
- 3. Waives Park Lands lease and licence fees for all amateur sporting clubs or community groups until September 30th, 2020.
- 2. All levels of government across the nation have shown leadership in assisting small business and residents, and have helped our communities stay safe, healthy, and resilient during the COVID-19 crisis.
- 3. Federal Government Support
 - 3.1 The Federal Government has provided an economic stimulus package of \$259 billion to date, including:
 - 3.1.1 the JobKeeper and JobSeeker payments
 - 3.1.2 boosting cashflow for employers (payroll PAYGW refund)
 - 3.1.3 temporary relief for financially distressed businesses (statutory demand threshold increased to \$20k)
 - 3.1.4 increasing the instant asset write off
 - 3.1.5 SME Guarantee Scheme (Government guarantee 50% of lenders new loans)
 - 3.1.6 Backing Business Investment (accelerated depreciation deduction of 50% from 12 March 2020)
 - 3.1.7 Partner income test for Centrelink increased from \$48,000 to \$79,000 per year
 - 3.1.8 \$110 million initiative to help exporters get their produce into overseas markets
 - 3.1.9 The HomeBuilder program offering \$25,000 grants to new home builders and renovators.
- 4. State Government Support
 - 4.1 The State Government has provided an economic stimulus package of \$1 billion to date, including
 - 4.1.1 Economic and Business Growth Fund of \$350 million
 - 4.1.2 Jobs Rescue Package of \$650 million.
 - 4.2 Key components of this support include:
 - 4.2.1 \$300 million Business and Jobs Support Fund
 - 4.2.2 \$250 million Community and Jobs Fund
 - 4.2.3 Payroll Tax Relief (6-month waiver for businesses ≤\$4M/pa payroll and Deferred payment for 6 months for businesses >\$4M/pa)
 - 4.2.4 Waiver of Liquor Licence Fees for 2020/21
 - 4.2.5 Land Tax Relief for eligible residential and non-residential landlords (2019/20 up to 25% land tax relief and outstanding bills deferred for 6 months; 2020/21 relief increased to 100%)
 - 4.2.6 Relaxation of the current Job Accelerator Grant criteria
 - 4.2.7 \$5.7 million State Government support package provided to help local tourism operators and partners, with two programs offering direct financial support
 - 4.2.8 \$10,000 Emergency Cash Grants for eligible Small Businesses (turnover ≥\$75,000/annum and total wage bills ≤\$1.5 million)

4.2.9 \$10,000 grant funding from the South Australian Tourism Commission (SATC) to assist regional tourism organisations.


5. Local Government Support

5.1 Not immune to the financial impacts of the pandemic, local governments have offered packages of measures consistent with their mandated roles and responsibilities, tailored for their communities, and with recovery in mind.

6. City of Adelaide Support

- 6.1 Following a Council recommendation that a package of support be developed for local residents and businesses to address the social, cultural and economic impacts of the COVID-19 pandemic, the City of Adelaide acted decisively by introducing the \$4 million City Support Package, which included these assistance measures:
 - 6.1.1 100% rent free for three months for lessees of Council owned properties
 - 6.1.2 100% rent free for three months for community leases of Council owned properties
 - 6.1.3 100% rent free for three months for Adelaide Central Market tenants
 - 6.1.4 Waiving of the separate rate for the Rundle Mall precinct for three months, (at a cost of approximately \$1 million)
 - 6.1.5 A three-month waiver of all Park Land lease and licence fees for sporting clubs and community groups at a cost of approximately \$118,000 (excluding GST)
 - 6.1.6 Making the city accessible by creating more flexibility regarding on street parking regulations
 - 6.1.7 Support for our city communities especially our vulnerable communities, including outreach programs
 - 6.1.8 Increasing City of Adelaide's cleaning regime to ensure the city is kept as clean and hygienic as possible
 - 6.1.9 Facilitating access to hardship provisions advice with our Rates Hardship approach options include deferral of rates payment
 - 6.1.10 Establishing a Small Business Task Force (SBTF) to work in collaboration with Business SA, State and Federal Government Departments and other agencies through the challenges that they are experiencing as a result of the COVID-19 restrictions. The SBTF has been:
 - 6.1.10.1 Providing consistent, up-to-date information and advice to city businesses on support packages and other services available from Federal and State Governments, peak bodies and industry associations
 - 6.1.10.2 Circulating weekly COVID-19 editions of the City Business Newsletter to nearly 8,000 subscribers
 - 6.1.10.3 In direct contact with over 70 city businesses and Precinct Chairs and Coordinators (representing 700 businesses), and over 195 visitor economy stakeholders
 - 6.1.10.4 Encouraging local businesses looking to open their doors to patrons to explore collaborative marketing opportunities, and has launched a <u>video series</u> featuring the real-life experiences of our local business champions,
 - 6.1.11 In response to feedback from city businesses that further specialised advice is required to support them in responding to the impacts of COVID-19, and to position them to thrive in an increasingly globalised and digitally connected marketplace the SBTF is working with Business SA to identify and deliver a range of specialised support services.
- 6.2 An additional measure introduced by the City of Adelaide to support its city users and businesses is the UPark Plus initiative implemented in April 2020. Providing touch free parking at a significantly discounted price of \$8 for all day parking across all nine U-Park locations during April June, more than 9,500 city users have signed up for this initiative.
- 6.3 Prior measures introduced by Council to assist ratepayers include:
 - 6.3.1 Waiving all outdoor dining permit fees permanently, at a cost of approximately \$400,000 in the 2020-21 financial year (excluding GST and based on income received 2018-2019).

6.3.2 Providing ongoing rate relief to all its ratepayers over the past six years with a clear direction from Council to keep the rate in the dollar frozen. This decision has resulted in a cumulative loss of rate income of \$15 million over this same period and a significant benefit to our ratepayers.



- The City of Adelaide's current rates hardship provisions allow all ratepayers to make an <u>application for rate relief</u>. Support measures introduced to assist businesses and residents impacted by the COVID-19 crisis include:
 - 6.4.1 Postponement of payment for the 4th quarter rates (due 1 June 2020) for three months until 31 August 2020
 - 6.4.2 Repayment arrangements (weekly, fortnightly or monthly) based on an agreed amount
 - 6.4.3 No fines or interest to be charged on any 4th quarter outstanding rates (due 1 June 2020) until 31 August 2020
 - 6.4.4 Fines and interest suspended on all outstanding historic rates until 31 August 2020
 - No new debt recovery action to be instigated for any business that enters into a financial arrangement with the City of Adelaide, including any pre-existing debt.
- 6.5 The City of Adelaide's Quarter 4 rates notices sent in mid-April 2020 totalled \$25.7m (noting that some ratepayers have already paid their entire financial year rates upfront) with a due date of 1 June 2020. We have received payment for 67.74% of Quarter 4 rates to date, which compares to 72.68% for the same time last year.

6.6 The City of Adelaide has received 124 rates hardship applications for 365 assessments. This represents 1.40% of our 26,003 total assessments for 2019-2020. Of these applications, 86 have been received from commercial ratepayers.

7.1 The City of Adelaide's \$4 million City Support package aligns with and in some cases exceeds the support measures introduced by the other Capital Cities across Australia, outlined in the table below. At this stage, no capital city is offering rate waivers, and all require a ratepayer seeking assistance to make a formal application under their financial hardship provisions.

8. The City of Prospect Support

- 8.1 The City of Prospect's COVID-19 Recovery Package includes waiving and remitting of rates for commercial businesses at an estimated cost of \$500,000 for:
 - 8.1.1 Businesses forced to close or had their trade modified by Government regulation will receive a 100% remission for the current quarter, due 2 June 2020
 - 8.1.2 Businesses closed or have experienced an impact on trade for a minimum of six weeks due to COVID-19, or can demonstrate a loss of income over 60%, or are part of the Job Keeper program will receive a 50% remission for the current quarter, due 2 June 2020.
 - 8.1.3 Waiving of the Village Heart Marketing Fund separate rate for the 4th quarter 2019-2020, and the 1st quarter 2020-2021, (noting the full levy is \$19,500).
 - 8.1.4 Waiving leases and licence fees winter seasonal hires 2019-2020
 - 8.1.5 Waiving Payinthi and Nailsworth Hall facility hire fees
 - 8.1.6 Waiving footpath trader fees for 2020-2021 and reimbursing all fees paid for the current year
 - 8.1.7 Waiving fines and interest on late payment of Council rates including residential until 31 December 2020.
- 8.2 The City of Prospect receives over 88% of its income directly from rates with 7.5% of ratepayers being non-residential. In comparison, The City of Adelaide receives just 56% of its income directly from rates and 77% of ratepayers are non-residential. The financial impact of providing rate relief to a smaller base of commercial ratepayers is more suited to the City of Prospect given most of their rate income is sourced from residential ratepayers.

- 8.3 The City of Adelaide's income from non-rates sources amounts to 44% of total income and is sourced primarily from statutory fees and charges (parking fines, expiation fees, parking fees from both onstreet parking and Council's UParks and charges for the Adelaide Aquatic Centre and Golf Links) and Commercial Tenancies.
- 8.4 These income streams have all been significantly impacted as a result of COVID-19 and the restrictions that have been put in place, and limit our capacity to provide further support measures, particularly in the context of the Council request that Administration identify \$20 million in operational savings in 2020-21.
- 9. Draft Bill Local Government (Public Health Emergency) (Rate Relief) Amendment Bill 2020
 - 9.1 Introduction to Parliament on 28 May 2020 of the Draft Bill Local Government (Public Health Emergency) (Rate Relief) Amendment Bill 2020 seeks to provide an amendment to the Local Government Act 1999, more specifically the insertion of Section 165A Rebate of rates COVID-19 public health emergency.
 - 9.2 This amendment would see council rates waived for local businesses and not for profit organisations that have been forced to close as a result of Government directives in the wake of the COVID-19 crisis.
 - 9.3 The waiver of rates would apply for the period between when the restrictions commenced and ended.
 - 9.4 Based on the details outlined in the Bill, the table below shows the likely businesses that have been shut or significantly impacted as a result of COVID-19, noting that the challenge comes with determining how long a particular business has been impacted, given the restrictions vary greatly.
 - 9.5 The estimated cost to the City of Adelaide of providing rate remissions to the businesses outlined below is approximately \$9.7m per quarter. Evidence to support a rate waiver would be required rather than a blanket application across all businesses.

- 10. Additional Packages of Measures to Assist Small Businesses and Residents
 - 10.1 It is recommended that the adoption of any potential packages of measures to assist small businesses and residents is considered:
 - 10.1.1 After the outcome of the Draft Bill Local Government (Public Health Emergency) (Rate Relief) Amendment Bill 2020 is known. The financial impact of the Draft Bill is estimated at approximately \$9.7 million per quarter and will support small businesses in the City.
 - 10.1.2 As part the Special Committee Meeting workshops and Council meetings scheduled over coming weeks:
 - 10.1.2.1 The Special Committee Meeting workshop scheduled for 15 June will assist Council in its deliberations about the adoption of any potential package of measures to further assist small to medium businesses and residents in the context of the draft 2020-21 Business Plan and Budget. The workshop will focus on financial recovery principles, expenditure framework, fees and charges, and prudential borrowing limit.
 - 10.1.2.2 On 23 June, Council will meet to approve the City of Adelaide's financial recovery principles, expenditure framework, fees and charges, and prudential borrowing limit.
 - 10.1.2.3 On 30 June, Council will meet to approve the draft 2020-21 Business Plan and Budget, prior to public consultation in July and final adoption on 11 August 2020.
 - 10.2 Additional assistance or packages of measures that Council could consider (based on evidence provided by the applicant where required) could include:
 - 10.2.1 Extension of the existing \$4 million City Support package for a further 3 months (or some variation of this package).
 - 10.2.2 Deferral or waiver of all rates for small businesses forced to close as a result of mandated Federal or State Government restrictions up until 31 August 2020.
 - 10.2.3 A 50% deferral or waiver of all rates for small businesses that can demonstrate a reduction in trade, or loss of income of more than 50% up until 31 August 2020.
 - 10.2.4 Provide longer term assistance and allow small businesses a period of up to two years to pay their rates, enabling businesses the opportunity to rebuild.

- 10.2.5 Section 182 (3) of the *Local Government Act (1999)* allows Council to grant other or additional postponements of rates "to assist or support a business in its area" implying that financial hardship may not be the only criteria to be eligible for assistance.
- 10.2.6 Rates may be deferred for a longer period (the number of quarters to be determined by Council), and an encumbrance attached to the property which will be released upon sale of the property at which time the outstanding rates would be recovered. During this time, interest would continue to accrue.
- 10.2.7 Reduce the special discretionary rebate, currently set at 10% to reduce the impact of an increase in rates as a result of an increased valuation. Properties that have had an alteration or an addition or is a new development site are not eligible for the rebate. The implications of applying the discretionary rate will be discussed in detail at the Special Committee Meeting workshop scheduled for 15 June.
- 10.2.8 A targeted package to support the hotel and accommodation sectors who have experienced significant loss of business and higher than normal vacancy rates through lost bookings as a result of South Australia's strong border controls and restrictions on interstate and overseas travel as a result of COVID-19. The Hotel and Accommodation sector makes up 6.23% of all rate income generated. Annual rates raised in 2019-2020 totalled approximately \$6.9m. A rate waiver for this sector would cost approximately \$1.7m per quarter, noting that some businesses are more financially able and have the capacity to pay without any support from Council.

11. City Recovery

- 11.1 In May the City of Adelaide launched its Recover + Reimagine project which is inviting ideas from Council and the community, including businesses and residents, to help our city thrive.
- 11.2 The City of Adelaide is working closely with the State Government on initiatives related to events and city activation.
- 11.3 It is important that the City of Adelaide has sufficient funding available to support demand driving initiatives to enliven and activate City laneways, mainstreets and precincts, including the Winter Lights initiative and Splash, aimed at encouraging people to return to the City, to linger longer, and to support local businesses throughout the Winter months and into Spring and Summer.

Councillor Martin will ask the following Question on Notice:

'Could the administration advise what contractual or common law rights of termination or postponement are available to the City of Adelaide with respect to the Central Market Arcade Redevelopment?'

REPLY

- 1. As advised to Council in response to the Motion on Notice by Councillor Moran for the meeting of Council on 10 March 2020, Council has entered into a legally binding agreement with ICD Property, and Council is therefore legally bound to proceed with the CMAR Project in accordance with the terms of that agreement. Council has no entitlement under that agreement to unilaterally defer commencement of the CMAR Project or otherwise vary its terms, and it cannot do so without the agreement of ICD Property.
- 2. Any unilateral attempt by Council to defer the CMAR Project may constitute a repudiation by Council of its contractual obligations, potentially exposing Council to a termination of the Project Delivery Agreement, and a substantial claim by ICD Property for loss and damage in respect of the considerable monies already expended by ICD Property, together with future losses including loss of profit on the project. Any defence by Council of such claims would be expensive and would take place in a public forum.
- 3. Council's reputation as a body that third parties can contract with in the knowledge that Council will comply with its contractual obligations will be significantly adversely affected. That may impact Council's ability to undertake future development activity and may deter third parties from dealing with Council on major projects.

QUESTION ON NOTICE

Councillor Martin will ask the following Question on Notice:

'It was reported on May 22nd that the Federal Government had allocated \$1.8 billion to local government in Australia for road upgrades and community projects to help to offset the impacts of the coronavirus pandemic.

Could the Administration advise whether any of this funding has been allocated for;

- 1. an upgrade to the Adelaide Aquatic Centre following a Council's formal letter to gauge Commonwealth interest in supporting the project
- 2. any other project, including road works in the City of Adelaide which have been severely curtailed due to the City of Adelaide's difficult financial position?'

REPLY

- 1. The Administration can advise that funding requests have been submitted to the following Government agencies in support of a redevelopment and / or upgrade of Council infrastructure. Details of these funding requests were shared in a confidential CEO Briefing held for Councillors on 23 May 2020.
- 2. Adelaide Aquatic Centre:
 - 2.1. State Government COVID-19 Recovery Stimulus Package.
 - 2.1.1. Through various discussions with State Government, a number of projects have been identified that would deliver shared strategic interests of the City of Adelaide and the State Government, to the benefit of the city and its community, the Adelaide Aquatic Centre being one.
 - 2.2. Council of Capital City Lord Mayors (CCCLM) Economic Stimulus Projects.
 - 2.2.1. Capital City Lord Mayors have created a COVID-19 response nationwide infrastructure task force. Each Capital City is submitting infrastructure priority proposals, there is no specific criteria however 'shovel ready' is desired. The Adelaide Aquatic Centre has been proposed as one of those projects.
- 3. Councils receive a Financial Assistance Grant annually from Federal Government.
- 4. This consists of two components: General Purpose and Identified Local Road funding.
 - 4.1. General Purpose funds existing services to the community.
 - 4.2. Identified Local Road funds road infrastructure.
- 5. Annually we receive approx. \$500k. The Financial Assistance Grant allocation is calculated with population as a base, but then adds "horizontal equalisation" which considers each Council's ability to raise revenue or have above average costs of service provision. Reviewing the allocation of the current General Purpose funds shows that this is distributed consistently across metropolitan councils, however rural councils with a low population (and therefore rate income) and high visitor numbers or social programs (therefore expenditure) receive a grant allocation that is much higher per capita.

- 6. The Federal Government has brought forward its first Financial Assistance Grant payment for 2020-21 (note this is not additional funding), in response to drought, bushfires and COVID-19.
 - 6.1. City of Adelaide received \$448,866 for:
 - 6.1.1. General Purpose \$275,467
 - 6.1.2. Identified Local Road \$171,399.
- 7. The remaining pool of funding from Federal Government will be distributed in quarterly payments based on the Local Government Grants Commissions approved 20/21 recommendations.
- 8. In addition, Council has received a <u>Local Road and Community Infrastructure Grant</u>, a one-off stimulus to assist local councils to deliver priority local road and community infrastructure projects across Australia, supporting jobs and the resilience of local economies, to help communities bounce back from the COVID-19 pandemic. The City of Adelaide have been allocated \$337,528.
 - 8.1. The funding is specifically for additional works to the proposed 20/21 program, which can include accelerated projects brought forward from a future work program.
 - 8.2. The Administration will identify a program of works that aligns to the specific criteria (Local Road and Community Infrastructure Grant) to deliver during 20/21 addition to those identified in the draft 2020-21 Business Plan and Budget presented to Council at the Special Committee Meeting on 28 May 2020.

"Current deed with DPTI to run the service was due to expire in December 2023, however, the Minister has provided notice of his intention to terminate the Deed on 30 June 2020."

Could the Administration advise the date on the letter from the Minister and to whom among elected members the correspondence was distributed?'

REPLY

- 1. A letter was sent to the City of Adelaide CEO Mark Goldstone (the CEO) on 31 January 2020 by the Minister for Transport, Infrastructure and Local Government, Hon Stephan Knoll, where Council was notified of the Minister's intention to terminate the Deed on 30 June 2020. The letter also notified Council that the South Australian Public Transport Authority (SAPTA) would work with the Administration to develop new options.
- 2. Following receipt of the letter, the CEO provided a response to the Hon Stephan Knoll on 20 February 2020 acknowledging the Minister's intention to terminate the Deed. In this letter, the CEO also sought confirmation of the continuation of funding for the service and requested that SAPTA brief Council on the new service when a preferred route was selected.
- 3. The Minister responded to the CEO on 18 March 2020, advising that SAPTA would contact the Administration to discuss the proposed changes.
- 4. The consultation process was delayed as a consequence of COVID-19. The Administration was advised of SAPTA's preferred route on 20 April 2020 and Committee was briefed on the proposal on 19 May 2020.

Precinct Group Funding

- 2. If such funding is provided as at 1 above, will 20/21 funding be the same amount as for the current financial year or only part of the latter amount and what will be the process for receiving such funding
- 3. If such funding for 20/21 is not to be provided outside of the budget schedule to be completed late this calendar year, when and what amount will Council provide to Precinct Groups to enable them to assist in any post COVID City Recovery?'

REPLY

- 1. The draft 2020-21 Budget includes \$25,000 per precinct group, with an extra fund of \$80,000 for Precinct Groups to apply for specific events over and above their \$25,000 funding.
- 2. This is the same amount of funding as the current financial year and was included in the information pack and presentation discussed at the Special Committee meeting on Thursday 28 May.
- 3. The proposed 2020-21 precinct group funding will be included as part of the Expenditure Framework to be considered for adopted by Council on 23 June 2020. If the Expenditure Framework is adopted by Council precinct funding can be expended from 1 July 2020.


- 1. What is the broad use proposed for the development?
- 2. Where will it be located in relation to the West Terrace façade of the current structure?
- 3. Is it suggested that the new structure will increase the High School's buildings footprint on the Park Lands?
- 4. If the new development has been presented to the City of Adelaide for consideration?'

REPLY

- 1. The intended use for the proposed expanded teaching facilities is to accommodate an additional 300 students transitioning from year seven to high school at the commencement of 2022.
- 2. The two proposed teaching facilities will be located as follows and as shown in the following aerial image:
 - 2.1. A new building referred to as the 'Central Hive' will be located on the western side of Adelaide High School and within the existing Adelaide High School land parcel (shown in red in the following aerial image) – note this building replaces an old structure
 - 2.2. The rooftop of the southern wing (constructed in 2014) is proposed to be enclosed to provide additional science and general learning space note part of the southern wing (as shown) sits outside of the existing Adelaide High School land parcel and is subject to a yet to be finalised lease with the City of Adelaide.
- 3. The proposed new structures will not increase the current footprint of Adelaide High School on the Park Lands.
- 4. The State Commission Assessment Panel is the relevant authority. Council's role in the planning assessment is confined to providing comment on technical matters such as waste management and traffic movements.
- 5. The proposed new development:
 - 5.1. Was considered by the Adelaide Park Lands Authority at its meeting on 6 February 2020, in confidence. The Boards advice was provided to the meeting of Council on 11 February 2020.

5.2. Will be presented to Council at a date yet to be confirmed seeking 'landlord consent' as the extension to the southernmost building is partially located on council land (outside the red boundary shown below).

Rebuilding Adelaide's night life

MOTION ON NOTICE

Deputy Lord Mayor (Councillor Hyde) will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

'That Council:

- 1. Notes the City's \$1 billion per annum night economy has been devastated by the coronavirus (COVID-19) pandemic.
- 2. Notes that many cities around the world now have nightlife advocates, such as New York (the 'Nightlife Mayor'), London (the 'Night Tsar'), Amsterdam (the Nachtburgemeester") among many others, but that no Australian jurisdiction has a nightlife advocate.
- 3. Investigates the appointment of an advocate for the City's nightlife and economy that would act in the interests of all elements of the night economy, including live music and entertainment, hospitality, liquor licensing and other related policy matters, such as managing the complicated interface between the night and daytime economies and residents' rights to the quiet enjoyment of their properties.
- 4. Investigates a soundproofing subsidy scheme so that residents and hotels may be supported in soundproofing their premises to allow for increased night time activation around them that does not impinge upon their rights.'

ADMINISTRATION COMMENT

- 1. The proposal for a Night Ambassador was previously considered by Council in 2016. If the Motion is supported by Council, an investigation can be undertaken to determine if the appointment of an advocate for the City's nightlife would assist all elements of the night economy whilst protecting residents' rights.
- 2. Since 2006 Council has supported a Noise Management Program, with the purpose to assist residential property owners to undertake noise attenuation works by providing expert advice via Council's Acoustic Advisory Service (AAS) and financial support via Council's Noise Management Incentive Scheme (NMIS). The Program acknowledges the importance of achieving co-existence between different land uses by seeking to improve the quality of the living environment for residents.
- 3. The Acoustic Advisory Service (AAS) provides a free consultation service with a qualified acoustic engineer (external to Council) to provide general acoustic advice to eligible residents. The service makes recommendations on possible physical changes to their residence to address external noise issues, and assesses the suitability of work for financial assistance under Council's Noise Management Incentive Scheme. The service also provides a final site visit by the qualified acoustic engineer (free of charge) to check the completed acoustic works.

- 4. The Noise Management Incentive Scheme (NMIS), the first of its type in Australia, reimburses a proportion of the costs involved in undertaking the recommended acoustic works to the value of 50% of the total cost up to a maximum of \$1,100, noting it is proposed that the NMIS grant will increase to \$1,200 as of 1 July 2020.
- 5. Council does not have a scheme for non-residential properties.

Carparking Levels for Infill Developments

MOTION ON NOTICE

Councillor Khera will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

'That Council:

Requests administration provide a brief report on the impacts on local businesses of zero to minimal parking requirements for new apartment approvals, the ensuing expansion of permit parking, and the effect on business patronage with respect to drivers from outside the city, with a view to forming a council position on the matter. The report should consider the impacts on businesses that rely on outside visitation.'

ADMINISTRATION COMMENT

- 1. The Adelaide (City) Development Plan is the statutory document that guides the required car parking provision for new developments within the City. The car parking provision for developments are dependent upon the Zone in which the site is located.
- 2. There are no car parking spaces required for any form of development (e.g. residential or commercial) within the Capital City Zone which includes the core business area of the city. Whilst there is no car parking requirement in the Development Plan for new developments in the Capital City Zone, car parking is often provided in new buildings due to market demand. Purchasers either make the decision to pay for a car parking space or purchase an apartment without one and then either have no car, use other transport methods or store a car within a private car park.
- 3. For developments within other Zones such as the Main Street Zone, City Frame Zone and City Living Zone, the car parking requirement depends upon the type of land use proposed.
- 4. Under the current Residential and Visitor Permit Operating Guidelines, apartment buildings are defined as being ineligible for any sort of residential parking permit.
- 5. Residential parking permits are only issued to properties in certain areas, which does not include the core business area.
- 6. If this Motion is successful a report will be prepared with further detail on the current Development requirements on required carparking provisions for new apartment builds, any related impacts to on street parking availability in the city and potential effects on business patronage.
