MOTION ON NOTICE

Deputy Lord Mayor, Councillor Courous will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

‘That **part 1 of the decision of Council on 15/12/2020** in relation to a Proposed Event in the Park Lands – RCC 2021, namely:

“THAT COUNCIL

1. **Approves RCC 2021 to operate between Friday 19 February 2021 and Sunday 21 March 2021 in the southern half of Victoria Square / Tarntanyangga with trading times restricted to 10pm each day of operation.**
2. Notes public consultation was conducted on the City of Adelaide Your Say website for Option A and Option B, however MOMENTARILY PTY LTD withdrew their intention to pursue Option A after the completion of the consultation period.
3. Authorises the Chief Executive Officer to approve any further changes required to the event application where the change is necessary in order to fulfil a COVID Management Plan or COVID Safe Plan approved by SA Health. “

be amended to read as follows:

“THAT COUNCIL

1. **Approves RCC 2021 to operate between Friday 19 February and Sunday 21 March 2021 in the southern half of Victoria Square / Tarntanyangga with trading hours to 11.00pm Monday - Thursday (with the exception of the long weekend Sunday to midnight) and Friday and Saturday to midnight, with the following considerations/conditions:**
 - 1.1 **To a maximum of 85dB (A) at Front Of House (FOH), which is the weekday maximum noise levels allowed as stated in the Event Amplified Sound Management Guidelines.**
 - 1.2. **Noise bond of \$20k to be applied in accordance with the Event Amplified Sound Management Guidelines.**
 - 1.3. **That the Event Licence for RCC includes a requirement to develop and provide to Council a Business & Precinct Engagement Plan that will seek to ensure surrounding businesses are provided with information about the event and that, in particular, surrounding businesses will have the opportunity to partner with and benefit from the event.**
 - 1.4. **Requests Administration develop an activation plan to create the pedestrianisation of Gouger Street, in consultation with traders, underpinned by the same principle as East End Unleashed and conducted without unduly restricting access to the Adelaide Central Market on Friday night and Saturday morning.’**

ADMINISTRATION COMMENT

1. The amended recommendation as stated to approve the RCC 2021 event to operate [11.00pm Monday - Thursday](#) (with the exception of the long weekend Sunday to midnight) and Friday and Saturday to midnight, does comply with the Victoria Square/Tarntanyangga criteria for event use as detailed in the [Adelaide Park Lands Event Management Plan \(APLEMP\)](#) and is consistent with what the applicant has requested.
2. The [Adelaide Park Lands Event Management Plan \(APLEMP\)](#) Victoria Square/Tarntanyangga criteria for event use state the following operating hours: Sunday - Thursday: Close 11pm. Fridays & Saturdays: Close 11:59pm. Sundays that precede a Monday public holiday: Close 11:59pm on the Sunday. Open 11am for alcohol trade. Events can commence from 7am.

4. These operating hours proposed by the event applicant for RCC 2021 comply with the Victoria Square/Tarntanyangga criteria for event use as stated in the Adelaide Park Lands Event Management Plan (APLEMP).
5. Administration will include in the Event Licence a condition that the event organisers of RCC develop a business and precinct engagement plan, this plan will be provided to Administration and required as part of the event organisers final approval.
6. An activation plan to support businesses to attract people to the precinct, using the same principles as with the East End will be developed by Administration. An update will be provided to the Elected Members on the progress of the activation plan and the final implementation of the activation will be based on the outcomes of the engagement with the precinct and businesses.
