### Acknowledgment of Country & Moment Silence in Remembrance of Departed Community Members

Co-Chair, Lord Mayor Sandy Verschoor read the Kurna Acknowledgement.

*'The City of Adelaide Reconciliation Committee acknowledges that we are meeting on traditional Country of the Kurna people of the Adelaide Plains and pays respect to Elders past and present. We recognise and respect their cultural heritage, beliefs and relationship with the land. We acknowledge that they are of continuing importance to the Kurna people living today.*

*And we also extend that respect to other Aboriginal Language Groups and other First Nations who are present today.'*

### Committee Discussion

Discussion ensued in relation to:

- Item 5.1 – Report - Stretch RAP 2018-2021 Implementation Progress Report – January to March 2019
  - Ms Nicole Gollan, Reconciliation Officer, Participation & Inclusion, City of Adelaide, provided Committee members with an update of progress in implementation of City of Adelaide's Stretch Reconciliation Action Plan 2018-2021 for Quarter 3 2018/2019.
- Item 6.1 – Presentation - Reconciliation Committee Strategic Agency Representation
  - Ms Caro Mader, Manager Participation & Inclusion, City of Adelaide provided an update to indicate that Ms Vicky Welgraven had resigned as the Reconciliation South Australia's (SA) Board representative on the City of Adelaide Reconciliation Committee and advised that Mr Joel Bayliss would represent Reconciliation SA.
- Item 6.2 – Presentation – 2019 NAIDOC Week
  - Ms Nicole Gollan, Reconciliation Officer, Participation & Inclusion, City of Adelaide, provided an update on the Theme (Voice, Tree, Truth) for the 2019 NAIDOC Week and activities proposed.
- Item 6.4 – Presentation - Kurna Yerta Aboriginal Corporation (KYAC) update
  - Jeffrey Newchurch, KYAC Chairperson, provided an update on KYAC activity, processes and priorities.
  - A short documentary 'Aboriginal and Torres Strait Islander Repatriation' was shown, documenting the repatriation of the ancestral remains of two Kurna Old People who were returned from institutions in Sweden and Austria in August 2018. The Old People were welcomed back to Australia by Kurna Elders at a ceremony in Canberra and then finally returned to their Country at a repatriation reburial ceremony at Tennyson Dunes.

- Item 6.3 – Presentation - APY Art Centre Collective
  - Deb Myers, Operations Manager APY Art Centre Collective, utilising a PowerPoint presentation introduced the APY Art Centre Collective and informed the City of Adelaide Reconciliation Committee of the new Anangu gallery studio space being launched in May 2019.

During discussion following Item 6.4 and prior to receiving the Presentation listed in Item 6.3 the meeting adjourned at 3.21 pm for 15 minutes and resumed at 3.37 pm.

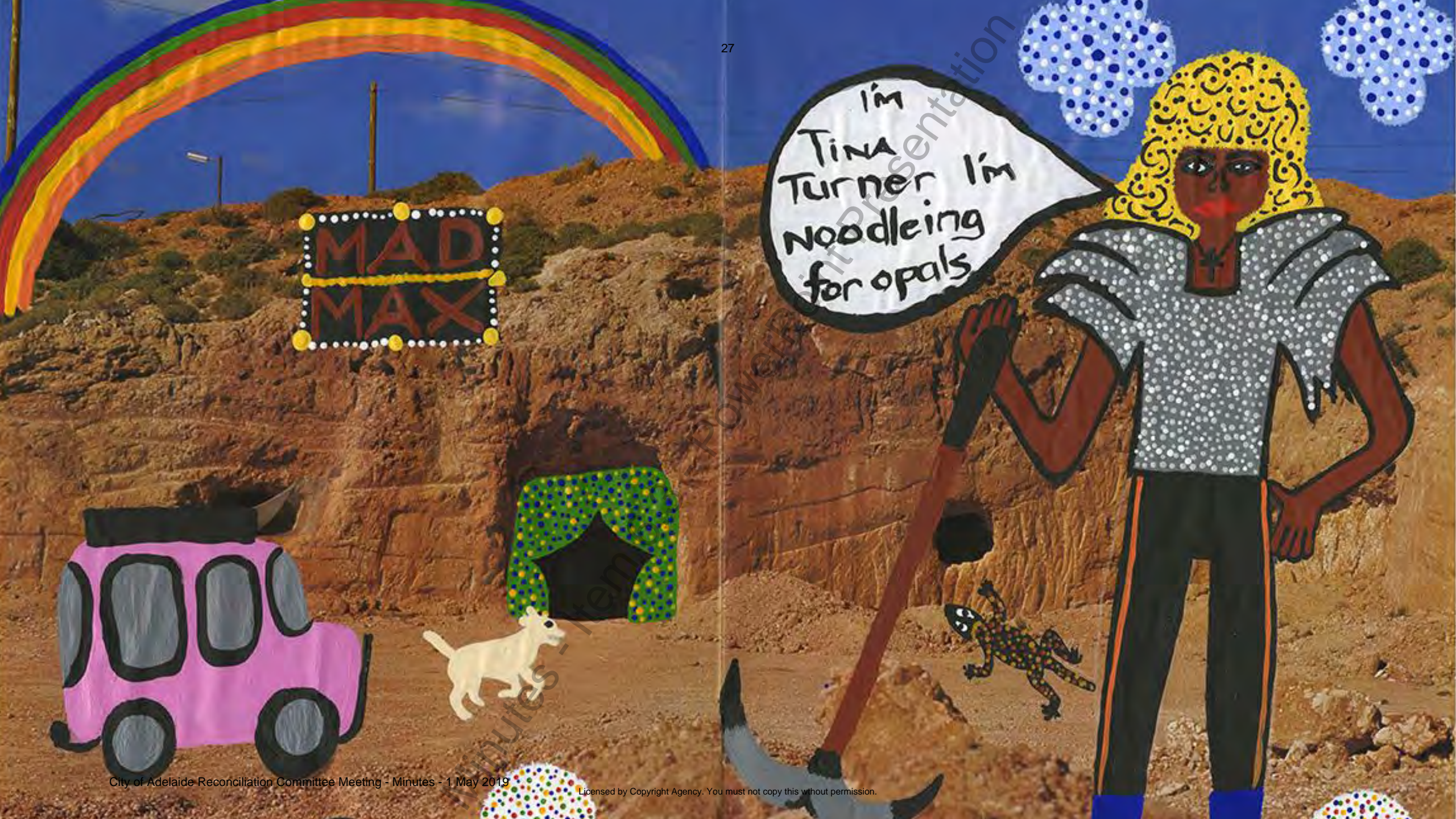
