Acknowledgment of Country & Moment Silence in Remembrance of Departed Community Members

Co-Chair, Lord Mayor Sandy Verschoor read the Kaurna Acknowledgement.

'The City of Adelaide Reconciliation Committee acknowledges that we are meeting on traditional Country of the Kaurna people of the Adelaide Plains and pays respect to Elders past and present. We recognise and respect their cultural heritage, beliefs and relationship with the land. We acknowledge that they are of continuing importance to the Kaurna people living today.

And we also extend that respect to other Aboriginal Language Groups and other First Nations who are present today.'

  - Ms Nicole Gollan, Reconciliation Officer, City Wellbeing (CoA) provided Committee members with an update on the strategic representation on the City of Adelaide Reconciliation Committee.
  - Mr Ian Liddy, a newly appointed Strategic Agency representative addressed the meeting to acknowledge Elders in the room, past and present, introduce himself and provide some background about himself

  - The Reconciliation Committee acknowledged that a Kaurna Cultural Mapping Project was to be presented to the Adelaide Park Lands Authority and noted that Mr Marty Reeve undertook to also present the Project to a meeting of Council's The Committee.




## Uncle Mickey's Episode

## **Snapshot of status**

Stakeholder engagement has progressed with the original Project Advisory Group.

## Location

The location of the *Place of Reflection* will be in the South West corner of Murlawirrapurka / Rymill Park (Park 14) pocket park alongside Tandanya National Aboriginal Cultural Institute as highlighted.





## **Vision and Themes**

## What we heard from the workshop with the Project Advisory Group:

- A place to remember, to commemorate and to pay respect.
- The artwork project should be inviting, while also providing private and safe space where people feel comfortable, like a hug or embrace where the community can come to remember and mend.
- The artwork should reflect stories and connections to water including ripples, as a symbol that encourages healing, cleansing and wellbeing.
- It should include sculpture, signage, story boards, seating and landscaping, including native plants and Aboriginal landscaping techniques.
- Elements of significant cultural relevance, such as kangaroos, emus and the coolamon could be incorporated, using materials that are reflective of the landscape.
- Provide opportunities for the employment and engagement of Aboriginal people in its delivery.
- With the intention that the site will be used by community for events and gatherings that commemorate/celebrate significant dates within the Aboriginal cultural calendar.



## **Artists & Engagement**

### **Artists**

As guided by the Project Advisory Group, this public art opportunity will be Aboriginal led. The opportunity will be offered to artists who identify as Aboriginal.

- Collaborative proposals from professional creative teams can include the support of artists, designers or other
  professionals of non-Aboriginal background to assist in delivery.
- The artist team must be experienced in working with a variety of Aboriginal community members including Elders and the respectful handling or interpretation of cultural knowledge.

## **Engagement Plan**

In collaboration with the City of Adelaide, the artist team will develop an engagement plan that will supplement and inform the development of the artwork.

Providing the opportunity for conversation, sharing of knowledge, and insight of the experiences of the Stolen Generation community.

## **Public Art Reference Group**

A **Public Art Reference Group (PARG)** has been established to provide expert advice and key stakeholder advice during the delivery of the public art process to create the artwork.

PARG will meet to assess and provide recommendations about the

- preferred artists to be invited to develop concepts; and
- preferred concept to be commissioned.

### PARG will consist of:

- Four nominated representatives from the original Project Advisory Group for the project, from
  - Kaurna Nation Cultural Heritage Association
  - Journey of Healing
  - Link Up/Healing Foundation
  - City of Adelaide Reconciliation Committee
- One member from the City of Adelaide's Public Art Round Table;
- One member from the City of Adelaide Public Art Assets Team;
- One member as an external Aboriginal art expert.
