## EXECUTIVE SUMMARY

On 22 May 2018, the City of Adelaide endorsed its second consecutive <u>Stretch Reconciliation Action Plan 2018-</u> 2021, launched on 28 May 2018 at Reconciliation SA's National Reconciliation Week Breakfast.

On 1 July 2018, the Stretch Reconciliation Action Plan 2018-2021 took effect, guiding a shared vision for delivery of meaningful reconciliation between the City of Adelaide and Aboriginal and Torres Strait Islander peoples.

Reconciliation Action Plan (RAP) delivery is monitored internally by a Reconciliation Action Plan Team (RAPT) that meets quarterly. Updates provided at this meeting form the basis of this quarterly update report to the Reconciliation Committee, to Council and to Reconciliation Australia. Reconciliation Australia, the creator of the RAP tool and with whom the City of Adelaide Stretch RAP 2018- 2021 is registered, also monitor City of Adelaide Stretch RAP 2018- 2018- 2021 is report.

Implementation of City of Adelaide Stretch RAP 2018- 2021 actions delivered between January to February 2021 is noted here.

# DISCUSSION

- 1. On 22 May 2018, City of Adelaide endorsed its second Stretch RAP 2018-2021.
- 2. The City of Adelaide's Stretch RAP 2018- 2021 builds on the legacy of previous City of Adelaide RAPs in guiding Council's vision for meaningful reconciliation with Aboriginal and Torres Strait Islander peoples in the City and more widely.
- 3. The City of Adelaide's Stretch RAP 2018- 2021 has 50 actions. Each has an officer of Council who, alongside their team and leaders, co- created the action including its timing, resourcing and integrated strategic alignment and who is responsible for its delivery.
- 4. Quarterly monitoring of delivery progress of the 50 Stretch RAP 2018- 2021 actions is undertaken by the team of 37 RAP action holders or RAP Champions. Their updates form the basis of this report.
  - 4.1. Understandably due to COVID-19 impacts, administration is reviewing the 37 RAP Champions on an ongoing basis to ensure the progression, accountability and actioning of Stretch RAP 2018-2021 actions.
- 5. A range of actions have been delivered and are captured in the Stretch RAP 2018- 2021 Implementation Progress Report January to February 2021 [Link 1].
  - 5.1. Understandably workflow has decreased dramatically and or came to a complete halt due to COVID-19 disruptions and its circumstances in which the update of action will be reflected as "pending".
- 6. As we transition through and out of COVID-19, delivery of actions will intensify.

## EXECUTIVE SUMMARY

The City of Adelaide's Stretch Reconciliation Action Plan (RAP) 2018-2021 has reached its final year guiding the shared vision for delivery of meaningful reconciliation between Council and Aboriginal and Torres Strait Islander peoples. The City of Adelaide Reconciliation Committee is actively guiding the drafting of a new Stretch RAP 2021-2024 and commends the Stretch RAP creation process and strategic document to Council as a useful means of continuing to progress City of Adelaide's Reconciliation objectives.

The creation of Stretch RAP 2021-2024 will become the City of Adelaide's third Stretch RAP and tenth RAP, displaying an extensive commitment to reconciliation to the wider community. This report provides a summary of the community engagement process from which a draft Stretch Reconciliation Action Plan 2021-2024 will be created.

# DISCUSSION

- 1. The City of Adelaide's Stretch RAP 2018-2021 [Link 1] has reached its final year guiding the City of Adelaide's shared vision for the delivery of meaningful reconciliation with Aboriginal and Torres Strait Islander peoples.
- 2. The current City of Adelaide Stretch RAP 2018-2021 has been acclaimed by members of local Aboriginal and Torres Strait Islander communities and other stakeholders as enabling meaningful reconciliation outcomes in the City and more widely.
- 3. The current Stretch RAP 2018-2021 has been described as "strong", "wholistic", "ambitious" and "innovative" by owners of the Reconciliation Action Plan program, Reconciliation Australia.
- 4. The City of Adelaide's Stretch RAP 2021-2024 will build on the legacy of previous City of Adelaide RAPs in guiding Council's vision for meaningful reconciliation with Aboriginal and Torres Strait Islander peoples in the City and more widely.
- 5. The Stretch RAP 2021-2024 drafting process consists of multiple community engagements, multiple consultations and drafting stages.
- The Stretch RAP 2021-2024 Community Engagement Process [<u>Link 2</u>] includes four distinct consultations as follows:
  - 6.1. Internal consultation with City of Adelaide administration via a series of workshops to generate a list of ideas and opportunities.
  - 6.2. External consultation with Kaurna Yerta Aboriginal Corporation (KYAC), including a specific workshop targeted at youth to generate a list of ideas and opportunities.
  - 6.3. A facilitated external consultation workshop with wider Aboriginal and Torres Strait Islander community members, CBD based Aboriginal organisations and businesses to generate a list of ideas and opportunities.
  - 6.4. Online engagement via the Your Say Adelaide engagement platform process providing an opportunity for the wider community to generate a list of ideas and opportunities. The consultation opened on Monday 8 February 2021 and closed on Monday 22 February 2021. The Information Pack [Link 3] provides background information on the RAP process and seeks community input.

- 7. The feedback received through the consultation engagement process will be presented to the Reconciliation Committee once it has been collated and will inform the development of the draft Stretch RAP.
- 8. The draft Stretch RAP 2021-2024 will be created in direct consultation with the City of Adelaide Reconciliation Committee over the next few months through a workshop. This will allow for oversight and Aboriginal and Torres Strait Islander community endorsement.
