#### **Committee Discussion**

  - Nicole Gollan, Reconciliation Officer, City Planning & Heritage, City of Adelaide (CoA), gave a precis of the final Stretch Reconciliation Action Plan (RAP) 2018 2021 report on the 50 actions, undertaken by the team of 37 RAP action holders, otherwise known as RAP champions and deliverables achieved from the City of Adelaide Stretch Reconciliation Action Plan 2018 2021, in particular:
    - Action 40 Encourage and support sustenance and growth of Aboriginal and Torres Strait Islander Languages where the creation of language snake jigsaws were used at community events and in library and community centre activities from creation in 2018.
    - Action 10 Explore ways in which the City of Adelaide will recognise dates that are significant to Aboriginal & Torres Strait Islander peoples resulting in the inaugural Kids on Country Event in 2019.
    - Action 21 Install Kaurna Acknowledgment in City of Adelaide facilities resulting in the Acknowledgment of Country inscribed on the customer centre wall behind front counter in 2020.
    - Action 3 Celebrate National Reconciliation Week to strengthen and maintain relationships between Aboriginal and Torres Strait Islander staff and non- Aboriginal and Torres Strait Islander staff – providing educational and promotional opportunities during National Reconciliation week and throughout the year by working in partnership and empowering others to provide reconciliation programs and activities in the City of Adelaide community centres and libraries.
    - Action 4, work with Kaurna to identify opportunities to incorporate First Nations understandings of native biodiversity management strategies that can be used in the Park Lands resulting in the delivery of the historical 2021 Kaurna Kardla Parranthi Cultural Burn.

- Item 5.2 Stretch Reconciliation Action Plan 2021 2024 Final Endorsement
  - Nicole Gollan, Reconciliation Officer, City Planning & Heritage (CoA), gave a precis of the Stretch Reconciliation Action Plan (RAP) - 2021 – 2024 final version to note, outlining:
    - The preparation and consultation process of the Stretch Reconciliation Action Plan 2021 2024.
    - The monitoring program including that Reconciliation Australia as the manager of the RAP program monitors the CoA Stretch RAP implementation with an annual progress report.
    - The Stretch RAP is the City of Adelaide's third Stretch RAP and tenth RAP in total, displaying an extensive commitment to reconciliation to the wider community both state wide and nationally and continues to build on the legacy of previous City of Adelaide RAP in guiding Councils vision for meaningful reconciliation with Aboriginal and Torres Strait Islander peoples in the city and wider area; and that
    - The City of Adelaide is the first local government in Australia to reach such a milestone in the RAP program.



# Update: Aboriginal and Torres Strait Islander artwork in the City

- The City of Adelaide Strategic Plan and Cultural Strategy have commitments that Aboriginal and Torres Strait Islander peoples and cultures are strongly represented in city life.
- The Public Art Action Plan also commits to the delivery of public art that celebrates Adelaide's rich and vibrant Aboriginal and culturally diverse identities.
- The Stretch Reconciliation Action Plan embraces public art, including exploring locations, funding and partnership opportunities for a statue of Iparrayti and a memorial to Sir Douglas Nicholls.
- 20 artworks currently exist across the city, and 10 are in planning or progress.



### Update: City of Music Laneways: No Fixed Address Lane mural

- The City of Music Laneways project names Adelaide laneways after music identities who have experienced success of which Adelaide is proud.
- A prominent laneway in the heart of the City has been named after No Fixed Address, the first Aboriginal reggae rock group in Australia and the first Aboriginal band to tour overseas.
- The lane includes new street signage, plaques and artwork to build on Adelaide's reputation as place of culture and creativity.
- A mural that honours the band has been created by local Aboriginal artists Elizabeth Close, Shane Cook and Thomas Readett.
- The laneways is being promoted as a cultural tourism site and marketed as part of the wider City of Music Laneways trail.

### Update: Female Leaders in the Adelaide Town Hall Chamber: Aunty Shirley Peisley AM

- A project to include portraits of women in the Chamber that have contributed significantly to shaping our city and state.
- Council has approved commissions or loans of portraits of six female leaders, all of whom have all achieved significant firsts in local political, social and cultural spheres.
- A key portrait commission that is underway is of Aunty Shirley Peisley AM, first Co-Chair of the Reconciliation Committee.
- Dr Ali Gumillya Baker has been selected for this commission. Dr Baker, a Mirning woman from the Nullarbor on the West Coast of South Australia, is a highly regarded photographic artist, performer and filmmaker, with artworks held in national collections.

### Update: A Place of Reflection

- A high-profile memorial that will promote healing for members of the Stolen Generations, their families and friends and the wider community.
- To be created in the South West corner of Murlawirrapurka (Park 14) alongside Tandanya National Aboriginal Cultural Institute.
- The artist brief was shared with 13 talented, local and national Aboriginal artists with a connection to South Australia, seeking their interest in developing an artist team to deliver a sculptural and landscape integrated artwork.
- Four artists with significant cultural reputations, strong artistic experience and personal links or experience of the Stolen Generations have been engaged to create concepts:
  - Uncle Donald 'Bluey' Roberts
  - Aunty Yvonne Koolmartrie and Exhibition Studios
  - Troy Anthony Bayliss
  - Paul Herzich
- Concepts will be considered by the Public Art Reference Group in early September, to inform a recommendation for the preferred artist to proceed to undertake delivery of the artwork.

### Update: Contemporary acquisitions - Civic Collection

- As part of the Creative Sparks program, City of Adelaide makes acquisitions of contemporary artworks as a reflection of the evolution of the City.
- A diverse range of artworks are acquired from local artists, including those that reflect and celebrate Aboriginal and Torres Strait living cultures.
- Recent acquisitions include artworks by:
  - Anna Dowling, a descendant of the Badimia people of the Yamatji region in Western Australia. Her work represents the cultural and physical resilience and fortitude of the Aboriginal community.
  - James Tylor, a multi-disciplinary artist whose practice explores Australian environment, culture and social history. His work reflects the perspectives of his multicultural heritage comprising Nunga (Kaurna Miyurna), Maroi (Te Arawa) and European (English, Scottish, Irish, Dutch and Norwegian) ancestry.
  - Brad Darkson, who currently works across various media including sound, sculpture, multimedia installations and painting. Conceptually, his work is informed by strong ties to both his Narungga First Nations and Anglo Australian heritage.

### Update: Aboriginal and Torres Strait Islander professional development in Public Art Grants

- New grant program introduced in 2021 to provide professional development opportunities for Aboriginal and Torres Strait Islander artists, artisans, and creatives in Public Art.
- Delivered through mentorships, fellowships, internships, and placements.
- Funded by Arts South Australia and the City of Adelaide to facilitate and increase participation and input from Aboriginal and Torres Strait Islander creatives in the City.
- Five inaugural grants awarded to:
  - Guildhouse new mentorship for Aboriginal and Torres Strait Islander artists as part
     of its Catapult program.
  - Open Space Contemporary Arts (OSCA) an Aboriginal and Torres Strait Islander artists and creatives inclusion program.
  - Nancy Bates work with the Titjikala Womens' Choir (NT), creating new songs in language.
  - Mali Allen-Pearce her project Mali Isabel Art Launch.
  - Janet Milera skills development and mentoring with renowned Adelaide contemporary artist Ruby and a cultural mentorship with Dr. Uncle Dookie O'Loughlin.

### What is APLA?

The City of Adelaide has long recognised the value of the Adelaide Park Lands to the city, state and its inhabitants. Since 2005 the Park Lands have received protection when the State Government passed the <u>Adelaide Park Lands Act 2005</u> (SA).

This does four main things:

1. Defines the Adelaide Park Lands

2. Requires a management strategy for the Park Lands

3. Establishes seven statutory principles for the management of the Park Lands

4. Establishes the Adelaide Park Lands Authority – as an advisory body to the City of Adelaide and the State Government.

### Who is the APLA Advisory Board?

APLA is chaired by the Lord Mayor of Adelaide and has four members appointed by the Council and five members appointed by the state. Current membership is as follows:

The Lord Mayor Ms Sandy Verschoor (Presiding Member), Ms Kirsteen Mackay (Government Architect – Deputy Presiding Member), Ms Allison Bretones (Executive Officer Parks and Leisure Australia (SA/NT region), Mr Rob Brookman AM (former Executive Director, Adelaide Festival), Ms Jessica Davies-Huynh (Director on the Kaurna Yerta Aboriginal Corporation board), Mr Stephen Forbes (Botanist), Councillor Alex Hyde (City of Adelaide), Ms Stephanie Johnston (Heritage and Urban Planner), Mr Craig Wilkins (CEO of the Conservation Council of SA) & Mr Ben Wilsmore (Landscape Architect (Past President AILA SA).


# The Role of APLA

The City of Adelaide manages approximately 80 per cent of the Park Lands, with the remaining 20 per cent (which includes the Botanic Garden and Botanic Park) managed by the South Australian Government.

APLA is principally an advisory body on Park Lands matters which also prepares the Adelaide Park Lands Management Strategy. It has its own <u>charter</u>.
