### **EXECUTIVE SUMMARY**

On 8 June 2021, Council approved the Stretch Reconciliation Action Plan (RAP) 2021-2024. The Stretch RAP was launched and took effect on 7 July 2021 at the Lord Mayor's NAIDOC Luncheon.

The Stretch Reconciliation Action Plan 20121-2024 is a shared vision for the delivery of meaningful reconciliation between the City of Adelaide and Aboriginal and Torres Strait Islander peoples.

Reconciliation Action Plan delivery is monitored internally by a Reconciliation Action Plan Team that meets quarterly. Updates provided at these meetings form the basis of quarterly update reports to the Reconciliation Committee, to Council and to Reconciliation Australia. Reconciliation Australia who is the manager of the RAP program also monitors the City of Adelaide Stretch RAP 2021-2024 implementation via an annual progress report.

This report details the first quarterly update of the Stretch Reconciliation Action Plan 2021-2024.

### DISCUSSION

- 1. The new Stretch Reconciliation Action Plan 2021-2024 (Link 1) was launched during NAIDOC Week 2021.
- 2. The Stretch RAP 2021-2024 builds on the legacy of previous City of Adelaide RAPs in guiding Council's vision for meaningful reconciliation with Aboriginal and Torres Strait Islander peoples in the City and more widely.
- 3. The City of Adelaide (CoA) is recognised by Reconciliation Australia as the first Council in local government in Australia to reach the milestone of 10 consecutive RAPs.
- 4. This Stretch RAP was jointly created by incorporating the opportunities identified during the community engagement process, and was drafted in direct consultation with:
  - 4.1. The CoA Reconciliation Committee, allowing oversight and Aboriginal and Torres Strait Islander community endorsement of such significant cultural content.
  - 4.2. The Kaurna Yerta Aboriginal Corporation, including Kaurna youth.
  - 4.3. The broader Aboriginal and Torres Strait Islander community in South Australia.
  - 4.4. The City of Adelaide's Administration to ensure accountability regarding commitment to deliverables, a responsible officer (internal RAP champion), resourcing and timelines of delivery.
  - 4.5. CoA Marketing and Communications team to support the launch and the design of the Stretch RAP 2021-2024. The design encompasses our Language Snake utilising the earthy pastel colour palette from our 2020 NAIDOC in the Mall artwork.
- 5. On 26 October 2021, City of Adelaide's internal Reconciliation Action Plan Team (RAPT) was formed and inducted into the role that each staff member plays in promoting Reconciliation at the City of Adelaide.
- 6. The RAPT is made up of "champions" key staff who hold responsibility for delivery of actions within the Stretch RAP 2021-2024.
- 7. As the Stretch RAP 2021-2024 was endorsed after budget planning had already been set for 2021/22, many of the actions are scheduled for delivery from 2022 onwards.
- 8. However, there are some early actions due for delivery by December 2021. These are all on track and further progress reporting will be made at the next Reconciliation Committee meeting in February 2022.
- 9. The table below highlights the actions of the Stretch RAP 2021-2024 with an early deliverable by December 2021. Each action has other deliverables due throughout the life of the Stretch RAP.

**Update:** A Place of Reflection

A high-profile memorial that will promote healing for members of the Stolen Generations, their families and friends and the wider community.

The artist brief was shared with 13 talented, local and national Aboriginal artists with a connection to South Australia, seeking their interest in developing an artist team to deliver a sculptural and landscape integrated artwork.

**Four artists** with significant cultural reputations, strong artistic experience and personal links or experience of the Stolen Generations were engaged to create concepts:

- Uncle Donald 'Bluey' Roberts and Marijana Tadic
- Aunty Yvonne Koolmatrie and Exhibition Studios
- Troy-Anthony Baylis, JPE Design and Guildhouse
- Paul Herzich, Mantirri Design

Concepts were considered by the Public Art Reference Group to inform a recommendation for the preferred artist to proceed to undertake delivery of the artwork.



Location: within Murlawirrapurka/Rymill Park alongside Tandanya National Aboriginal Institute

Yvonne Koolmatrie & Karl Meyer with Exhibition Studios have been awarded the creation of the artwork

#### **Yvonne Koolmatrie**

- Yvonne is a Ngarrindjerri weaver from the Riverland, who has been exhibiting her work across the world for over 30 years.
- She represented Australia at the Venice Biennale in 1997, with her works held in countless galleries across the country.
- 64 pieces of her work were exhibited in the Tarnanthi Festival in 2015.
- Yvonne was awarded the 2016 Australia Council for the Arts. Red Ochre award for the achievements.

## Karl Meyer & Exhibition Studios

- Karl Meyer is a SA based artis/designer with a successful portfolio of creating pubic artworks over the past decade.
- He has completed major pubic art commissions in SA, ACT and QLD.
- He is the managing Director of Exhibition Studios, a firm specialised in creation, design and construction for creative **projects**.

### The concept design features:

- the cultural symbolism of a meeting place
- seating elements spaced around the outer diameter representing the petals of a flower when seen from above
- weaving and the natural elements as an expression of culture, creation, connecting and healing
- a focal sculpture of a mother figure with hands holding arms as if nurturing a missing baby.

**The next step** will be for the artist team to detail the concept design in consultation with the City of Adelaide project team including documentation such as methodology, engineering reports, risk assessment and maintenance plans in accordance with Australian Standards, Building Codes and Legislation.

The City of Adelaide Project team will also work with the artist team to help realise and facilitate information sharing about the project with the community.

The Place of Reflection is intended for delivery by May 2022.
