Co-Chair, Lord Mayor Sandy Verschoor read the Kaurna Acknowledgement.

The City of Adelaide acknowledges that we are meeting on traditional Country of the Kaurna people of the Adelaide Plains and pays respect to Elders past, present and emerging.

We recognise and respect their cultural heritage, beliefs and relationship with the land.

We acknowledge that they are of continuing importance to the Kaurna people living today.

And we also extend that respect to other Aboriginal Language Groups and other First Nations who are present today.'

The reading was followed by a minute of silence for departed community members

#### **Confirmation of Minutes**

The Reconciliation Committee resolved to confirm the September, October (Special) & December meeting Minutes in February 2022.

#### Committee Discussion

Discussion ensued in relation to:

- Item 6.2 Puti on Kaurna Yerta
  - Lois Boswell (Chief Executive Officer Department of Human Services), Dale Agius (Principal Advisor on Aboriginal partnerships & practice Department of Human Services), Aaron Ken (Iriwi) and Alex Reid (Executive Director Community and Family Services Department of Human Services) were present as a follow up on a discussion with the Reconciliation Committee relating to the intention to establish a hub in the city and with pride gave an update on putting on the *Puti on Kaurna Yerta* project in addressing aims to decrease rough sleeping in the CBD, in particular:
    - Indicating a pride in presenting and acknowledging that many present in the Colonel Light Room have been part of Puti on Kaurna Yerta including Uncle Jefferey and Aaron Ken as the leaders of the two Chairs of the two organisations that have been the cultural lead
    - Goals.
    - Key Principles.
    - Aboriginal Cultural Leadership.
    - Iwiri & Kaurna together.
    - Cultural Protocol Gathering.
    - Puti and supports/services at Puti.
    - Learnings, system observations and lessons.
  - The Reconciliation Committee noted that the Safety & Wellbeing Taskforce would also be presenting to Council.
  - At the conclusion of the update Me Jefferey Newchurch left the Colonel Light Room at 3.20pm.

- Item 6.1 Aboriginal Art and Cultures Centre project
  - Shouwn Oosting (Aboriginal Stakeholder Engagement Lead, Lot Fourteen Project, Department of the Premier and Cabinet) accompanied by Jason Downs (Manager Client Engagement), provided details to inform and update on emerging plans for the LOT Fourteen Aboriginal Art and Cultures Centre project:
    - Adelaide City Deal Lot Fourteen Projects.
    - Lot Fourteen Precinct Overview.
    - The Circle First Nations Aboriginal Entrepreneur Hub.
    - Aboriginal Arts & Cultures Centre.
  - During the update Mr Jefferey Newchurch re-entered the Colonel Light Room at 3.22pm.

    - Identify where parking will be and will there be an agreement with Kaurna Nation as a whole.
    - Identify details on augmented virtual reality theatre space creating a future not looking at future
    - Arrange a presentation in 2022 relating to the curation of collections.
- Item 6.3 Australia Day Council of SA
  - Gina Rings (First Nations Producer) and Jan Chorley (Chief Executive Officer Australia Day Council) provided an update on emerging plans for 2022 Australia Day:
    - First Nations Program ADCSA 2019-2021.
    - AUS Day in the Markets.
    - AUS Day in the Mall.
    - AUS Day in the Park Elder Park.
  - During the update Mr Ian Liddy left the Colonel Light Room at 3.56pm and re-entered at 3.59pm.
  - At the conclusion of the update Mr Ivan-Tiwu Copley left the Colonel Light Room at 4.05pm.
- Item 6.4 Public Art update
  - Sarah Feijen (Team Leader, Arts & Culture, City of Adelaide) and Logan MacDonald (Project Lead, Public Art, Arts & Culture, City of Adelaide) gave an update on A Place of Reflection:

    - Yvonne Koolmatrie & Karl Meyer with Exhibition Studios awarded the creation of the artwork.

  - Jeffrey Newchurch, KYAC Chairperson provided Committee members with an update on KYAC activity, processes and priorities, including Puti on the Park, a telephone interview with himself and Aunty Lynette with people from London around National Park City and a major repatriation on 7 December 2021. A reburial at Smithfield Memorial Park of 130 First Nations Old People at a dedicated Kaurna memorial site called Wangayarta.

  - Nicole Gollan (Reconciliation Officer, City Planning & Heritage, City of Adelaide) gave a precis of the 2021-2024 Stretch Rap Quarterly Update, in particular:

      documents to ensure all employees and Senior Leadership provide an Acknowledgement
      of Country upon commencement of business where applicable.
    - Action 23 Ensure a diversity of Aboriginal and Torres Strait Islander archival materials, images and stories are appropriately used across Council business and its subsidiaries 25 November 2021 at the Adelaide Central Market hosted a photo shoot specifically for Aboriginal talent for their current and upcoming summer and Christmas campaign. A successful photo shoot images included inter-generations and gender balance challenging the typical stereotype of Aboriginal peoples.
    - Action 29 City of Adelaide Reconciliation Action Plan Team (RAPT) meets quarterly to actively monitor RAP implementation – 26 October 2021 internal RAPT formed and inducted RAPT champions
    - Office of Lord Mayor Civic Functions and Commitments Acknowledgment and celebration of success of Aboriginal Youth Accommodation, Tika Tirka and presentation of Keys to the City dedicated to and honouring Uncle Lewis Obrien.

# Puti on Kaurna Yerta


## Goals

- Improve safety and wellbeing of at-risk visitors (and those around them).
- Reduce anti-social behaviour by visitors.
- Facilitate the return to country for those who wish to go.



## **Key Principles**

- Responses must embed Aboriginal community leadership, cultural authority and cultural frameworks
- 2 Responses must be multi-agency, collaborative, coordinated, flexible, person-centred and assertive
- 3 There are no 'quick fixes': we must embed governance, planning and collaboration, at both the operational and strategic level, for short, medium and longer-term outcomes
- 4 Encourage and support individuals to maintain connection or reconnect with communities
- 5 Responses must include locally based as well as broader (population-wide) strategies.



# **Aboriginal Cultural Leadership**

## Kaurna Yerta Aboriginal Corporation Represent the country

- Cultural authority for matters relating to land, water, language and protocols of the Kaurna people
- Guidance around Kaurna cultural matters; ceremony, Welcome to Country, relationship dynamics, kinship connections and behaviour/conduct while on country

# What's at Puti?

- Camping for approximately 50 people day and night (and daily visitors during daylight hours)
- DHS and other agency staff from 7am 10pm, 7 days a week
- Security (7pm to 7am) and culturally supportive policing
- Dedicated MAPS Bus from 4pm-6am
- Diversionary activities including yarning, church and music
- Limited meals, tea and coffee and snacks, camp cooking
- Three large mobile showers and additional toilets
- Two small buildings, with kitchen and clinic
- Large outdoor bbq
- Fire pits and fire wood









# A snapshot after 37 days...

- Far more individuals recorded at the Hub than expected
- Dozens have returned to community (approx. 50% from NT)
- Many vaccinations delivered at the Hub
- ID cards processed for many individuals
- Large numbers of Centrelink onsite appointments
- Successful admissions to Withdrawal Services, Glenside
- Successful admissions to Aboriginal Sobriety Group site

# "Ngapartji Ngapartji"

'I give you something, you give me something'.

This is a Pitjantjatjara concept of reciprocity and exchange

Currently services try and build relationships that are either transactional in nature or they act like welfare and proceed to give them everything they ask for. Both of these are limited in creating change and are damaging in the long run, by creating dependency. "

# What have we learnt in 5 weeks?

- More remote visitors frequenting the CBD than understood
- Extremely high levels of alcohol addiction, some IV drug use and multiple comorbidities
- Strong cultural leadership is critical to all decisions
- People congregate and form communities and will continue to
- Many people want to change their lives and return to country
- Significant system gaps exist for this group
- Services can partner, create a safe gathering place and develop individualised case plans.
- This approach is labour intensive and requires strong, single agency coordination

# System observations and lessons

## SAPOL

- Drinking/fighting/congregating outside Government House,
   North Terrace, Whitmore Square have significantly reduced
- Several incidents of violence/unrest managed by means other than arrest
- Excessive alcohol consumption is the main cause of violence
- Domestic violence continues to be an issue

# System observations and lessons SA Health

- Access to early individualised support and primary health care leading to better outcomes
- Main reasons for ED presentations: psychosocial; chronic skin conditions; diabetes; respiratory infections
- Regular assertive outreach from all services in a safe, regular and central environment
- Certain specialist supports important to enabling sustainable outcomes

# System observations and lessons

- Safe Gathering Spaces enable better and quicker service access
- Hub model drove re-engagement with services
- Supportive approach to assisting prison-exit process and prevention of poor outcomes
- Connection to safe accommodation and supports for Remote visitors fleeing family violence
- Homelessness is not the primary issue
- Return to Country needs to be a cultural response first.

# Other key strategies

**Puti on Kaurna Yerta** is one of six strategies developed by the Safety and Wellbeing Taskforce to keep the community – both visitors and residents – safe.

The remainder include:

- 1. Embedding cultural leadership and authority
- 2. CBD Remote Aboriginal Visitor Outreach and Service Hub
- 3. Safe places to stay and transitional accommodation options
- 4. Culturally appropriate alcohol & other drug responses
- 5. Improving pathways to successfully Return to Country
- 6. Improving amenities and developing culturally safe places to connect



# Where to from here?

## Puti on Kaurna Yerta

- 1. Continue weekly assertive case management across all services
- 2. Continue efforts to return people to country if appropriate and safe
- 3. Continue wrap around health services and supports including AOD
- 4. Implement a new approach to exceptional needs clients
- 5. Explore a safe place to gather and access services in the future
- 6. Explore temporary and/or transitional housing alternative
- 7. Bring together Kaurna, APY and Warlpiri nations











# 04.03 Proposed Massing Level 1




#### 04.04 Mode Diagrams Lower Ground






