In April 2016, Council resolved for Administration to undertake a Local Area Traffic and Parking Management Plan for the South Ward Local Area. The project was deferred until the new Council commenced in November 2018.

The project is strategically aligned with the Parking objectives under the Smart Move Interim Action Plan 2016-2018, being that Council will develop and implement North Adelaide and South Ward local area traffic and parking management plans.

Based on a review of the North Adelaide Local Area Traffic and Parking Management Plan Project, staff have worked to ensure that the South Ward study address the LATPM principles as well as taking a more holistic review of the street environment. It has enabled residents, businesses and visitors a chance to look at the streets they use as well as how the local streets meet their needs.









## Parking

LIVEABLE OUTCOME

- Visitors and businesses want more, residents want less
- Residents would prefer space is used for gardens or bike lanes
- Perceived lack of parking (and parking time limits) impacts businesses
- Residents without permits find it hard to park close to home, and difficult for visitors

"Do away with 15 minute/ 30 minute parking restrictions. I am less likely to come here for breakfast on the weekends if I have to walk for miles"

"Parking permit for commercial lease holders, I move my car 5 times a day to avoid getting parking tickets!"

"Much less parking needed"





- Many want to see improvements to bike infrastructure (on and off road)
- Priority should be making the area safe for cyclists and pedestrians (wider bike lanes, safer streets, off-street paths)

"Prioritise pedestrians-cyclists-scooters over cars with every decision" "Physically separated bike lanes" "More one way streets and less parking would allow for protected bikeways"





 Desire for more gardens on verges, green median strips, benches, water fountains, and more appealing pavers on footpaths (removing black bitumen).

"More small trees and plants replacing car parks to break up the streetscape- like Ada Street!"

"Benches allow for street life"

"Gilles Street has new grey concrete pavers,
now lets do the same of South Terrace please"

"Perhaps a community garden to encourage
local socialising and produce growing"





- Many recognise the value and benefits of e-scooters
- Though they often pose a safety concern when not in use
- Become an eye sore
- Designated areas, stands, and cages would help

"The scooters are the best!"

"Unregulated scooter parking must be addressed as it is a big hazard"

"E-scooters look great fun and are an economical way to get around the city for young people"

#### Public Transport.

People feel that the free bus service could be improved - more frequent and more efficient routes.

#### The Hutt Street Centre.

The provision of services to homeless and vulnerable people is extremely important however sometimes this can negatively impact on the experience of residents and visitors in the south ward.

Residents would like to see electricity poles removed and underground electricity installed.

Would improve aesthetic and allow room for gardens.



Overall, engagement was high

People are happy with the South Ward, but would like to see Council make changes.

It is important that residents and businesses feel istened to and that some tangible changes are implemented.

# Top Priorities.

# Contentions.

People want to see a solution for e-scooters lying around the South Ward.



The most disagreement was with parking. Visitors and businesses want more, and residents want less.



#### **External Actions**

- Report back to the project Steering Committee with the results of the engagement
- Finalise the engagement report, and round back with the community with a summary of the engagement
- Provide a summary of the engagement to the City Access team to ensure that relevant issues are given due consideration in the City Access Strategy

#### **Internal Actions**

- Review the feedback and ensure that location specific comments and issues are collated and provided to the relevant Administration staff for review/action
- Develop an internal process that ensures that any new or renewal infrastructure projects have taken into consideration the design elements identified by the community from the engagement.
- Report back to Council in April 2020 with feedback from external and internal stakeholders with the outcomes and opportunities from the above actions
