# City Street Activation Key Messages

- At the Council meeting on 9 March 2021 Council requested updated Parklet Operating Guidelines be prepared
- The needs of the city have changed following COVID-19 with requests being received from businesses for use of public space in response to varying levels of physical distancing restrictions
- Parklets provide potential to:
  - facilitate new and/or expanded outdoor dining spaces
  - increase patronage through physical distancing in line with COVID-19 requirements
  - support businesses through increased vibrancy and street activation.
- The Temporary Use of Public Space Policy and new Permit Fee Model endorsed by Council in 2020 provide the framework for updated guidelines
- Based on feedback, proposals being received and review of the past Parklet Program, there are three key principles we are seeking Council Members input on.

Parklets are created by re-imagining road or parking spaces to provide outdoor space for nearby cafés, restaurants and shops. Bike racks, planter boxes, landscaping and other amenities can also be included.

# City Street Activation Summary of Original Parklet Program

### Background

- The original Parklet Program ran from 2012-2016 and Operating Guidelines were developed to support implementation
- Council worked with a number of local businesses to create privately funded parklets
- At the same time the State Government installed 9 parklets (Bank St)
- The Operating Guidelines lapsed with the closure of the Parklet Program in 2016
- Only 3 parklets remain from this original Program
- Most have been removed due to street upgrades and business changes in some cases the upgrades included Outdoor Dining opportunities reflective of success of the parklet (i.e. Gawler Place)
- Since the closure of the original Program administration has continued to receive requests for parklets of various quality
- The development of a Parklet policy and operating guideline will assist CoA to provide clear and consistent advice on proposals

## City Street Activation Lessons learnt from the previous Parklet Program

### What worked well

- Parklets work best in locations where pedestrian traffic is already high
- Early and wide consultation with the affected community and businesses

### What we learnt

- Parklet administration is very resource intensive
- The design and quality of the parklets vary enormously
- Parklets were predominately for commercial use associated with adjoining business
- Post closure removal of parklets can be difficult to negotiate

### **Opportunities**

Potential for parklets to provide:

- Increased physical distancing in line with COVID-19 requirements
- Support for businesses to promote vibrancy and activations
- Clear guidance on design and quality requirements
- Varied uses
- Test-bed for trialling whether permanent changes to infrastructure would be beneficial

### City Street Activation Key Matters for Parklets

### Matters to be considered for parklets:

- Location site suitability, impacts on drainage, lighting, infrastructure, traffic, proximity to other parklets, amenity
- Safety traffic, cyclists and pedestrians, night visibility, standards for construction
- Design public realm quality, structural standards, size
- Furniture and fixtures (non-permanent vs permanent)
- Landscaping to improve and soften overall appearance
- Perception of privatisation of public space
- Responsibility for maintenance and cleaning
- Loss of parking spaces and revenue should limits be placed to reduce impacts on parking?
- Fees what are costs to Council, should applicants be charged fees or pay a bond
- Consultation and decision making processes
- Tenure length of permit, opportunity to extend or renew
- Compliance

### What are Council Members' views on fixed structures?

The current Outdoor Dining Operating Guidelines do not allow fixed furniture.

**Opportunities** 

- Fixed seating creates a permanent space with multiple opportunities for utilisation
- Fixed furniture provides more design options for applicants and often better outcomes for patrons
- Fixed barriers provide protection for patrons and create a safer environment
- Permanent customer protection (eg sun and rain) can provide year round activation opportunities
- Does not require the storage space of non fixed furniture by businesses

### Challenges

- Pergolas/fixed awnings may interfere with security camera visibility
- Enclosed areas may create spaces for anti social behaviour after hours
- Significant expenditure by applicants on fixed structures may increase expectation for exclusive occupation of the space

# What are Council Members' views on the designation of parklets for private use only?

Considerations

- Parklets can provide improvements to the public realm and activate public spaces for use by all
- Parklets in CoA are primarily developed and funded by local business operators
- Perception that private enterprise is getting financial benefit from public space
- A high quality parklet can require up to \$40,000 of private investment to install. Given this investment businesses may prefer exclusive use

# What are Council Members' views on charging fees for Parklets?

Considerations

- Council adopted a new Permit Fee Model in September 2020
- Charging fees for parklets in line with the Permit Fee Model is consistent with the use of public space in the CBD
- Outdoor Dining permit holders are not currently charged a fee
- Parklets differ from general outdoor dining as they can reduce on-street parking availability and associated revenue

- Additional trading area assists business viability
- Parklets provide flexibility for businesses to operate under varying levels of physical distancing restrictions
- A bond could be required from applicants to ensure removal of the parklet at no cost to Council if the permit lapses or business closes
- Parklet assessment is resource intensive for administration
