THAT COUNCIL

- Acknowledges the City of Adelaide's ongoing commitment to supporting positive ageing in our community.
- 2. Authorises the Chief Executive Officer or delegate to advise the Federal Government funding body that Council will commence the transition out of delivery of Commonwealth Home Support Program services in 2025, with services facilitated through the City of Adelaide ceasing on 30 June 2025.
- 3. Notes that Commonwealth Home Support Program services currently delivered to City of Adelaide residents, will remain accessible for eligible residents through alternative providers and that Administration will work with current clients and the Department of Health and Aged Care, to ensure a smooth transition to a new provider.

3. Requests administration to halt the progress of the Light Square Master Plan, due to serious concerns regarding financial transparency, traffic disruptions, economic harm to local businesses, inadequate consultation and the lack of alternative traffic solutions.

'3. Requests administration to pause the progress of the Light Square Master Plan, due to serious concerns regarding financial transparency, traffic disruptions, economic harm to local businesses, inadequate consultation and the lack of alternative traffic solutions, and defer the matter to a Committee workshop.'

Discussion ensued

Councillor Martin called a point of order against Councillor Davis around a comment he made regarding a 30km/hr speed limit in the city. The Lord Mayor ruled that Councillor Davis had spoken inaccurately.

Councillor Davis called a point of order against Deputy Lord Mayor, Councillor Elliott for breaching Regulation 29 of the *Local Government Procedures at Meetings*) Regulations 2013, for casting doubt on Council Members' motives, and requested the Lord Mayor remove Deputy Lord Mayor, Councillor Elliott from the Council Chamber. The Lord Mayor ruled against the point of order.

Councillor Davis called a point of order against Councillor Noon for breaching Regulation 29 of the *Local Government Procedures at Meetings*) Regulations 2013, for being disruptive and requested the Lord Mayor remove Councillor Noon from the Council Chamber. The Lord Mayor ruled against the point of order.

Councillor Davis called a point of order against Councillor Noon, for disrespect to Councillor Couros, when the motion for extra time for Councillor Couros, had allegedly failed. The Lord Mayor ruled to continue the meeting.

QUESTION ON NOTICE

Councillor Phillip Martin will ask the following Question on Notice:

'Noting the motion adopted by Council in April 2024, could the Administration advise;

- 1. What progress has been made further to its advice in October 2024 that it was in discussions with DIT about increasing walk time for pedestrians at traffic signals crossing O'Connell Street and,
- 2. Whether the Brougham Street intersection has been included in these discussions?'

REPLY

- 1. On 11 October 2024, an E-News was published which provided Council Members with an update on pedestrian signal operation along O'Connell Street. Noting that the Department for Infrastructure and Transport (DIT) had provided in-principal support to extending the pedestrian crossing time for all east-west crossings of O'Connell Street, North Adelaide, CoA will work with DIT to implement the following changes:
 - 1.1. reduce the cycle length where possible, most notably in the midday and off-peak times.
 - 1.2. increasing the pedestrian walk time setting (green man) to 8 seconds for east-west movements across O'Connell Street and 12 seconds for north-south movements parallel to O'Connell Street.
- 2. On 23 October 2024, Council staff met with DIT to discuss the implementation of the proposed changes, and an agreed action was assigned to DIT to progress the changes.
- 3. Council is awaiting an update regarding date of implementation.
- 4. A meeting is scheduled for 27 February 2025 to discuss this matter with DIT after which a further update will be provided to Council Members.
- The intersections included in discussions to date have been the intersections on O'Connell Street between Barton Terrace West and Ward Street which does not include the Brougham Place intersection. Council staff will discuss with DIT the inclusion of the Brougham Place intersection in the proposed changes at the meeting on 27 February 2025.
