 purpose of community consultation commencing at 9:00am on Tuesday 6 May 2025 and
 concluding at midnight Tuesday 27 May 2025, subject to the following amendment:
 - 1.1 That a proposed Minimum Rate of \$600 is introduced as part of the Draft 2025/26 Rating Policy.
- 2. Authorises the Chief Executive Officer to make any necessary changes to the Draft 2025/26 Business Plan & Budget document arising from this meeting, together with any editorial amendments and finalisation of the document's formatting and graphic design.

Discussion ensued, during which Councillors Couros and Abrahimzadeh entered the Colonel Light Room at 5.33 pm.

With the consent of the mover, seconder and the meeting, the motion was varied to include an additional 3 parts to read as follows:

- 1.2. That the proposed 2025/26 Road Event (Closure Fees) apply to State and Federal Government agencies and entities.
- 1.3. That the proposed transfer of Precinct Activation resources of \$0.822m (including 3.0 FTE) to the Adelaide Economic Development Agency remains within the City Culture Program, subject to a final decision by Council in relation to the Precincts Review.
- 1.4 That the Community Sports Building Redevelopment (Concept Design) allocation of \$100k for 2025/26 be the subject of a further report to Council in relation to confirming the project to be selected from the Community Buildings Priority Needs Analysis.'

Discussion continued, during which the Lord Mayor sought leave of the meeting to adjourn the meeting for a period of 5 minutes.
