24 Item 13 - Lord Mayor's Reports

Councillor Hyde left the Council Chamber at 6.03pm.

The Lord Mayor addressed the meeting as follows:

'Tonight, Council has adopted its 2022 financial result, which includes a \$977,000 operating surplus - turning an operating deficit into a surplus for the first time in nine years while freezing the rate in the dollar for the ninth consecutive year.

This is a significant achievement, especially given the impacts of COVID-19 and the more than \$20 million in support Council has provided to our businesses and community, including our extensive efforts to attract people back into the city.

I would like to thank our CEO Clare Mockler and the administration for their diligence in bringing the budget back into the black while also achieving \$24 million in savings.

This work has been done while delivering a capital program of more than \$45.2 million (up from \$32.3 million the previous financial year) and quarantining \$21 million in Council's Future Fund for strategic investment into new revenue generating in new assets and opportunities to grow our city in the future.

Also on the agenda tonight is Council's End of Term report and it really is remarkable how much has been achieved for our community over the past four years.

Unlike previous Councils, we have had a global pandemic to contend with and in addition to the rapid and ongoing support for our businesses, Council kept our community safe and connected during the 2020 and 2021 shutdowns and the devastating Omicron wave earlier this year.

We increased the cleansing of public spaces, automated all of our pedestrian crossings, facilitated access to vaccinations and testing as well as assisted vulnerable residents to access groceries and medication and stay connected to friends and family.

Despite the unprecedented circumstances we found ourselves in, we continued to shape our city for the future with once in a generation projects like Eighty Eight O'Connell and Market Square getting underway.

We also continued to be a city of firsts leading the way with the first Kaurna Kardla Parranthi / Cultural Burn in the Adelaide Park Lands in more than 200 years and becoming the first Council in South Australia to be accredited carbon neutral.

Our city is better placed for the future as a result of the work we have done over the past four years and I'd like to thank members for their contribution and representation of our city ratepayers, residents and businesses.

For the members who aren't running again, thank you for your service to the City of Adelaide and to those who are, I wish you the best of luck.'

QUESTION ON NOTICE

Councillor Martin asked the following Questions without Notice:

'Noting the Advertiser report published on August 21st 2021 and stating that Council had been paid \$28 million for the air rights above the redeveloped Central Market Arcade known as Market Square, could the Administration advise if this amount has been added to the Future Fund calculations shown on page 9 of the Council's Long Term Financial Plan under the heading Future Fund and Investment Policy and, if not, why not?'

REPLY

- 1. The Project Delivery Agreement (PDA) for the Central Market Arcade Redevelopment incorporates a sale of air rights.
- 2. The PDA stipulates that this air rights payment is to be deducted from the total cost of Council's returnable works. Therefore, there are no cash funds received from the sale of air rights, rather it is accounted for as an offset of monies owed for the returnable works portion of the contract.
- 3. Given this treatment, the sale of air rights is not recognised in the Future Fund. The Future Fund and Investment Policy refers to proceeds from asset sales to be deposited into the fund. Accordingly, this has not been accounted for in the Long Term Financial Plan.
