11 Item 13 - Lord Mayor's Reports

The Lord Mayor addressed the meeting as follows:

'May I firstly congratulate all of you on being elected for the 2022-2026 term. We are making the transition from candidate to decision-maker, with the majority of councillors, 7 of 12, newly elected and therefore, needing to learn about Local Government and capital city governance as well as the status quo.

Local Government is not only the most accessible for candidates seeking election, it is also the most relevant to people's every day lives.

We are privileged to have great influence and a degree of power and with that great responsibility toward our community.

As the Capital City Council, our role and our decisions are particularly important. Our city is the engine room of our state and it's vital that we represent not just the narrow range of those who elected us within this city, but recognise we represent the city's entire eco-system and to some extent, the essence of being South Australian.

Looking around the chamber, I'm impressed by the skills you all bring and I'm full of optimism for the term ahead. We have now completed the majority of our mandatory training under the Act and I look forward to working with you for the benefit of the city.

Since being elected, I have met with Premier Peter Malinauskas and Minister Champion and discussed a range of matters where the state and city can work together. I look forward to progressing these conversations.

I have begun to meet Council staff and have said in my first address to them that one of my goals is to ensure the Corporation is an employer of choice in local government, offering both prestige and career paths.

I might add that our aspiration for our operations should be aimed at high quality policy debate, good design and exemplary implementation. This will bring prestige to our capital city and install pride in our staff. I would also hope that as the capital city we could continue to mentor and support other local governments as we have done through policy and resource sharing.

Shortly, we will elect a Deputy Lord Mayor. It is my intention to work with whoever is chosen but have said to potential candidates that I would prefer an existing rather than newly elected councillor take the role.

I am keen to have a return to a Committee structure and two Council meetings per month. A Committee structure would allow perhaps three or four councillors to be appointed as Chair and provide an opportunity for councillors, not just the LM and DLM, to chair meetings.

My other intention is to ensure that every member of council has a role as a chair of a significant committee or a representative or nominated role on an external body.

To this end, I look forward to the workshop to be held on the 6th of December where we will ensure we understand the implications of the proposals before us.

The path forward could be assisted by the passage of Councillor Martin's motion on notice, which endorses the increase in number of Council meetings and changes to the Committee structure without, I hope, being prescriptive.

I am keen that we as a new Council build on the positive achievements of our predecessors and we will I am sure, put in the necessary work to be timely, strategic and focused.

You would know that significant deadlines approach. The most pressing an understanding of our finances in order to set a strategic budget and agenda and importantly, responding to the planning review. I am pleased to inform you that the Minister has extended the deadline to the 30th of January. This is still a challenging period of the year and a short time frame.

I have, therefore, decided that this year's Christmas Lunch and Reception will not be going ahead. With only

five weeks between being sworn in and Christmas Day, I believe the time would be better spent coming to grips with the issues the city faces.

Council recently announced an exciting program of community Christmas events for us all to enjoy during the festive season including a free Christmas Concert at Adelaide Town Hall. I encourage everyone to get out and about and enjoy some Christmas cheer in the city. I look forward to our meetings and working with you all in the future.
