5 Item 4.1 - Revised Strategic Priorities

The Chair gave a precis of the item indicating that feedback from the November 2021 meeting had been included in the strategic priorities.

Discussion ensued in relation to strategic priorities, measurement and purpose of a leadership / development tool.

Unanimous Decision

That the CEO Performance Review Committee:

- Approves the revised wording for the strategic priorities, as provided in Item 4.1 on the Agenda for the meeting of the CEO Performance Review Committee held on 3 March 2022, subject to the following revisions:
 - 1.1 Inclusion of the following dot point in the Build partnerships to enable new opportunities section -
 - Build and maintain relationships with city stakeholders with a stakeholder management plan
 - 1.2 Vary the 2nd and 3rd dot point in the Robust financial management section to read -
 - Identify a minimum of 2 new revenue streams

6 Item 4.2 - 360 Degree Leadership Review Tools

The Chair gave a precis of the item.

Order to Exclude the Public

That the CEO Performance Review Committee

1. Having taken into account the relevant consideration contained in section 90(3) (b) and section 90(2) & (7) of the *Local Government Act 1999 (SA)*, this meeting of the CEO Performance Review Committee dated 3 March 2022 resolves that it is necessary and appropriate to act in a meeting closed to the public for the consideration of Item 4.2 [360 Degree Leadership Review Tools] listed on the Agenda.

Grounds and Basis

Discussion of commercial considerations associated with this Item is sought to protect the commercial position of the council and not confer a commercial advantage on a provider.

The disclosure of discussion in association with this Item could reasonably be expected to confer a commercial advantage on a person with whom the council is proposing to conduct business and prejudice the commercial position of the council.

Public Interest

The CEO Performance Review Committee is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of this information may result in release of information prior to the finalisation of 'commercial in confidence' negotiations conferring a commercial advantage on a person with whom the council is proposing to conduct business at this point in time, and because the disclosure of commercial considerations could prejudice council's position and ability to discuss/participate or influence a proposal for the benefit of the Council and the community in this matter and in relation to other contract negotiations.

2. Pursuant to section 90(2) of the Local Government Act 1999 (SA) (the Act), this meeting of the CEO Performance Review Committee dated 3 March 2022 orders that the public (with the exception of members of Corporation staff and any person permitted to remain) be excluded from this meeting to enable this meeting to receive, discuss or consider in confidence Item 4.2 [360 Degree Leadership Review Tools] listed in the Agenda, on the grounds that such item of business, contains information and matters of a kind referred to in section 90(3) (b) of the Act.

Members of the public and Corporation staff present not directly involved with Item 4.2 left the Colonel Light Room at 11.20am.

Discussion ensued in confidence relation to the providers and tool identified in Item 4.2.
