2. Acknowledgement of Country & Moment Silence in Remembrance of Departed Community Members

Co-Chair, Lord Mayor Sandy Verschoor read the Kurna Acknowledgement.

The City of Adelaide acknowledges that we are meeting on traditional Country of the Kurna people of the Adelaide Plains and pays respect to Elders past, present and emerging.

We recognise and respect their cultural heritage, beliefs and relationship with the land.

We acknowledge that they are of continuing importance to the Kurna people living today.

And we also extend that respect to other Aboriginal Language Groups and other First Nations who are present today.'

4. Committee Discussion

Maria Zotti (Manager Park Lands & Sustainability, City of Adelaide) informed and provided an update on the review of the Adelaide Park Lands Management Strategy 2015-2025 outlining:

- The Adelaide Park Lands Management Strategy (APLMS) must be reviewed at least once every 5 years and is prepared and maintained by Kadaltilla / Park Lands Authority, the principal advisory body to Council and State Government on protection, management, enhancement and promotion of the Adelaide Park Lands.

- The overarching intent of the APLMS.
- Current APLMS content in relation to Kurna.
- Kadaltilla / Park Lands Authority is seeking to collaborate with Kurna community to develop and review the APLMS and has written to Kurna Yerta Aboriginal Corporation seeking involvement.
- Alignment between the City of Adelaide's Stretch Reconciliation Action Plan and review of the APLMS.
- Review Timelines.

Susanne Panagaris (Business Development Manager, The Circle - First Nations Entrepreneur Hub. Lot Fourteen, Department of the Premier and Cabinet) and Kelly May (Operations Manager) informed and provided an update on the First Nations Entrepreneur Hub and how this initiative is building capacity and capability across the Aboriginal Business Sector, in particular:

- Development and funding.
- Design and delivery team comprised of 12 First Nations business owners.
- Governance Committee formed – acknowledging the contribution of Jeffrey Newchurch and Lynette Crocker.
- Soft launch in February 2021 with website, branding, the naming of The Circle and the Business Development Support Services offered immediately.
- Official launch 27 August 2021.
- The Circle Vision.
- The Circle – Service Model.
- The Circle Hub.
- Engagement and collaboration with First Nations businesses and owners.
- Members as of 30 June 2022.
- The Circle Outcomes as of 30 June 2022.
- The Circle Team.
- First Nations Business Showcase – 27 October 2022.

Discussion ensued in relation to:

- Membership, process and criteria for acceptance to The Circle. Currently 70% of The Circle membership is 100% First Nation owned, 30% are majority First Nation owned.
- Lecture Theatre – 200 people capacity – The Circle members can attend sessions, utilise space or rent out space.

- An Innovation Hub with independence with a 5-10 year plan to be solely operated by Aboriginal interests.

- Past, present, future - truth telling and the narrative in perspective; climate change and practices on country; living together; connection to country; look at river as a living entity; legacy.
- Framework – Aboriginal component, connection & continuity.
- 'Your house is not our house' - investment and equity in one house.
- Shared vision and journey.

- Item 6.2 – Stretch Reconciliation Action Plan 2021 - 2024 Progress

Nicole Gollan (Reconciliation Officer, City Planning & Heritage, City of Adelaide) gave an update on progress for the City of Adelaide's Stretch Reconciliation Action Plan 2021-2024 in particular:

- Overall progress for the Stretch RAP is on track for its first year and planning and planning and budgeting for future projects and deliverables has been incorporated into City of Adelaide

(CoA) service planning processes.

- Action 24 – Key highlight from RAP - CoA Ongoing commitment in celebrating NAIDOC week: 2022 theme to Get up! Stand up! Show up!

CoA activations in the public realm – libraries and community centres for public engagement, including the annual Aboriginal & Torres Strait Islander exhibitions to engage the public in traditional and contemporary artworks.

Installed annual display of 25 Aboriginal & Torres Strait Islander flag banners along King William Street and Grote Street to create public awareness and promote celebration of Aboriginal & Torres Strait cultures in the City.

NAIDOC in the Mall Event including official ceremonies, cultural experiences, stall activations by local Aboriginal businesses under the Gawler Place Canopy emphasising CoA commitment to showcasing, promoting opportunities, celebrating and educating.

Feature emerging Aboriginal artist Ardnyamathanha, Narungga and Yarliyadi woman Iteka Ukarla Bromley who has stated that her artwork represents the 2022 NAIDOC theme and shows the path that people travel from different places and different walks of life both Aboriginal people from different communities and language groups and how the lives of aboriginal people can come together in unison.

Lord Mayor's NAIDOC luncheon inclusive of presentations and entertainment by Nathan May.

4th consecutive year the Lord Mayor presented a NAIDOC Award. 2022 recipient Peramangk and Kaurna man and respected Elder, Uncle Ivan-Tiwu Copley. As publicly stated by the Lord Mayor, is the longest serving member on the Reconciliation Committee, dedicating 19 years of service. He has had a deep commitment to reconciliation between Aboriginal and Non Aboriginal for more than 30 years. Dedicated his life's work both personally and professionally to achieve better outcomes for Aboriginal peoples helping educate and provide awareness of the history of the country, truth telling, achievements and enduring culture.

- **Vision:** The Adelaide Park Lands will be a globally recognised park system which surrounds and permeates our city and is central to our identity
- **Key outcome:** The Park Lands are a place of Kaurna cultural significance
- **Strategy to achieve this:** Recognise, promote and protect sites of Kaurna cultural heritage significance

Kadaltilla / Park Lands Authority

- The Adelaide Park Lands Management Strategy is prepared and maintained by Kadaltilla / Park Lands Authority
- Principal advisory body to Council and State Government on protection, management, enhancement and promotion of the Adelaide Park Lands
- Established by the *Adelaide Park Lands Act 2005*
- Lord Mayor is Presiding Member, plus four other members appointed by Council
- Five members appointed by the State Government
- Membership of the Board includes knowledge, skills and experience of indigenous culture or reconciliation

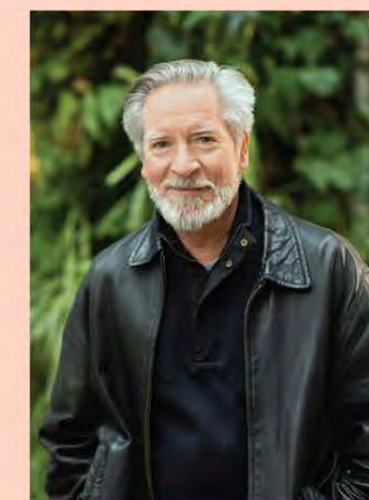

Overarching Intent of the new APLMS

The intent for the new Strategy is to become more relevant to today's context by addressing key contemporary drivers, including:

- Better representation of Kaurna culture
- Global case studies
- The role of technology
- Societal shift
- Political change.

The outcome is to identify a pipeline of priority 'step-change' projects that:

- Reflect Kaurna connection to Country
- Contribute to the identity and liveability of the city
- Attract visitors
- Protect biodiversity
- Demonstrate or celebrate the city's heritage
- Add value to the local economy
- Respond to climate change.

Current APLMS states:

Map and protect sites of Kaurna cultural heritage significance in the Park Lands.

Acknowledge the ongoing significance of Kaurna culture in the Park Lands through:

- Public art and monuments
- Interpretive signage
- Development and promotion of interpretive trails
- Incorporating culturally appropriate protocols into Park Lands management regimes
- Creation of a Reconciliation Native Garden

Current APLMS states:

Celebrate living Kurna culture throughout the Park Lands by:

- Interpreting sites of significance to Kurna people
- Walking tours such as the Adelaide Kurna Walking Trail
- Increasing understanding of Kurna culture and language through site interpretation, public art installations and promoting the dual naming of the Park Lands and Squares.
- Initiate the appointment of a ranger/Kurna heritage officer to provide interpretation and education opportunities for the community

Recognise the role of the Park Lands as a significant meeting place for Aboriginal people through the creation of a safe and inclusive spaces for all cultures and people on Kurna land

Kaurna Collaboration

Kadaltilla is seeking to collaborate with Kaurna community to develop the next Strategy for the Adelaide Park Lands

An initial conversation with Kaurna Yerta Aboriginal Corporation (KYAC) was had on 26 July 2022

The Presiding Member of Kadaltilla has written to KYAC seeking involvement in the review of the Strategy, including feedback on:

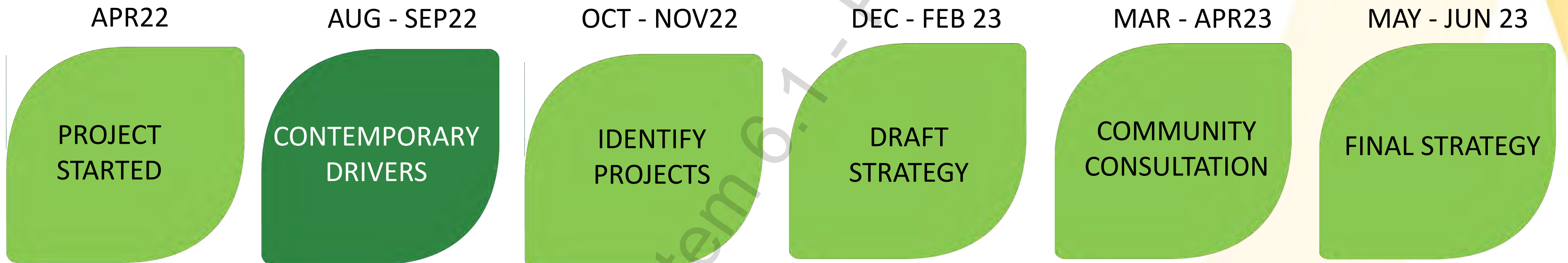
- How Kaurna culture can be best incorporated into future planning for the Park Lands?

3. The City Plan is an opportunity for an integrated and collaborative plan that addresses the unique characteristics of Adelaide and facilitates Council's vision to become the most liveable city in the world
4. **The City Plan is an opportunity to give expression to our commitment to reconciliation**

City Plan - Setting the Scene

City of Adelaide will develop a City Plan that is a spatial vision which aims to help shape the kind of future that our communities want

It will be:

1. A guide on ways to reshape the city based on a long-term vision, with a 10-year delivery focus
2. A guide for future growth and development of the city
3. A guide for future city experiences
4. A guide to inform future decisions about infrastructure investment
5. A guide to inform future amendments to the Planning & Design Code



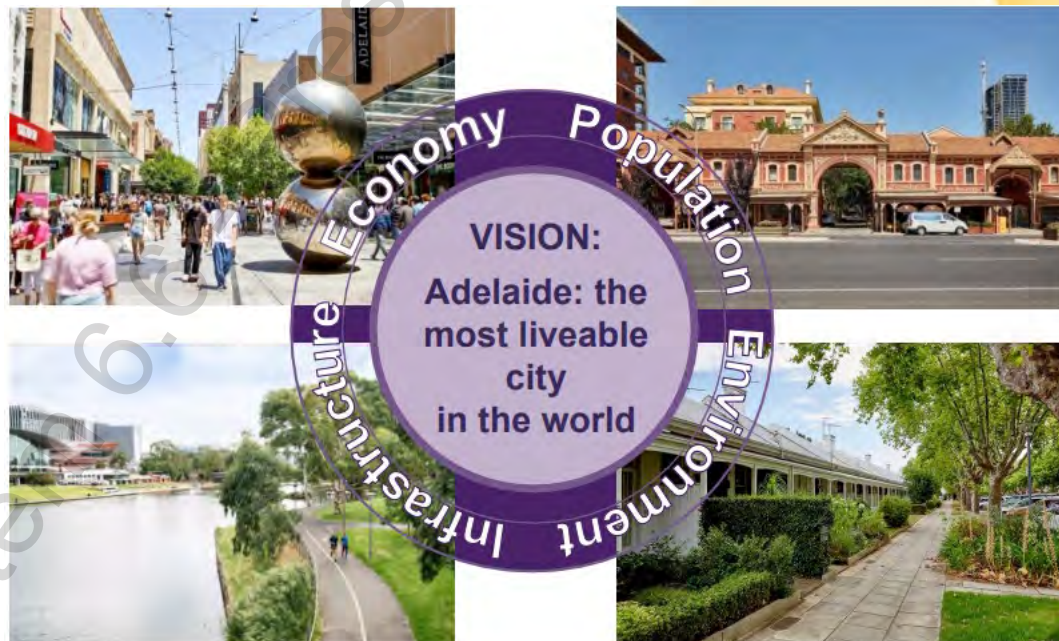

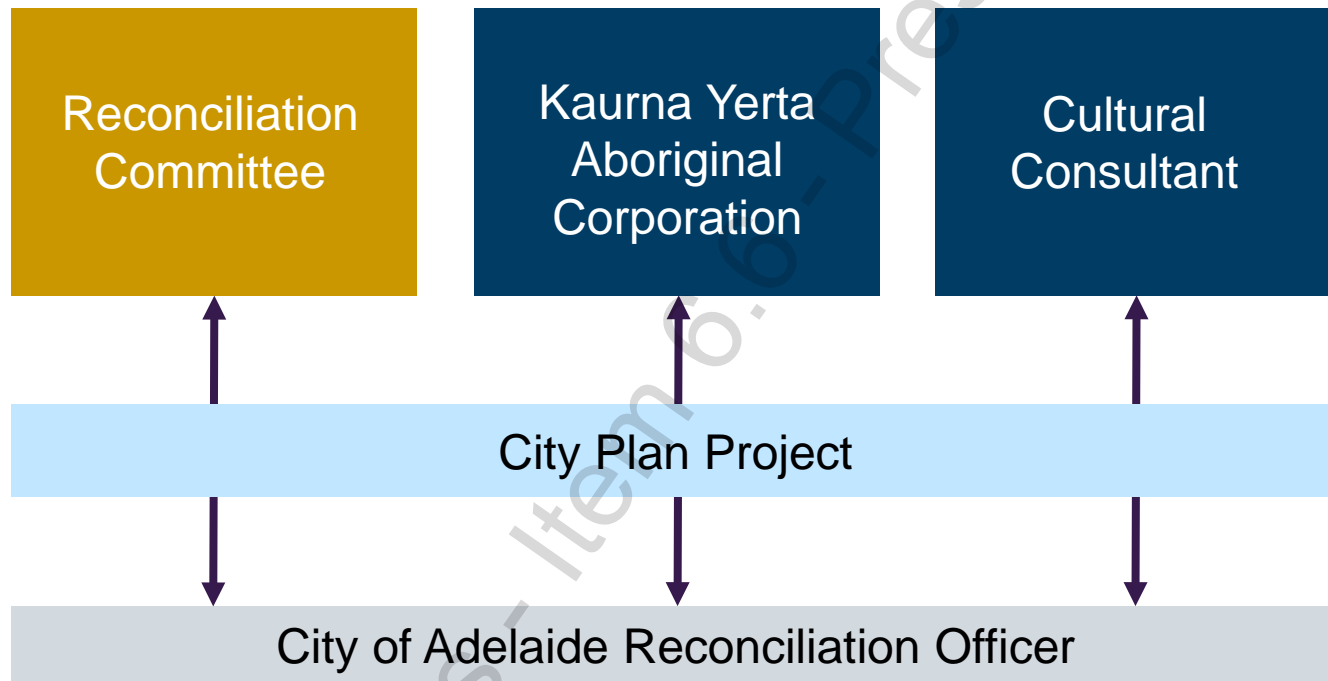
