The University of Adelaide has been involved in helping to design and Adelaide High School has been involved and hoping they will help to construct the final design.
- APPA is seeking a grant and sponsorship from Bunnings.
- The aim is for a simple transitional space that is there as people come of the tram which is a statement claiming that this will not always be car park.

Project Background

- The South Australian Government has committed \$80 million to design and build the new Adelaide Aquatic Centre within Park 2.
- The site immediately south of the existing centre was chosen in 2022 following community consultation.
- The Government has committed to:
 - No net loss of Park Lands through the project development.
 - The protection of trees along Barton Terrace West and Jeffcott Road.





Code Amendment Background

- Changes to the Planning and Design Code are proposed via a Code Amendment to:
 - Ensure the right planning policies are in place to enable a new aquatic centre to be built within Park 2.
 - Support the return of the existing aquatic centre site to Park Lands.
- The current Code envisages the redevelopment of the existing centre.
 - The Community Land Management Plan supports an Aquatic Centre.





Code Amendment

- The Code Amendment proposes to amend the Adelaide Park Lands Zone by:
 - Introducing a new Sub Zone called the 'Adelaide Aquatic Centre Sub Zone'.
 - Introducing a Concept Plan to help guide development in the affected area.
 - Removing policies that are no longer relevant.
 - Listing minor or temporary works required to build the new facility.
 - Supports aquatic centre, swim shop, café, health and wellbeing facilities i.e. Gymnasium.



Government of South Australia Department for Infrastructure and Transport

Code Amendment Engagement

- 6 weeks consultation, 23 January 2023 6 March 2023, via PlanSA.
- Activities undertaken to date:
 - Direct mail distribution to key stakeholders.
 - Letter box drop and door knocking of 57 local residences.
 - Phone calls to 40 peak associations, sports clubs and allied health providers who use the existing centre.
 - Pop Up information stand in centre foyer with opportunity to speak to project team members during peak times.
 - Signage in Park Lands.



Code Amendment Next Steps

Following the close of the Code Amendment on 6 March 2023:

- Designated Entity reviews submissions.
- Engagement Report prepared.
- Final Code Amendment prepared.
- Minister for Planning (or his delegate) assesses the Code Amendment.
- Minister makes a decision to approve, amend and approve, or refuse the Code Amendment.
- If approved, the Code Amendment is referred to ERDC for review.







Project Status Update

Design Phase:

- Commenced late 2022 with the development of the functional Design Brief (completed early February 2023):
 - Included aquatic centre end user consultation (peak sporting bodies/clubs).
 - Included public consultation.

Master Plan & Concept Design Phase:

- Commenced mid February 2023.
- Continued dialogue with City of Adelaide and Kadaltilla on remediation of Park 2 and return of existing aquatic centre site to Park Lands.

Approvals:

- Development Application lodged with SCAP following:
 - Code Amendment complete.
 - Concept Design complete.
