23 Item 11 - Lord Mayor's Reports

The Lord Mayor addressed the meeting as follows:

'The City of Adelaide has this week successfully held a citizenship ceremony for over 80 people. It was a joyful occasion marked by optimism and youthful enthusiasm.

It reminded me of the demographics in our city which is more diverse, educated, and youthful than the metropolitan area or the state.

More than 50% of us were born overseas, 40% speak a language other than English in their homes and our average age is 30, with 25% of our community being between 15 and 24.

This was apparent in speaking to the conferees who came from every continent, were generally below 40 and some were actually international students and still at university.

Previously I recall never having more than 20 new citizens at such a ceremony and it reminded me that with increasing movement and residential arrivals we need to ensure our services and information are explicit and user friendly.

On Australia Day I also attended Mourning in the Morning and an evening Light on the River. These events recognized the competing narratives that occupy our national day. The event in the morning acknowledges aboriginal dispossession and the ongoing gap in achievement That in the evening acknowledges our nation's pride, vibrancy and achievements.

The Federal Government has now reinstated our capacity to organise our citizenship ceremonies as we see fit, and on a date we nominate, so in future we can choose to hold ceremonies on an alternative day or

evening. I would propose to do so.

The Council has also supported celebrations for the Lunar New Year with the biggest street party to date in Gouger Street, at which I and a number of state leaders were privileged to speak. It is another example of the vibrant, rich and evolving culture of our City, and the contribution being made by people born overseas.'

Councillor Li will ask the following Question on Notice:

'What measures are in place to ensure the Adelaide Free Wi-Fi Project is delivered on time, within budget, and achieves the planned benefits?'

REPLY

- 1. At its meeting on 12 December 2021, Council awarded a contract to TPG Telecom to replace the Adelaide Free Wi-Fi network with the latest Wi-Fi technology utilising the Ten Gigabit Adelaide fibre network.
- 2. ADLFree powered by TPG Telecom is a \$4.8 million project jointly funded by the Australian Government and City of Adelaide as part of the \$699 million Adelaide City Deal. The City Deal is a 10-year agreement between the Australian and South Australian governments and the City of Adelaide to grow Adelaide as an innovative and vibrant city.
- 3. To ensure the successful delivery of the project, and to mitigate any risks to Council, the contract includes key milestones for TPG Telecom to achieve, and a payment schedule that is linked to Council's acceptance of the milestone certification process.
- 4. Due to the global supply chain issues in 2022, there has been a six-month delay in the overall delivery of this project. However, the delay has not resulted in any increase in the cost of the project. The revised completion date for the network rollout is June 2023.
- 5. To ensure that the network achieves the overall intended benefits of this project, the contract also identifies key service levels which include service availability, service performance, and service utilisation measures.
