EXECUTIVE SUMMARY

The Adelaide Park Lands Authority known as Kadaltilla / Park Lands Authority is the principal advisor to both the Council and the State Government on the protection, management, enhancement and promotion of the Adelaide Park Lands.

This report presents the advice of Kadaltilla / Park Lands Authority following their meeting on 30 March 2023 (see Agenda for Kadaltilla / Park Lands Authority on Thursday, 30th March, 2023, 5.30 pm - City of Adelaide)

- 1. The Adelaide Central Market Authority (ACMA) Charter 2022 (Link 1 view here) states that the appointment of Board Members to the ACMA Board requires a Board Member selection panel undertaking an expression of interest process and making recommendations to Council for Council's approval and appointment.
- 2. It is noted that the Chair Selection Panel will have to be convened first to allow for the Chair to be appointed and then sit on the Board Member Selection Panel. The specific clauses of the ACMA Charter that address the Chair and Board Member recruitment are:
 - 2.1. The following section of the ACMA Charter Clause 4.4.1.2 (a) of the ACMA Charter, "one Board Member with board leadership experience will be nominated by a Board Member selection panel, comprising the Council's CEO, the Council's senior manager in charge of human resources, and two Council Members, to be a Board Member and Chairperson".
 - 2.2. In accordance with Clause 4.4.1.2(b) of the ACMA Charter, "up to five Board Members with an appropriate range of skills and experience will be nominated by a Board Member selection panel comprising the Council's CEO, the Council's senior manager in charge of human resources, the Chairperson and two Council Members."
- 3. The current Board Members are listed below in the following table, which provides their term commencement date and date of expiry. Please note the appointment of Board Members is for a maximum 3 year term. All current Board Members are in their first term of appointment.

'That the Lord Mayor Dr Jane Lomax-Smith write to the Premier Peter Malinauskas, Attorney-General Kyam Maher and Minister Nat Cook urging the government to progress a ban on LGBTIQA+ conversion therapy practices in South Australia.'

ADMINISTRATION COMMENT

- 1. If this motion is passed the Lord Mayor will write to the Premier Peter Malinauskas, Attorney-General Kyam Maher, and Minister Nat Cook to advocate progressing a ban on LGBTIQA+ conversion therapy practices in South Australia.
- 2. The SA Labor Party made an election commitment in the lead up to the last State election.
 - 2.1. In a letter to the South Australian Rainbow Advocacy Alliance the Premier said, "Labor is fundamentally opposed to the practice of conversion therapy which tries to change someone's sexual orientation or gender identity and if elected, will work to ensure this practice does not occur in South Australia." [Link 1].
- 3. In December 2019, SA Health's Chief Psychiatrist issued a memorandum to public health mental health services, restricting gay conversion therapy in SA Health services.
- 4. On Tuesday 6 July 2022, the Hon. Stephen Wade asked the State Government to report on any identified breaches of this directive.
 - 4.1. On Tuesday 6 September 2022, The Hon. Kyam Maher reported that no breaches have yet been identified [Link 2].
- 5. A legislative ban would bring South Australia in line with Queensland and ACT who passed laws banning conversion therapy in August 2020, and Victoria who followed in February 2021.
- 6. Tasmania, Western Australia, and NSW are also considering legislation on this issue.

EXECUTIVE SUMMARY

Section 90(2) of the *Local Government Act 1999 (SA)* (the Act), states that a Council may order that the public be excluded from attendance at a meeting if the Council considers it to be necessary and appropriate to act in a meeting closed to the public to receive, discuss or consider in confidence any information or matter listed in section 90(3) of the Act.

It is the recommendation of the Chief Executive Officer that the public be excluded from this Council meeting for the consideration of information and matters contained in the Agenda.

For the following Chief Executive Officer Reports seeking consideration in confidence

18.1 Confidential Recommendations of the City Planning, Development and Business Affairs Committee [section 90(3) (b), (d) & (h) of the Act]

The Order to Exclude for Item 18.1:

- 1. Identifies the information and matters (grounds) from section 90(3) of the Act utilised to request consideration in confidence.
- 2. Identifies the <u>basis</u> how the information falls within the grounds identified and why it is necessary and appropriate to act in a meeting closed to the public.

ORDER TO EXCLUDE FOR ITEM 18.1

THAT COUNCIL:

1. Having taken into account the relevant consideration contained in section 90(3) (b), (d) & (h) and section 90(2) & (7) of the *Local Government Act 1999 (SA)*, this meeting of the Council dated 11 April 2023 resolves that it is necessary and appropriate to act in a meeting closed to the public as the consideration of Item 18.1 [Confidential Recommendations of the City Planning, Development and Business Affairs Committee] listed on the Agenda in a meeting open to the public would on balance be contrary to the public interest.

Grounds and Basis

This Item is confidential as it contains certain confidential information (not being a trade secret) the disclosure of which could reasonably be expected to confer a commercial advantage on a person which whom the Council is conducting business, prejudice the commercial position of the Council and prejudice the commercial position of the person who supplied the information and confer a commercial advantage to a third party.

The disclosure of information in this report could reasonably prejudice the commercial position of the Council with respect to its commercial dealings with the land as well as prejudice the commercial position of parties who have supplied intellectual property and commercial in confidence information.

This item contains certain information of a confidential nature (not being a trade secret) the disclosure of which could reasonably be expected to confer a commercial advantage on a person with whom the Council is conducting business, prejudice the commercial position of the Council and prejudice the commercial position of the person who supplied the information.

Council has also sought legal option on the matter and the advice provided requested that the matter should be considered in confidence due potential litigation associated with Council's decision in respect of the matter

Public Interest

The Committee is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of this information in this report, including certain financial information and further direction, may prejudice Council's future commercial dealings regarding its strategic land holding. In addition, information within this report contains the intellectual property and commercial in confidence information of parties who have supplied information which if released could negatively impact Council. On this basis, the disclosure of such information may severely prejudice the City of Adelaide's ability to influence the proposal for the benefit of the City of Adelaide and community in this matter.

The Committee is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of this information within this update pertains to non–binding commercial negotiations for the Council. The release of such information may severely prejudice the Council's ability to influence a proposal for the benefit of the Council and the community in this matter
