## **EXECUTIVE SUMMARY**

The purpose of this report is to provide a progress update on implementation of the <u>Stretch Reconciliation Action Plan (RAP) 2021-2024</u>.

The Stretch RAP 2021-2024 is a shared vision for the delivery of meaningful reconciliation between the City of Adelaide and Aboriginal and Torres Strait Islander peoples.

The Stretch RAP has actions and deliverables across four key areas: Relationships, Respect, Opportunities and Reporting.

## DISCUSSION

- 1. The purpose of this report is to provide a progress update on implementation of the Stretch Reconciliation Action Plan (RAP) 2021-2024 (**Attachment A**).
- 2. Previous reports to the Committee on implementation of the Stretch RAP were provided on <u>4 May 2022</u> and verbally on 7 September 2022.

#### **Background**

- 3. The Stretch RAP 2021-2024 builds on the success of previous City of Adelaide RAPs in guiding Council's vision for meaningful reconciliation with Aboriginal and Torres Strait Islander peoples in the city and more widely.
- 4. The City of Adelaide (CoA) is recognised by Reconciliation Australia as the first local government in Australia to reach the milestone of 10 consecutive RAPs.
- 5. The Stretch RAP 2021-2024 was developed with community and includes feedback from community engagement processes including:
  - 5.1. CoA Reconciliation Committee, allowing oversight and Aboriginal and Torres Strait Islander community endorsement of such significant cultural content.
  - 5.2. The Kaurna Yerta Aboriginal Corporation (KYAC) including Kaurna youth.
  - 5.3. The broader Aboriginal and Torres Strait Islander community in South Australia.
  - 5.4. CoA administration to:
    - 5.4.1. Ensure accountability regarding commitment to deliverables, a responsible officer (internal RAP champion), resourcing and timelines of delivery.
    - 5.4.2. Support the launch and the design of the Stretch RAP 2021-2024.

#### **Progress Update**

- 6. The Stretch RAP 2021-2024 Implementation Progress Report (**Attachment A**) outlines the progress of actions from September 2022 to April 2023.
- 7. The Stretch RAP 2021-2024 incorporates four main Action Areas with 30 Actions comprising of 116 Deliverables. Of these deliverables:
  - 7.1 26 have been completed within the agreed timeframe
  - 7.2 25 are ongoing work
  - 7.3 43 are on track for delivery as per the agreed timeframe
  - 7.4 6 are pending
  - 7.5 16 are delayed, however all are in progress:
    - 7.5.1 2 are subject to co-partner funding which is yet to be achieved
    - 7.5.2 The remainder have been retimed for delivery in 23/24
- 8. The table below outlines key achievements:

  - 9.4. NAIDOC week delivered by NAIDOC SA with City of Adelaide support and events.

#### **Next Steps**

- 10. A report will be prepared in December 2023 to align to the six-monthly updates provided to the Committee.
- 11. Preparation of the new Stretch RAP will commence towards the end of the 2023 calendar year.
- 12. The City of Adelaide and the Reconciliation Committee are leaders in promoting meaningful reconciliation. As part of this leadership role, over the next reporting period, the Committee will consider opportunities to showcase achievements of its Stretch RAP.

  - 4.4. Annual NAIDOC event hosted by the Lord Mayor including presentation of the Lord Mayor's NAIDOC Award.
  - 4.5. NAIDOC in the Mall, which will run for the fifth consecutive year and includes official ceremonies, feature artworks by local emerging Aboriginal artists and cultural experiences through stall activations under the Gawler Place Canopy.
- 5. Formal invitations and event information will be extended to Reconciliation Committee Members and Council Members closer to date, as event planning progresses.

## DISCUSSION

- 1. The purpose of this report is to consider the Voice to Parliament and to enable the Reconciliation Committee to agree on actions in response to the current process.
- 2. The State and Federal Governments have committed to establishing a First Nations Voice to their Parliaments.
- 3. The processes represent the commitment to implement the Uluru Statement from the Heart.

#### **State Government**

- 4. On Sunday 26 March 2023, South Australia became the first state in Australia to have a First Nations Voice to Parliament after the <u>First Nations Voice Bill 2023</u> was assented to by Her Excellency the Honourable Frances Adamson AC, Governor of South Australia in a special meeting of Executive Council on the steps of Parliament House.
- 5. The Bill provides a connected, direct and independent line of communication for First Nations people to South Australia's Parliament and the government, to allow important, shared communication by locally elected regional members.
- 6. The State Government has provided a two page information brochure explaining the process.
- 7. The First Nations Voice will be established through an election process for First Nations people to represent community at a local level. The presiding members of each Local First Nations Voice will become the State First Nations Voice members.
- 8. The Electoral Commission of South Australia will set a date for the South Australian Local Voice elections which will be held in 2023.
- 9. At this election, Aboriginal and Torres Strait Islander people living in South Australia will be able to vote for who they want to represent them on their Local Voice. It will be important for community to be on South Australia's electoral role to be eligible to vote.
- 10. The Commissioner for First Nations Voice, Dale Agius, is engaging with community to share information on the model that has been passed by State Parliament. More details on the first election of the Local First Nations Voices is expected to come.
- 11. Further information on how to nominate and vote in the Local Voice will be provided to the Committee as it becomes available.

#### **Federal Government**

- 12. On 1 December 2022, the Federal Government introduced the <u>Referendum (Machinery Provisions)</u>
  <u>Amendment Bill 2022</u> to Parliament taking the next step towards a referendum for a Voice to Parliament for Aboriginal and Torres Strait Islander peoples.
- 13. This means that in 2023 Australians will have their say in a referendum to recognise Aboriginal and Torres Strait Islander peoples in the Constitution through an Aboriginal and Torres Strait Islander Voice.
- 14. The Voice will be an independent, representative advisory body for First Nations peoples. It will provide a permanent means to advise the Australian Parliament and Government on the views of Aboriginal and Torres Strait Islander peoples on matters that affect them.
- 15. On 23 March 2023, the Prime Minister announced the constitutional amendment and referendum question agreed to by the Referendum Working Group and the Government. It is understood that these will soon be introduced into Parliament. The constitutional amendment and referendum question reflect the advice of the First Nations Referendum Working Group.
- 16. For a national referendum to be successful, the proposed question must receive a national majority "Yes" vote, and receive a majority "Yes" vote in a majority of states (at least 4 out of 6) as determined by the Australian people.

#### City of Adelaide involvement

17. The agenda for the Council meeting to be held on 9 May 2023 will include at a Motion on Notice regarding the Voice. The Motion on Notice seeks:

'That Council:

Consistent with successive Council terms at the City of Adelaide's in our strong support for reconciliation, agrees to recommend to all residents of the City a "yes" vote at the referendum to be held later this year to

alter the Constitution to recognise the First Peoples of Australia by establishing an Aboriginal and Torres Strait Islander Voice and asks the Administration to:

- 1. Develop a page on Council's website setting out the resolution of Council supporting the "yes" vote, together with information about the referendum including, when available, locations at which votes can be cast in our local government area, and
- 2. Arrange for official Australian Government publications related to the referendum to be accessed with an online link or, in the case of printed material, through the Colonel Light Centre, Council libraries and Community Centres.'
- 18. Administration's comment about the Motion of Notice advises that the City of Adelaide has not adopted a formal position on the First Nations Voice to Parliament and has to date treated the vote as a decision for an individual. Should Council progress this motion, We will ensure all official information is made available linked through a dedicated page on the CoA website and that official publications are made available through the Colonel Light Centre, Council libraries and Community Centres.
- 19. <u>City of Adelaide's website</u> currently includes information about the Voice to Parliament, and we will share information via social media, Libraries and Community Centres.
- 20. Administration has already contacted the Australian Electoral Commission to access its resources to share with the community.

#### **Next Steps**

- 21. This report recommends that the Reconciliation Committee recommends to Council, that Council:
  - 21.1. Supports respectful conversations about constitutional recognition of Aboriginal and Torres Strait Islanders and the Voice to Parliament at State and Federal Governments.
  - 21.2. Authorises the Lord Mayor to write to the State Government and Commonwealth Government on behalf of Council requesting that local governments and communities are kept informed on the proposals.

- An annual event in partnership with the Kaurna Community
- A program designed by Kaurna leaders to connect young people with Culture and help foster a sense of inclusion and identity
- First held in 2018 soon after the determination of the Kaurna Peoples Native Title claim
- Now an Enduring Commitment in the City of Adelaide Stretch Reconciliation Action Plan

E 2 Kids on Country | 2 May 2023





- Opportunity for Kaurna young people to connect with Kaurna Culture by walking on their Country
- Community-led learning experience for young people to enhance knowledge about Kaurna Culture
- A day to share their Culture with Aboriginal kids from other Language Groups and non-Aboriginal kids.





- One day event (9.30am-2pm) run annually in Spring
- Held in the natural area at the back of Wirrarninthi (Park 23) adjacent to the billabong where the bush tours are held
- Schools with high numbers of Aboriginal students (initially identified by Kaurna) largely from the north and south of the City
- Years 3/4/5
- Free to participants (transport, lunch and Cultural Activities supplied)
- Between 300-450 students at each event



- Cost of the event is \$30k (approx.), with partnership support from State Government/Green Adelaide
- Around 1200 students from schools around Adelaide have taken part in a range of Cultural activities - art, weaving, carving, cultural bush tours, native plant propagation, dance, wodli building, storytelling and more!
- All events have been run or coordinated by Kaurna Elders and community leaders






















- Post event surveys have shown a high level of satisfaction amongst participants
- Students highly engaged, felt proud and connected to their Culture

# Kids on Country Kaurna Cultural Activity Day Next Steps and The Future

- Next event proposed for 1 November 2023
- Opportunities to include Aboriginal kids from City schools
- Adapt Cultural activities to target older High School students
- Explore links to curriculum and tailor activities to integrate Indigenous Knowledge into STEM subjects
- Seek additional funding partners to allow the event to run over two days with greater exposure
- Open the event as a school holiday activity
- Seek to maximise reconciliation outcomes
- Explore different locations eg the new wetlands in Victoria Park/Pakapakanthi

# Kaurna Voices- Cultural Mapping





- Stretch Reconciliation Action Plan: Utilise the Kaurna cultural mapping project to capture sites of significance in the City and North Adelaide.
- City of Adelaide is currently undertaking a Cultural Mapping Project, entitled Kaurna Voices.
- The project is managed by Kaurna Cultural Consultants, Southern Cultural Immersion with input from the KYAC Board.
- Kaurna Voices involves working with a group of Kaurna Elders and Community members to create a written, visual and audio record of Kaurna Culture and personal accounts of their lives in the City.
- The information and stories gathered will be combined with existing information on Kaurna Cultural Heritage to develop a Kaurna Voices web resource for the Kaurna Community and the City of Adelaide.

# Kaurna Voices - Cultural Mapping


The project acknowledges and celebrates Kaurna Cultural Heritage through:

- The preservation, interpretation and continuation of Kaurna traditional knowledge which will help build Kaurna community capacity to hold and transfer knowledge from the past, present and into the future.
- The creation of a mixed media cultural mapping database that captures the many and varied layers of Kaurna Cultural Heritage.
- Involvement of Kaurna young people who are responsible for the collection, recording, documentation of cultural information.
- An important opportunity to put language back on Country through interpretation and stories.
- Identification of significant Cultural sites that need to be protected, acknowledged or interpreted.
- The provision of a Kaurna Cultural Lens to guide and enhance any master planning and design; Information from the project will be used by Council to better inform and enhance master planning and project implementation in the Park Lands.

# Kaurna Voices - Cultural Mapping



- In 2005 a Cultural survey of the Adelaide Park Lands was undertaken with Kaurna Elders.
- The report identified a range of sites or places of Cultural significance or interest.
- Information from this report has been consolidated into a map identifying these sites. The places and stories shown on the map is being used as the basis for the Kaurna Voices project.



# Kaurna Voices – Cultural Mapping



The project so far....

- Preparation of questions, scripts for interviews.
- Interviews and recording of stories and memories from eight Kaurna Elders and key community leaders (four women and four men)
- Written transcripts and audio and video documentation of Kaurna engagement
- Edited 3-4 minute films from each interview
- Research and collation of existing Cultural Heritage information to complement the locations and stories from the filming
- Development of bespoke webpages (in progress)

# Kaurna Voices – Next Steps

- Finalise Kaurna Voices webpages and launch first stage.
- Budget bid for next financial year to continue the project.
- Future stages would expand webpages to create a richer and more comprehensive overview of Kaurna Culture using information from previous studies and Kaurna Cultural Heritage Assessments.
- Advice will be sought from Kaurna Elders and Community Leaders on which sites (from the 80 currently mapped) and stories are progressively interpreted and presented on the website.
- The Kaurna Voices project will create a Kaurna Cultural lens over the whole City and Park Lands.
- Opportunities to incorporate Tiati/Truth Telling into the project.
