EXECUTIVE SUMMARY

The purpose of this report is to seek the Reconciliation Committee's endorsement of the draft Stretch Reconciliation Action Plan 2024-2027 (draft RAP) (**Attachment A**).

At its meeting on 6 September 2023, the Committee discussed a report outlining the approach to developing the draft RAP for implementation from 1 July 2024 (<u>Link 1</u>). This included consideration of actions to continue from the current RAP, new priorities and new artwork development.

The current Stretch Reconciliation Action Plan 2021-2024 concludes 30 June 2024. The City of Adelaide (CoA) committed to implementing 106 actions over the 2021-2024 period. Of the 106 actions, 49 are complete (47% of actions), 22 are on track for delivery on timeframe (22% of actions), 28 are being considered for extension into the next RAP (26% of actions), and five were assessed by the Committee and determined not to progress (5% of actions).

There are four types of RAP depending on an organisation's maturity in integrating reconciliation within their core business strategies and providing meaningful involvement with internal and external Aboriginal and Torres Strait Islander people in reconciliation. The City of Adelaide continues to demonstrate a high level of maturity in Reconciliation and has been pre-approved to develop a Stretch RAP by Reconciliation Australia.

The draft RAP has been developed through a rigorous consultation process with CoA employees and members of the Reconciliation Committee and Kaurna Yerta Aboriginal Corporation (KYAC).

Subject to support from the Committee, the draft RAP will be presented firstly to the City Planning, Development and Business Affairs Committee of Council and then to Council before being submitted to Reconciliation Australia for endorsement.

DISCUSSION

Background

- The purpose of this report is to seek the Reconciliation Committee's endorsement of the draft Stretch Reconciliation Action Plan 2024-2027 (draft RAP) (Attachment A).
- 2. At its meeting on 6 September 2023, the Committee discussed a report outlining the approach to developing the draft RAP for implementation from 1 July 2024 (<u>Link 1</u>). This included consideration of actions to continue from the current RAP, new priorities and new artwork development.
- 3. The current Stretch RAP 2021-2024 is due for completion by 30 June 2024. The City of Adelaide (CoA) committed to implementing 106 actions over the 2021-2024 period. Of the 106 actions:
 - 3.1. 49 are complete (47% of actions)
 - 3.2. 22 are on track for delivery on timeframe (22% of actions)
 - 3.3. 28 have been incorporated into the next RAP (26% of actions)
 - 3.4. 5 were assessed by the Committee and determined not to progress (5% of actions).

RAP Development Process

- 4. There are four types of RAP depending on an organisation's maturity in integrating reconciliation within their core business strategies and providing meaningful involvement with internal and external Aboriginal and Torres Strait Islander people in reconciliation. The four types of RAP are:
 - 4.1. Reflect: Building strong foundations assist organisations to engage in reconciliation meaningfully.
 - 4.2. **Innovate:** Implementing change outlines actions for achieving an organisation's vision for reconciliation.
 - 4.3. **Stretch:** Reconciliation leadership suited to organisations that demonstrate strong meaningful engagement with internal and external Aboriginal and Torres Strait Islander people.
 - 4.4. **Elevate:** Transformation change organisations that have a strong strategic relationship with Reconciliation Australia and actively champion initiatives to uphold the self-determination of Aboriginal and Torres Strait Islander peoples and drive systemic and transformational change at a National level.
- 5. The CoA continues to demonstrate a high level of maturity in Reconciliation and has been pre-approved to develop a Stretch RAP by Reconciliation Australia.
- 6. The draft RAP has been developed through a rigorous consultation process with CoA employees and community members of the Reconciliation Committee and Kaurna Yerta Aboriginal Corporation (KYAC).
- 7. Two internal groups have been set up to oversee the development process and provide advice as needed. They are:
 - 7.1. RAP Advisory Group: consists of Council representative (Councillor Giles), 2 Reconciliation Committee Aboriginal Community Representatives, Marketing team, Arts team and a KYAC representative. The group is responsible for engaging with the engagement consultant and Artist to ensure the development process is best practice.
 - 7.2. RAP Writing Group: consists of Reconciliation Officer, Marketing and Senior Social Planner. The writing group was responsible for interpreting the internal consultations, drafting the document and will undertake review of the document prior to final endorsement.
- 8. The CoA engaged a consultant experienced in facilitating consultation to support RAP development. The successful consultant was Reconciliation SA who designed and delivered approximately 8 consultation sessions to ensure the CoA, Reconciliation Australia and wider community aspirations were incorporated into the draft RAP.
- 9. The following engagements were completed to inform the draft RAP:
 - 9.1. 19 March 2024 CoA City Shaping portfolio leaders
 - 9.2. 26 March 2024 CoA City Services portfolio leaders
 - 9.3. 2 April 2024 CoA Corporate Services portfolio leaders
 - 9.4. 4 April 2024 CoA First Nations workshop
 - 9.5. 10 April 2024 Reconciliation Committee
 - 9.6. 11 April 2024 Kaurna Yerta Aboriginal Corporation.

- 10. The RAP is based on four themes:
 - 10.1. Relationships Building meaningful relationships supports the Council to meet the aspirations of local Aboriginal and Torres Strait Islander communities.
 - 10.2. Respect Respect for Aboriginal and Torres Strait Islander communities creates healthy relationships, embraces diversity and promotes harmony.
 - 10.3. Opportunities Providing opportunities for Aboriginal and Torres Strait Islander communities to assist Council in its goal of being a socially inclusive city.
 - 10.4. Governance Tracking progress and reporting.
 - 10.5. Under each theme is a focus area for the next three years as well as actions, deliverables, timeframes and responsibility to lead implementation.
- 11. To assist with ease of interpretation, actions in the draft RAP are colour coded against where that activity has come from. The Writing Group has considered the following when preparing actions for 2024-2027:
 - 11.1. Reconciliation Australia Stretch template: RAPs require endorsement from Reconciliation Australia. To ensure a timely endorsement process Reconciliation Australia shares a template with activity that is mandatory. These actions are coded in red. They are mandatory actions and required to be within the RAP.
 - 11.2. Consultation actions are coloured in blue. These actions are a result of the internal consultations and consultation with key stakeholders. A report was produced by Reconciliation SA which detailed high level actions and in-depth activity; this activity is included in the draft RAP 2024-2027.
 - 11.3. Kaurna actions are coloured in green. These actions have a direct impact on the Kaurna community and will require collaboration with KYAC to achieve.
 - 11.4. The draft RAP responds to the consultation themes of Leadership, Building Capability, Procurement, Engagement and Strategic Partnerships.

RAP Artwork

- 12. An expression of interest was released in early March 2024 seeking Aboriginal artists to develop new RAP artwork. An evaluation of the applicants was completed with the successful applicant We Create Print Deliver (Link 2) notified early in April 2024. The artist has committed to engaging with Kaurna leaders to ensure that Kaurna involvement is paramount in the development of the RAP artwork.
- 13. The artist was scheduled to meet with the RAP Advisory Group on 2 May 2024 to discuss the artistic brief prior to commencing the artwork. A verbal update will be provided to the Reconciliation Committee.

Next steps

- 14. Pending endorsement by the Reconciliation Committee and the Council the draft RAP will be submitted to Reconciliation Australia for their endorsement. This can take between 4-10 weeks.
- 15. Council Members will receive a briefing on 14 May 2024 prior to considering the draft RAP for endorsement, currently proposed for the 4 June City Community Services and Culture Committee, with the intent to present to Council on 11 June 2024.
- 16. Your Say Adelaide consultation will be undertaken on the Reconciliation Australia endorsed version of the RAP. Consultation will run for 4-6 weeks, this will occur following endorsement from Reconciliation Australia.
- 17. The Reconciliation Committee will have the opportunity to review the consultation feedback and the draft RAP before the draft is presented to Council for endorsement. Final endorsement of the RAP is targeting the end of the first quarter of the 2024/25 financial year (September 2024).
- 18. A launch is being planned and will follow the final endorsement, likely to be late September/early October 2024.

Governance

The City of Adelaide has established the Reconciliation Committee under section 41 of the *Local Government Act 1999 (SA)*, which is now entering its 22nd year of providing guidance to Council.

Councils Reconciliation Committee serves as an advisory body that supports the promotion of reconciliation in the city. Its responsibilities include; crafting and overseeing the implementation of the City of Adelaide's Stretch Reconciliation Action Plan, contributing to policy formulation, and offering strategic advice to the Council on matters that may affect Aboriginal and Torres Strait Islander communities.

The Reconciliation Committee is led by Dual Chairpersons, with one representing the Aboriginal community and the other representing the non-Aboriginal community. The committee is composed of representatives from the Council, strategic agencies, and includes members from the Kaurna and other Aboriginal communities.

On 13 December 2022, the City of Adelaide Reconciliation Committee appointed members for the term of Council 2022-2026.

Our Business

The Council and Administration of the City of Adelaide function carry out the duties and exercise powers as outlined in the *Local Government Act 1999 (SA)* and other pertinent legislation.

Comprising a Lord Mayor and 11 Council Members elected by the community, the Council represent the interests of Adelaide's 26,120 residents and 390,000 daily city users. Additionally, under the *City of Adelaide Act 1998*, the City of Adelaide has broader responsibilities in overseeing the city centre and the Adelaide Park Lands for the benefit of all residents, workers, students, and visitors. In response to the needs and opportunities of the city community, the Council delivers policies, programs, and services.

Our Vision at the City of Adelaide:

Our Adelaide. Bold. Aspirational. Innovative.

Achieving this vision involves implementing new projects, initiatives, and infrastructure, prioritising the well-being of the community in our decision-making processes. Annually, the City of Adelaide actively participates in numerous Reconciliation events, festivals, and activities, such as the Adelaide Fringe, Spirit Festival, National Apology Day, National Sorry Day, National Reconciliation Week and NAIDOC March and Family Fun Day.

The Executive Leadership Team is tasked with leading and developing a diverse set of teams, functions, and services to facilitate the successful execution of the City of Adelaide Strategic Plan.

The City of Adelaide has a workforce of 1034 employees, with nine individuals identifying as Aboriginal and/or Torres Strait Islander, making up 0.87% of our total workforce. Recognising the traditional land of the Kaurna Peoples, the City of Adelaide acknowledges the Kaurna People as the Traditional Owners and Custodians.

Our operations are spread across multiple sites, including the Colonel Light Centre, Eagle Chambers/Adelaide Town Hall, the Aquatic Centre, the Golf Course, the Depot, Adelaide Central Markets, the Nursery, City Libraries, Community Centres, Adelaide Bus Station, Archives, and the Prince Alfred Lane Bunker.

Our RAP Journey

The City of Adelaide is delighted to announce that this marks our eleventh Reconciliation Action Plan (RAP) and the Stretch Reconciliation Action Plan 2024-2027 as the fourth Stretch RAP endorsed through Reconciliation Australia.

In 1997, the City of Adelaide initiated a reconciliation journey with its Aboriginal and Torres Strait Islander communities. In May 2008, the Council endorsed its inaugural Reconciliation Action Plan, serving as a framework for implementing the Council's Reconciliation Vision Statement and recognising National Sorry Day.

The City of Adelaide maintains a longstanding, positive collaborative partnership with the Kaurna community, who are recognised as the Traditional Owners and Custodians of the Adelaide Plains, where the city is situated. The Council collaborates closely with the Kaurna Yerta Aboriginal Corporation, serving as the principal body of cultural authority.

A Stretch RAP involves a more extended, strategic perspective with goals spanning three years. Regular progress reports on implementation are shared with the Council throughout the calendar year, turning it into a dynamic, public document held to a high standard for its deliverables. Additionally, the monitoring of actions is supervised by our Reconciliation Officer.

Development of the RAP

The draft Stretch RAP has been developed through a rigorous consultation process with the City of Adelaide's employees and members of the Reconciliation Committee and Kaurna Yerta Aboriginal Corporation.

Reconciliation SA worked alongside our Reconciliation Officer in engagement and analysis to inform the development of our draft Stretch RAP.



EXECUTIVE SUMMARY

The purpose of this report is to provide an update following the report presented to the Reconciliation Committee at its meeting on 26 February 2024, regarding the status of the activities planned to celebrate National Reconciliation Week (27 May to 3 June 2024) and National NAIDOC Week (7 July to 14 July 2024).

1. Notes the update of activities to celebrate the 2024 National Reconciliation Week, between 27 May and 3 June 2024, and National NAIDOC Week, between 7 July and 14 July 2024, in the City of Adelaide, as contained in this report.

DISCUSSION

National Reconciliation Week (NRW), 27 May to 3 June 2024

- 1. The 2024 theme for National Reconciliation Week (NRW) is 'Now More Than Ever', which was chosen as a reminder to all of us that no matter what, the fight for justice and the rights of Aboriginal and Torres Strait Islander people will —and must —continue.
- 2. The City of Adelaide's (CoA) 2021-2024 Stretch Reconciliation Action Plan commits to providing educational and promotional support to NRW and supporting employees to attend events and participate during the week.
- 3. First Nations employees, along with members of the Reconciliation Committee, Council and Executive have been invited to the Reconciliation SA breakfast.
- 4. Flagpole banners will be displayed on King William Street and Gouger Street throughout the week.
- 5. CoA social media posts will share information about Reconciliation Week.
- 6. CoA activities during Reconciliation Week are detailed in the following table:

National NAIDOC Week, 7 July to 14 July 2024

- 7. National NAIDOC Week celebrations are held across Australia in the first week of July each year (Sunday to Sunday), to celebrate and recognise the history, culture, and achievements of Aboriginal and Torres Strait Islander peoples.
- 8. 2024 is the 50th year of the Celebration of NAIDOC. Adelaide will be the host city for National NAIDOC Week celebrations in 2024. It has been nine years since Adelaide was the host city for the national celebration.
- 9. The SA NAIDOC Committee is leading the coordination and organising of activities for the national celebration. The CoA's Reconciliation Officer is attending Committee meetings to observe and to receive regular updates on the organising Committee's activities.
- 10. The theme for 2024 is "Keep the Fire Burning! Blak, Loud and Proud!" which celebrates the unyielding spirit of Aboriginal communities and invites all to stand in solidarity, amplifying the voices that have long been silenced.
- 11. The CoA's 2021 2024 Stretch Reconciliation Action Plan commits to two annual events during NAIDOC week:
 - 11.1. **NAIDOC** in the **Mall** This event, on 9 July 2024, is for the public to participate in celebrations during NAIDOC week. The event will consist of various Aboriginal businesses, engaging activities for all ages, light refreshments, and entertainment for the duration of the event.
 - 11.2. **Lord Mayor's NAIDOC Award** This has been an annual event since 2019. The Award is given each year to a respected member of the Aboriginal community who has made significant contributions to Reconciliation in the City of Adelaide. The award ceremony has typically been held as a Civic Event for members of the award recipient's family, Reconciliation Committee members and other stakeholders involved in delivering on the City of Adelaide's Reconciliation Action Plan.

- 12. The Lord Mayor's Award ceremony has in the past few years been held as a CoA event but has historically been held in combination with the Premier's NAIDOC Awards where event activities aligned.
- 13. Due to the significance of National NAIDOC Week being hosted in Adelaide in 2024 the organising committees have agreed to combine the Awards with one event in 2024 to be held in the Adelaide Town Hall on Saturday 6 July 2024.
- 14. A Memorandum of Understanding with the SA NAIDOC Committee is being developed to confirm responsibilities and CoA funding commitment.
- 15. CoA activities during National NAIDOC week are detailed in the following table:

EXECUTIVE SUMMARY

The purpose of this report is to update the Committee on discussions with the Kaurna Yerta Aboriginal Corporation (KYAC) on Council projects in the City of Adelaide.

KYAC and the City of Adelaide (CoA) have a cooperative working relationship based on ongoing engagement about projects and their relationship to Kaurna Native Title. Meetings of the KYAC Directors and CoA Administration are held quarterly, or more frequently, to discuss projects and seek advice.

A highlight for the quarter was a meeting between the newly elected KYAC Board, the Lord Mayor and Executive Members of the City of Adelaide in April 2024.

DISCUSSION

Background

- 1. KYAC and the City of Adelaide (CoA) have a cooperative working relationship based on ongoing engagement about projects and their relationship to Kaurna Native Title.
- 2. Meetings of the KYAC Directors and CoA Administration are held quarterly, or more frequently, to discuss projects and seek advice. Meetings were held in:
 - 2.1. December 2023
 - 2.2. April 2024.
- 3. This report outlines projects discussed with KYAC since the November 2023 meeting of the Reconciliation Committee.

Kaurna Yerta Aboriginal Corporation Governance Process

- 4. In December 2023, KYAC held its annual general meeting to elect four Director roles. Following the elections the Board comprises:
 - 4.1. Existing Directors Mitzi Nam, Tim Agius and Alan Sumner
 - 4.2. New Directors Dennis Rigney, Emma Gollan, Anne Newchurch, and Mickey O'Brien.
- 5. The appointment of new Chair and Vice-Chair was completed in mid-March 2024. KYAC has previously advised that the Chair and Vice-Chair will be the KYAC City of Adelaide Reconciliation Committee strategic agency representatives. The new appointments were:
 - 5.1. Mitzi Nam KYAC Chair, and
 - 5.2. Dennis Rigney KYAC Vice-Chair.

April 2024 KYAC Pipeline meeting

- 6. The KYAC Board met with the Lord Mayor and senior members of the City of Adelaide Executive in April 2024 to discuss joint priorities and make connections with leaders in each organisation.
- 7. A pipeline meeting was subsequently held to provide an opportunity for new KYAC Directors to discuss previous items presented to KYAC. The items that were discussed included:
 - 7.1. Botanic Creek upgrade Seeking advice on preferred method of engagement.
 - 7.2. Adelaide Park Lands Management Plan Workshop with KYAC Directors to complete the Caring for Country component.
 - 7.3. Kaurna Voices Update on project direction.
 - 7.4. Red Ochre retaining wall New project to restore the retaining wall near the weir at Karrawirra Parri.
 - 7.5. *Dry area extension* Discussion about the intent of extending the dry area exemption. Suggestion for data to support the extension.
 - 7.6. Reconciliation Action Plan Action 17 Kaurna visibility.
 - 7.7. Repatriated Kaurna Artefacts Discussions about repatriation of Kaurna artefacts:
 - 7.7.1. In July 2023, following ongoing discussions with the German Embassy regarding the return of Aboriginal and Torres Strait Islander materials from Germany, Ambassador Dr Markus Ederer and representatives of the Kaurna people (Greater Adelaide region) approached the Australian Institute of Aboriginal and Torres Strait Islander Studies (AIATSIS) to organise and host a return event which will include AIATSIS and the Honourable Penny Wong Senator and Minister for Foreign Affairs.
 - 7.7.2. The Kaurna people and representatives at the Grassi Museum (Leipzig) have been discussing the potential return since 2019.
 - 7.7.3. This was not an AIATSIS negotiated return through its Return of Cultural Heritage program. However, AIATSIS welcomes the return of material from German institutions and acknowledges the shared efforts to support the community-led processes to repatriate artefacts and human remains from German collections to Australia.
 - 7.7.4. Artefacts documented to be gifted from the Pirltawardli site which is located on the North Adelaide Golf Course grounds.

- 7.7.5. Artefacts returned: Spear small, fishing net, women's digging stick and a Batton (wood splitter). Storage is being arranged at the Art Gallery of South Australia after the return ceremony.
- 7.7.6. The artefacts return ceremony was arranged for 11:00am-1:00pm, 3 May 2024 at Possum Park/Pirltawardli (Park 1).

Matter Arising

- 8. At the pipeline meeting, further engagement on the Botanic Creek upgrade project was discussed. The City of Adelaide was seeking advice on the preferred engagement method for KYAC.
 - 8.1. The project has three elements:
 - 8.1.1. Waterways management
 - 8.1.2. Vegetation management
 - 8.1.3. Cultural storytelling.
 - 8.2. KYAC has advised that they would like to be engaged at important points in the project with regular updates to KYAC about the progress.
- 9. A future item for discussion between the City of Adelaide and KYAC is recruitment of Aboriginal employees in the Adelaide Park Lands (Kaurna Rangers).
