'The City of Adelaide Reconciliation Committee acknowledges that we are meeting on traditional Country of the Kaurna people of the Adelaide Plains and pays respect to Elders past, present and emerging.

Kaurna miyurna yaitya mathanya Wama Tarntanyaku.

Ngadlurlu Kaurna Miyurna, puki-unangku, yalaka, tarrkarrila tampinthi.

We recognise and respect their cultural heritage, beliefs and relationship with the land.

We acknowledge that they are of continuing importance to the Kaurna people living today.

And we also extend that respect to other Aboriginal Language Groups and other First Nations who are present today.'

Kveta Vlotman (proxy) entered the Colonel Light Room at 2:33 pm.

The Lord Mayor then sought leave of the Reconciliation Committee to make an address. Leave was granted.

The Lord Mayor, on behalf of the Reconciliation Committee recognised the recent passing of Aunty Shirley Peisley AM and her extensive contributions to the reconciliation movement. Noting Aunty Shirley had spent six decades at the centre of social movements, great reform, and political change; including her significant role in the 1967 referendum. She was remembered as someone who operated with dignity, generosity and conviction and was a role model both for Aboriginal and Torres Strait Islander peoples and all who were fortunate enough to have met her. It was noted that her funeral would be taking place at 12:45pm on Wednesday 11 September 2024 at the Wattle Grand Chapel at Enfield Cemetery.

The Lord Mayor, on behalf of the Reconciliation Committee acknowledged the recent passing of fellow committee member Mitzi Nam's father and extended their deepest condolences to her during this difficult time.

- Ivan-Tiwu Copley asked if anyone from the Council had attended the Thursday 29 August LGA Roads and Works Conference in Hahndorf, and noted that there wasn't an opportunity for Aboriginal representation at large gatherings of the local government sector.
