- Yvonne Agius addressed the Committee to express disappointment regarding the media coverage surrounding the flying of the Aboriginal Flag at half-mast after the referendum. Yvonne Agius expressed her disappointment for the negative media coverage that resulted, noting her support for the approach to fly the flag at half-mast and apologised to the Lord Mayor for the public controversy caused by the decision. Yvonne Agius has extended an invitation to Council Members to attend future Reconciliation Committee Meetings.
- A question was raised seeking clarification of the Terms of Reference which was answered by Administration.
- The organisation Kaurna Warra Pintyanthi should be contacted to seek advice on the use of Kaurna Language for dual naming.
- A commitment was provided by Administration to inform the Committee about the decision-making process for the placement of Queen Iparrityi at Whitmore Square.
- An update on the Safer Places to Gather initiative and outreach services was provided to the Committee from Administration.
