THAT COUNCIL:

- 2. Welcomes the news that for the first time, and not the last, the Festival this year will be held in Adelaide.

'That Council:

1. Notes that the 2024 Australia China International Film Festival will be held in Adelaide in November 2024, noting that the Festival provides a unique opportunity to bolster South Australia's economy. This will be achieved not only through increased tourism but also by driving revenue for local businesses such as hotels, restaurants, and retail outlets, while further strengthening cultural ties and international relations.

- 2. Extends its gratitude to the event organiser, Shelly Yu, a member of the Adelaide Promoter Program, for her efforts in bringing this event to Adelaide, setting a precedent for future events. We note that the opening ceremony at the National Wine Centre, the Adelaide Zoo meet and greet, education and investment workshops, the Marriott Hotel accommodation partnership, and the closing ceremony at the Adelaide Convention Centre, are all hosted in venues located within the City of Adelaide.
- 3. Acknowledges that the Lord Mayor has agreed to provide a letter of welcome to the event organiser and will host a welcoming breakfast in the Queen Adelaide Room in November 2024.
- 4. Requests that the administration explore additional ways the Council can support this event, considering the organiser's willingness to continue hosting the festival in Adelaide for the next five years. Requests that the Lord Mayor provides a letter of request for funding, addressed to the Premier of South Australia, Peter Malinauskas, Minister for Tourism Zoe Bettison (Federal counterpart, Minister Farrell), and Minister for Arts Andrea Michaels (Federal counterpart, Minister Bourke), highlighting:
 - The significance of strengthening South Australia's relations with China, particularly in the areas of tourism, trade, and the arts.
 - That more than 1,000 tourism packages to South Australia have already been sold overseas, combining festival activities with sightseeing opportunities.
 - With 29% of Adelaide's residents speaking Mandarin, the city is an ideal location for this Festival.
 - The ongoing economic and cultural benefits this Festival will bring to Adelaide.
 - The potential to secure the Festival in Adelaide for the next five years, similar to the support provided by the State Government of Queensland and the City of Brisbane Council.
