Key Messages

- The Adelaide Park Lands Dry Area Regulation was implemented in 2014 as a strategy for addressing alcohol related anti-social behaviour
- In 2021, Blue Gum Park/Kurangga (Park 20) and Veale Park/Walya Yarta (Park 21) became Dry Areas 24 hours a day, 7 days a week
- A Dry Area makes it illegal to consume alcohol or carry an open liquor container in a designated public space
- The Minister for Consumer and Business Affairs has granted a short-term extension of the Park Lands Dry Area Regulation from 22 September 2023 to 22 December 2023 to allow time for targeted engagement



What is a Dry Area?

- A Dry Area makes it illegal to consume alcohol or carry an open liquor container in a designated public space
- Fines of up to \$1300 are applicable if a person consumes alcohol or has an open container
- SAPOL has the option to tip out open alcohol containers and issue a warning rather than a fine




City of Adelaide **Dry Zone Map**





Where are the Dry Areas?



About the Dry Areas?

- Most of the Adelaide Park Lands Dry Areas are timed from 8:00pm to 11:00am
- Blue Gum Park/Kurangga (Park 20) and Veale Park/Walya Yarta (Park 21) are dry areas 24 hours a day, seven days a week
- The City streets and Squares have been Dry Areas 24 hours a day, seven days a week since 2001



How long do Dry Areas apply?

- The City streets and Squares are permanent Dry Areas and do not require application for extension
- The Adelaide Park Lands Dry Areas have been reviewed every two-years since 2014
- The most recent review of the Adelaide Park Lands Dry Areas was in 2021 and is due to end on 22 December 2023



Who approves Dry Areas?

The approval process for Adelaide Park Lands Dry Areas is:

- 1. Council makes an application to State Government via Consumer and Business Services
- 2. The Liquor and Gambling Commissioner reviews the application and makes a recommendation to the Minister for Consumer and Business Affairs
- 3. If approved by the Minister, Dry Areas are made public by notice in the Government Gazette
