EXECUTIVE SUMMARY

The City of Adelaide Annual Report 2022/23 reports to the community and stakeholders on performance, achievements and planned outcomes as measured against both the City of Adelaide 2020-2024 Strategic Plan and 2022/23 Business Plan and Budget.

The Annual Report is a critical element of Council's Strategic Management Framework, serving as a point in time document of the City of Adelaide's achievements against commitments in our Vision, Strategic Plan, Business Plan and Budget and other key strategies and plans of Council.

Combined with quarterly reporting, the Annual Report is an important source of transparency and accountability to our community and key stakeholders on services, functions and projects supporting our city and its people to thrive. Council is committed to seeking and understanding our community, to ensure the services we plan and deliver meet the needs of our community.

The production of an Annual Report is a requirement of the Local Government Act 1999 (SA) (the Act). It must include any associated subsidiary annual reports of the Council and is to be considered and adopted by Council before 30 November each year.

DISCUSSION

1. In accordance with Section 131 of the Act:

“A council must, on or before 30 November in each year, prepare and adopt an annual report relating to the operations of the council for the financial year ending on the preceding 30 June.”

and

“the annual report of any subsidiary received by the council under Schedule 2 for the relevant financial year.”
 2. The City of Adelaide Annual Report must include material and specific reports on the matters specified in Schedule 4 of the Act including financial reports, legislatively required Council and Corporation practices, an annual report for any subsidiary, and achievements against Strategic Management Plans and the Business Plan and Budget.
 3. Highlights included in the 2022/23 Annual Report are:
 - 3.1. City-shaping developments that will boost residential growth, add vibrancy, and bolster the city and North Adelaide economies, this includes works and construction commenced on Market Square and Eighty Eight O’Connell.
 - 3.2. Providing additional funding and sponsorship to 18 events and festivals, including SALA, Feast Festival, Adelaide Film Festival, Illuminate and Cabaret Fringe Festival, to allow them to expand and grow
 - 3.3. Encouraging revitalisation and improvements of our main streets through grants to Adelaide West End Association and North Adelaide Precinct Association, while continuing to plan upgrades to Hutt Street, Melbourne Street and Hindley Street
 - 3.4. Investing in Green City Streets and Infrastructure with the development of an Urban Greening Strategy and further detailed design for Sturt Street greening to be finalised in 2023/24
 - 3.5. Cutting the ribbon on City Skate, Australia’s largest, Olympic-standard skate park
 - 3.6. Facilitating the local government election in November, including promotion and coordination of the elections, disbursements to the South Australian Electoral Commission and developing and delivering a training program for Council Members.
 4. The City of Adelaide Draft Annual Report 2022/23 (**Attachment A**) along with the subsidiary annual reports for Adelaide Central Market Authority (**Attachment B**), Adelaide Economic Development Agency (**Attachment C**), Kadaltilla / Adelaide Park Lands Authority (**Attachment D**) and Brown Hill and Keswick Creeks Stormwater Board (**Attachment E**), each of which have been approved by their respective boards, were presented to the Audit and Risk Committee on 6 October 2023 and will be presented to the Council meeting of 24 October 2023 for adoption.
 5. The audited financial statements for the City of Adelaide, Adelaide Economic Development Agency and Kadaltilla / Park Lands Authority will be presented to Council at its meeting of 24 October 2023. The audited financial statements will be included in these respective annual reports after this date.
 6. The audited financial statements for the City of Adelaide and each of the subsidiaries (Except Adelaide Central Market Authority), and that of Brown Hill Keswick Creek Stormwater Board (which is managed by the City of Unley as host Council), will be presented separately to this report to Council at its meeting of 24 October 2023. Council will receive these financial statements at its meeting of 24 October 2024. Adelaide Central Market Authority audited financial statements, were previously presented to the Audit and Risk Committee on 1 September 2023 and Council on 12 September 2023. These statements are included in **Attachment B**.
 7. The City of Adelaide Annual Report, along with Subsidiary Annual Reports, must be submitted to the Parliamentary Librarian of South Australia, the Director of the State Library, the South Australian Local Government Grants Commission and the National Library of Australia by 31 December annually.
 8. Once adopted, the Annual Report will be available on Council’s website with copies available at Council’s Customer Centre.
