EXECUTIVE SUMMARY

At the November meeting of the City Community Services and Culture Committee, Council will review its funding programs through a workshop, shaping the objectives and outcomes of these programs in line with its Draft Strategic Plan 2024-2028. This strategic direction will provide Administration with the parameters to align the Community Impact Grants and Strategic Partnerships Program with Council's objectives, prior to the next major funding round opening.

On 22 August 2023, Council resolved to adopt changes to the Community Impact Grants and Strategic Partnerships Operating Guidelines and noted that four categories of City of Adelaide grants would open by end of August as approved through the 2023/24 Business Plan and Budget. Council's commitment to consideration of Round One of the Community Impact Grants recommendations in November 2023, enabled eligible community applicants to seek support through the grant program to deliver their programs early in 2024.

The purpose of this report is to seek Council approval for seven recommendations for funding in excess of \$10,000 in Round One of City of Adelaide's 2023/24 Community Impact Grants, as detailed in **Attachment A**.

The total amount of grant funding recommended for approval is \$209,492, including \$139,492 in financial year 2023/24 and \$70,000 in financial year 2024/25 for three multi-year grant applicants.

DISCUSSION

- 1. The purpose of the Community Impact Grants and Strategic Partnerships Program (CIGSPP) is to provide financial support to eligible clubs, groups, educational institutions, organisations, and residents to deliver on the following Strategic Plan 2020-2024 outcomes:
 - 1.1. increase community use of and access to the Adelaide Park Lands
 - 1.2. safe and welcoming community spaces
 - 1.3. healthy and resilient communities
 - 1.4. support initiatives to achieve functional zero homelessness
 - 1.5. Aboriginal and Torres Strait Islander peoples and cultures strongly represented in city life
 - 1.6. beautiful, surprising places
 - 1.7. celebration of diverse community and collaborations.
- 2. At its meeting on 23 May 2023, Council requested a review of the CIGSPP Guidelines, in particular addressing the Assessment Criteria and reporting and communication processes.
- 3. On 22 August 2023, Council approved the current Guidelines for the CIGSPP and delivery of Round One of the Community Impact Grants.
- 4. Administration committed to delivering recommendations for Round One of City of Adelaide's 2023/24 Community Impact Grants, in November 2023 to enable eligible community applicants to seek support through the Community Impact Grants program to deliver programs early in 2024.
- 5. The CIGSPP has a budget through the 2023/24 Business Plan and Budget of \$688,000, across five funding categories:

- 6. \$276,685 of the 2023/24 CIGSPP budget has been expended. This includes an allocation of \$221,250 towards multi-year Strategic Partnerships. This funding category is expended and will not be opened for applications in the 2023/24 financial year.
- 7. If Council approves the recommendations in this report, the 2023/24 CIGSPP expended budget will total \$416,177 and there will be \$271,823 remaining in the CIGSPP budget for the 2023/24 financial year.
- 8. The report recommendations include allocations totalling \$70,000 in financial year 2024/25 for multi-year agreements, as outlined in paragraph 13.

Recommendations for Funding of Over \$10,000 in Round One of 2023/24 Community Impact Grants

- 9. Round One of the 2023/24 Community Impact Grants was open from 28 August to 25 September 2023.
- 10. 21 applications were received in this round with requests totalling \$344,145. All applications were received through the online grants management platform, SmartyGrants.

11. Seven applications are recommended for funding in this report (as listed in Attachment A) and summarised in the following table:

- 12. Applications were for a maximum of \$25,000 per application, per year, for up to two years.
- 13. Three of the seven applications recommended for Council approval are for multi-year funding. The Council approved Operating Guidelines for the CIGSPP provide for applications for multi-year funding for a Program or Community Event, capped at two years.
 - 13.1. To apply for multi-year funding an eligible project must be scheduled to be held across both 2023/2024 and 2024/2025 financial years.
 - 13.2. As part of the assessment for multi-year funding, the history and viability of the Program or Community Event is considered.
 - 13.3. Applicants who are successful in obtaining approval for multi-year funding are required to complete an acquittal report for the first year of funding received through Community Impact Grants for their Program or Community Event. This acquittal must be received and approved by the City of Adelaide before the applicant can receive the second year of the multi-year funding agreement.

Panel Assessment of Applications in Round One 2023/24 Community Impact Grants

14. Applications in Round One of 2023/24 Community Impact Grants were assessed against the CIGSPP Guidelines eligibility and assessment criteria, last approved by Council at its meeting on the 22 August 2023.

 - 15.1. Manager, City Lifestyle
 - 15.2. Team Leaders from Community Wellbeing and Social Planning and Reconciliation
 - 15.3. Project Officers from Community Wellbeing, and
 - 15.4. Grants Officer from the City of Onkaparinga as an external representative.
- 16. The Panel assessed the applications in the subcategories of Community Events and Community Programs competitively against each other.
- 17. The Panel unanimously agreed on the recommendations made in this report.

Applications Not Recommended by the Panel

- 18. Five applications over \$10,000 were unsuccessful and not recommended for funding. A summary of these applications with panel comments is provided here [Link 3 view here]. The applicants and project titles are:
 - 18.1. Mercury CX, 'Summer Cinema'
 - 18.2. YouX at the University of Adelaide, 'Mojo Mondays'
 - 18.3. Australian Young Christian Workers Movement, 'In Harmony Building a resilient community'
 - 18.4. Australian Indonesian Association of South Australia, 'Indonesian Cultural Night'
 - 18.5. The Gold Foundation, 'Work Ready Project'.
- 19. One application for funding over \$10,000 was deemed ineligible as it did not meet necessary criteria of the Community Impact Grants:
 - 19.1. Better than Yesterday Initiative, James Alexander ineligible due to being from a Sole Trader that council has not engaged with before.

Round One Community Impact Grants between \$2,000 and \$10,000

20. The Council approved Operating Guidelines for the CIGSPP provide for delegation to the Chief Executive Officer for determination and approval of Community Impact Grants valued between \$2,000 and \$10,000.

- 22. If the recommendations in this report are approved, \$271,823 of the 2023/24 CIGSPP budget will be remaining to be expended in the 2023/24 financial year.
 - 22.1. These funds will be expended through delivery of the following funding categories: Community Impact Quick Response Grants, Youth Led Grants, Community Infrastructure Grants and Round Two of Community Impact Grants.
 - 22.2. Strategic Partnerships will not be opened for applications in 2023/24 financial year as the budget has been exhausted on multi-year partnerships.
- 23. The CIGSPP will be reviewed and brought to Council for consideration in February 2024, for alignment with the Strategic Plan 2024-2028.
