## MOTION ON NOTICE

Councillor David Elliott will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

That Council:

- 1. Notes that on 09 May 2023 Council approved \$13,000 in Community Impact Grant funding for the 50th Pride March in Adelaide on 28 Oct 2023.
- 2. Request Administration to make arrangements to facilitate City of Adelaide Staff and Council Member participation in the 2024 Pride March as a City of Adelaide contingent, noting the City may be required to pay a registration fee.
- 3. Request Administration to put in place a process for ensuring and encouraging City of Adelaide Staff and Council Member engagement with future Pride Marches as a contingent.
- 4. Request Administration identify and allocate appropriate funding for the procurement of a City of Adelaide banner to be used for Pride March and Pride events.

## ADMINISTRATION COMMENT

- 1. Administration can investigate the required arrangements for the facilitation of City of Adelaide Staff and Council Member participation in the 2024 Pride March, as a City of Adelaide contingent.
- 2. Administration can investigate the resources required to procure a City of Adelaide banner for use in Pride March and Pride events.
- 3. Following investigations into the facilitation of City of Adelaide Staff and Council Member participation in the 2024 Pride March, and the procurement of a City of Adelaide banner to be used for Pride March and Pride events, a Business Plan and Budget submission may be required for additional funding in 2024/25.
- 4. Administration will continue to promote gender and sexual diversity within the workforce via its Diversity and Inclusion Awareness Dates program, and associated activities.
- 5. Administration promoted the 2023 Pride March to staff through 'The Next Edition' internal communication newsletter.
