EXECUTIVE SUMMARY

The purpose of this report is to seek Council endorsement of the draft Disability Access and Inclusion Plan 2024-2028 (draft Plan) for the purposes of public consultation.

Preparing the draft Plan is a legislative requirement under the *Disability Inclusion Act 2018 (SA)* and must demonstrate alignment with national and state disability inclusion plans.

The draft Plan replaces the City of Adelaide Disability Access and Inclusion Plan 2019-2022 and is drafted for alignment with the City of Adelaide Strategic Plan 2024-2028 endorsed by Council on 12 December 2023.

The draft Plan seeks to remove barriers and challenges people with a disability may experience in the city. It is a roadmap to how City of Adelaide will make this happen, designed in conjunction with people with lived experience of disability through our Disability Access and Inclusion Advisory Panel. The draft Plan outlines five goals:

- 1. Infrastructure that helps people to move around and navigate the city.
- 2. Liveable neighbourhoods and communities that enable everyone to participate.
- 3. Events and festivals for everyone to attend.
- 4. Businesses that are welcoming to more customers.
- 5. Inclusive customer and employee experience that is embedded into everything the City of Adelaide does.

Each goals focus is to create a positive impact for people with a disability by removing barriers and increasing opportunities to experience and enjoy the city, including a key initiative that will focus the City of Adelaide's effort for the life of the Plan (four year focus), through leadership, delivery, partnerships, facilitation and advocacy.

DISCUSSION

Background

- 1. The purpose of this report is to seek Council endorsement of a draft Access and Inclusion Plan 2024-2028 (draft Plan) for stakeholder and community consultation (Attachment A).
- 2. The preparation and publication of a Disability Access and Inclusion Plan (Plan) every four years is legislatively required under the *Disability Inclusion Act 2018 (SA)* and must demonstrate alignment with national and state disability inclusion plans. The State Government is expected to release the next four year State Plan in mid-2024.
- 3. The current State Disability Inclusion Plan includes seven outcome areas:
 - 3.1. Employment and Financial Security
 - 3.2. Inclusive Homes and Communities
 - 3.3. Safety, Rights and Justice
 - 3.4. Personal and Community Support
 - 3.5. Education and Learning
 - 3.6. Health and Wellbeing
 - 3.7. Community Attitudes.

Review Process

- 4. The City of Adelaide's Access and Inclusion Advisory Panel (the Panel) which consists of six individuals with lived experience of disability and six organisational representatives has provided oversight for developing the draft Plan.
- 5. The Panel was engaged in visioning for the Plan through two workshops facilitated by disability service consultancy Purple Orange in February 2023, and further input and feedback in August 2023.
- 6. Administration is liaising with the State Government on changes at the state and national level, including priority areas and future strategic directions.
- 7. Internal workshops and an employee survey have been used to get feedback on achievements to date, explore the visioning from the Access and Inclusion Panel and identify opportunities for the draft Plan.

Draft Plan

- 8. The draft Plan identifies five goals, each with a four year focus area.
 - 8.1. Goal 1: Infrastructure that helps people to move around and navigate the city.
 - 8.1.1. Four Year Focus: Transport Strategy Embed accessibility within the City of Adelaide city-wide Transport Strategy incorporating input from people with lived experience of disability by December 2024.
 - 8.2. Goal 2: Liveable neighbourhoods and communities that enable everyone to participate.
 - 8.2.1. Four Year Focus: Sensory Friendly Spaces Investigate potential locations and cost for quiet/sensory friendly spaces in the city and develop a dedicated space by June 2028.
 - 8.3. Goal 3: Events and festivals for everyone to attend.
 - 8.3.1. Four Year Focus: Cultural Strategy Provide opportunities for artists and people with disability to participate in arts and culture and embed in a City of Adelaide Cultural Policy by December 2024.
 - 8.4. Goal 4: Businesses that are welcoming to more customers.
 - 8.4.1. Four Year Focus: Business Access and Inclusion Program Promote inclusive businesses to raise the standard to others and support people to identify places where they will experience fewer barriers by June 2026.
 - 8.5. Goal 5: Inclusive customer and employee experience that is embedded into everything the City of Adelaide does.
 - 8.5.1. Four Year Focus: Inclusive Council Meetings Provide opportunities for more people to contribute to Council decision-making processes by June 2025.
