PURPOSE OF YOUR ENGAGEMENT

Community engagement will inform the development of a Disability Access and Inclusion Plan 2024-2028 for the City of Adelaide. The Plan guides annual actions across Council to improve outcomes for people experiencing disability. It will build on the achievements of previous strategies since 2013 including the current City of Adelaide Disability Access and Inclusion Plan 2019-2022.

We are now seeking approval to consult on the draft Plan with the general community, stakeholders and businesses regarding the goals and priorities contained in the draft Plan. The engagement will seek to encourage feedback from people with disability living, working, and visiting the city (including identified priority groups) and organisations that support people with disability.

BACKGROUND INFORMATION

The *Disability Inclusion Act 2018 (SA)* mandates local governments to have disability action and inclusion plans developed in consultation with the community. Disability action and inclusion plans guide actions across local governments to improve outcomes for people experiencing disability. All local governments must report on their plans annually to the Department of Human Services and plans be reviewed at least once in each 4-year period.

City of Adelaide has been developing a new draft Plan throughout 2023 including two externally facilitated workshops with the City of Adelaide Access and Inclusion Advisory Panel, and a series of internal staff workshops.

Council will now publish and engage on the draft Plan to:

- Inform the community of Council's strategic direction and priorities for disability access and inclusion.
- Seek feedback and suggestions to further develop the draft Plan, to final version.
- Promote awareness of the Plan among the community and businesses

Stakeholder groups will also be notified directly including the City of Adelaide Access and Inclusion Advisory Panel, Department of Human Services, the Local Government Access and Inclusion Network, and disability advocacy groups.

Following advice from City of Adelaide's Access and Inclusion Advisory Panel, there will be an easy read version of the draft Plan available, and multiple ways to access the draft and provide feedback.

Further detail is being developed by the City of Adelaide engagement team to target the lived experience of people to ensure the engagement is intersectional and includes those priority groups identified in the *Disability Inclusion Act 2018 (SA)*.

City of Adelaide's Strategic Plan 2024-2028 includes the following overarching strategic direction and actions to support this engagement:

- *Our Community - An inclusive, equitable and welcoming community where people feel a sense of belonging.*

LEGISLATIVE REQUIREMENTS

- Section 16(4) of the *Disability Inclusion Act 2018 (SA)* requires Council to engage during the preparation of a disability and inclusion plan and have regard for feedback received.
- Section 9(1) of the *Disability Inclusion Regulations 2019 (SA)* mandates a State authority (which includes Councils) must consult with people with disability, their families and carers, and persons or bodies representing the interests of people with disability. This includes publishing the draft Plan on our website and preparing a public notice.
