

# **High-Level Engagement Plan**

#### PURPOSE OF ENGAGEMENT

Council has requested a review of its current program and development of an overarching Funding Programs Policy applicable to all areas of Council and its subsidiaries, distributing funding through grants, sponsorships, incentives or strategic partnerships.

The draft Funding Programs Policy provides a framework for the multiple funding programs across the City of Adelaide and its subsidiaries and includes:

- Funding Priorities
- Funding Program Principles
- Eligibility Framework
- Funding Management Process

Through the proposed engagement, feedback from stakeholders will be sought to:

- Inform key stakeholders of Council's new draft Funding Programs Policy.
- Seek feedback on the proposed Policy to ensure it is in line with the needs and expectations of the community.

#### BACKGROUND INFORMATION

Through its funding programs, the City of Adelaide supports a diverse range of initiatives and projects that strengthen the social, cultural, economic and environmental aspects of the city and partners with the community and businesses to realise outcomes aligned with the Council's Strategic Plan 2024 -28.

This draft Funding Programs Policy has been informed by a workshop held on 7 November 2023 at the City Community Services and Culture Committee. Consultation and contribution has been sought from all City of Adelaide programs that are currently responsible for administering funding programs.

### STRATEGIC LINK

The City of Adelaide's funding programs are aligned with the with the four pillars of the Strategic Plan 2024-2028:

- OUR COMMUNITY Building a vibrant, connected and inclusive
- OUR ENVIRONMENT Creating a resilient, protected and sustainable
- OUR ECONOMY Growing and developing an innovative and responsive
- OUR PLACES Creating interesting, purposeful and safe

Funding Programs are categorised by their primary priority area outcomes; however, all eligible projects will demonstrate alignment with each of these priority areas.

# LEGISLATIVE REQUIREMENT

Council is required to engage for a minimum of four weeks on the development of a new draft policy. Council's Community Consultation Policy will be used to guide the process.
