However, for Harvest Rock 2024, DIT will facilitate the closure of Bartels Road.

The closure of Bartels Road will inconvenience motorists who rely on this route for their daily commute and/or to access nearby areas. The detours and alternate routes will result in additional travel time and disrupt regular commuting patterns, affecting those who depend on this road, especially on weekdays.

Furthermore, the closure of Bartels Road will lead to increased traffic congestion on the alternate roads, including but not limited to North Terrace, Rundle Road, and Wakefield Road. This diversion of traffic is likely to overwhelm the surrounding roads, causing delays and congestion, particularly during peak travel times. Unfortunately, the Traffic Management Centre (TMC) will face challenges in implementing effective action plans to alleviate congestion and minimise delays. Additionally, the closure will cause delays to Adelaide Metro bus services, which will need to detour and those on the alternate routes the Bartels Road traffic will divert to, therefore impacting regular commuters who rely on these services.

To address any concerns and ensure effective communication, SAPTA and TMC will require the City of Adelaide, as the venue manager, to provide a contact for customer feedbacks. Additionally, we will require the establishment of a website landing page containing detailed information about the road closures and road closure timings related to the event. A link to this page will be included on the Adelaide Metro website, ensuring easy access to the relevant information for the public.
