#### Apartment Buildings

The were several apartment buildings that we could not access after multiple attempts over the course of the Distribution. 23 & 31 Frew St were not accessible. We left 30 at both of these locations with a note from Blue Tongue on behalf of the Council.

#### **Uni Student Accommodation**

Y Suites – 128 Waymouth St. 780 apartments in this facility. The concierge / manager would only accept 5 postcards for the common area.

Would not allow access to the letterboxes after multiple attempts

Dwell - 12-18 Synagogue Place. 300 apartments. No letterboxes, they only wanted 100 for the common area.

Uni SA House – 160 Rundle Mall – no one available to chat to. No letterboxes, left 100.

Switch - (Student Hostel). 203 North Tce, 350 apartments. Left 100

Scape - 230 North Terrace. Around 500 apartments. Left 100.

City Garden Uni Lodge - 105 Gray St. 800 apartments. No letterboxes. Left 100

Uni Adelaide Village - 210 Grote St. 400 apartments. No letterboxes. Left 50.

Yugo – 269 North Tce. 680 apartments. They have letterboxes but they said they don't use them. Front desk wanted 100 and will tell the students about it as they come in.


