EXECUTIVE SUMMARY

DISCUSSION

- 1. The purpose of the Quarterly Forward Procurement Report is to provide further information and visibility to Council on major procurement and contracting activity.
- 2. The following is an extract from the Procurement Policy, adopted by Council on 14 December 2021:

"The Council will have regard to the following measures in ensuring probity, accountability and transparency"

- Council Members will be provided with a quarterly forward procurement plan for consideration, detailing tenders and subsequent contracts that have an estimated value of over \$2,000,000 (ex GST) or that are high risk and will require Council Member approval;
- Council Members will be requested to approve the award of all contracts that exceed \$2,000,000 (ex GST)."
- 3. As such, a Quarterly Forward Procurement Report is provided to Council each quarter outlining planned procurement activities with an estimated spend over \$2,000,000.
- 4. This report covers Quarter 4 of the 2023/24 financial year.
- 5. The Procurements listed in **Attachment A** of this report will be released to the market during Quarter 4 of the 2023/24 financial year. These procurements relate to delivery in the 2024/25 financial year and are subject to adoption of the 2024/25 Business Plan and Budget. In order to progress the 2024/25 capital program, these procurements will be released to the market before the budget adoption and will be "Subject to approval of the FY 2024/25 Business Plan and Budget".
- 6. Contracts will not be awarded before adoption of the 2024/25 Business Plan and Budget. There is therefore no financial risk with releasing to the market in Quarter 4 should projects not be funded in the Budget.
- 7. The Procurement Policy (Link 1) requires the provision of a forward procurement plan for expected expenditure over \$150,000 and making this publicly available on the City of Adelaide website. This report is prepared at the start of the financial year and represents an estimate of procurements based on the approved business plan and budget and upcoming expiring contracts. This is also available on the website.
