



## High-Level Engagement Plan

---

### PURPOSE OF ENGAGEMENT

Phase 1 engagement to inform the development of the draft Light Square / Wauwi Master Plan (draft Master Plan) occurred from February 2024 to May 2024 to identify issues, opportunities and ideas for the future of Light Square/Wauwi.

A draft Master Plan has been developed with the support of Oxigen Landscape Architects with subconsultants Yellaka – Karl Telfer, Kaurna cultural inputs, and WGA, Strategic Transport Planning.

This engagement plan is for phase 2, which will provide an opportunity to review and provide feedback on the draft Master Plan.

Proposed engagement will be to:

- Inform key stakeholders and the community of the City of Adelaide's draft Light Square/Wauwi Master Plan.
- Present three options for a pedestrian-centred, safe, activated, inclusive and greener Square and seek feedback on the preferred option for the Master Plan.

### BACKGROUND INFORMATION

The *Adelaide Park Lands Management Strategy 2015-2025* calls for a master plan to be prepared for all City Squares. This priority continues in the draft *Adelaide Park Lands Management Strategy – Towards 2036*, including a focus on Light Square.

The Master Plan will guide the Square's future as an important community green space in the west end of the city. A key benefit of the Master Plan will be to provide a framework for investment and partnerships to transform the Square.

The Master Plan responds to the City of Adelaide's population target of 50,000 residents by 2036. The residential population of the north-west is projected to double by 2036 and accommodate 8% of the city's population. Light Square/Wauwi is an increasingly important green space in the north-west of the city as population and density increase.
