EXECUTIVE SUMMARY

The purpose of this report is to seek endorsement of a draft Social Infrastructure (Assets) Policy (the draft Policy) (Attachment A), for the purposes of public consultation.

Development of the Policy is a strategic target in the City of Adelaide Strategic Plan 2024-2028:

"Develop a Social Infrastructure Policy by 2024 to support our current and emerging community needs".

The endorsed City Plan - Adelaide 2036, was informed by a detailed social infrastructure assessment and identifies locations for social infrastructure based on factors such as population growth, accessibility, land availability, and integration with other land uses.

To support the City of Adelaide in delivering social infrastructure, the draft Policy focuses on the buildings and spaces that facilitate the delivery of social services by governments and other service providers (referred to as social infrastructure assets).

The draft Policy aims to guide the planning and development of social infrastructure assets to better serve community needs and population growth through the timely delivery of, and equitable access to, social infrastructure.

The draft Policy is proposed to be applied through a planning framework that includes:

- Direction setting through the City Plan Adelaide 2036
- Investment planning through developing a Community Facilities Investment Plan (proposed Investment Plan) that will inform the Long-term Financial Plan (future stage of work)
- Service planning to ensure community needs are met, including marginalised and vulnerable population groups.

Pending Council decision on the draft Policy, public consultation will be undertaken in early 2025. The consultation will seek feedback on the draft Policy objectives and principles and stakeholders' priorities for social infrastructure asset planning and delivery.

Consultation feedback on the draft Policy will inform the development of a Community Facilities Investment Plan which will prioritise investment in the development, upgrade or consolidation of community facilities to meet current and future needs. The Community Facilities Investment Plan is a future stage of work and will be subject to a separate Council decision.

DISCUSSION

Background

- 1. The purpose of this report is to seek endorsement of a draft Social Infrastructure (Assets) Policy (the draft Policy) (**Attachment A**), for the purpose of public consultation.
- 2. Development of the Policy is a strategic target in the City of Adelaide Strategic Plan 2024-2028 (Strategic Plan):
 - 2.1. Develop a Social Infrastructure Policy by 2024 to support our current and emerging community needs.
- 3. The endorsed City Plan Adelaide 2036, was informed by a detailed social infrastructure assessment and identifies locations for social infrastructure based on factors such as population growth, accessibility, land availability, and integration with other land uses.
- 4. The City Plan defines social infrastructure broadly, based on definitions used in State Planning Policies and by Infrastructure Australia:
 - 4.1. Social infrastructure is the interdependent mix of facilities, places, spaces, programs, projects, services and networks that maintain and improve the standard of living and quality of life in a community.
- 5. The draft Policy focuses on the buildings and spaces that facilitate the delivery of social services by governments and other service providers (referred to as social infrastructure assets).
- 6. For the purposes of the draft Policy, Community Buildings in the Adelaide Park Lands are excluded as they are addressed through the Adelaide Park Lands Community Buildings (Sport and Recreation) Policy and Investment Plan.

Draft Social Infrastructure (Assets) Policy (Attachment A)

- 7. The draft Policy aims to guide the planning and development of social infrastructure assets to better serve community needs and population growth through the timely delivery of, and equitable access to, social infrastructure. The draft Policy:
 - 7.1. Acknowledges the role of social infrastructure in creating an equitable, inclusive and liveable city, as per the Strategic Plan.
 - 7.2. Defines social infrastructure and the Policy's role in planning for buildings and spaces. Service delivery is addressed in the application of the Policy through service planning.
 - 7.3. Sets out three Policy objectives:
 - 7.3.1. Place-based planning: Take a place-based approach to planning and developing social infrastructure assets at the neighbourhood and city-wide scale to address community needs now and for future generations.
 - 7.3.2. Equitable access: Ensure users' access to social infrastructure assets is convenient, easy, and affordable, recognising that marginalised and vulnerable populations benefit most from equitable access.
 - 7.3.3. Coordination and delivery: Enable shared investment, programming, and timely delivery of social infrastructure assets to strengthen their community value and support sustainable city growth.
 - 7.4. Includes four policy principles:
 - 7.4.1. Responsive: Responsive to current and future community need.
 - 7.4.2. Accessible: Well located and designed for access and social inclusion.
 - 7.4.3. Adaptable: Designed to be flexible and adaptable to changing needs.
 - 7.4.4. Sustainable: Sustainable delivery and operation of facilities.
 - 7.5. Outlines the City of Adelaide's roles in social infrastructure asset provision:
 - 7.5.1. Owner/Custodian/Direct Provider
 - 7.5.2. Leader
 - 7.5.3. Partner
 - 7.5.4. Facilitator

- 7.5.5. Advocate.
- 8. Application of the draft Policy is proposed to occur through a policy framework that includes:
 - 8.1. Place-based planning and assessment:
 - 8.1.1. The City Plan Adelaide 2036 sets the long-term vision and strategic goals for the development and enhancement of social infrastructure, ensuring alignment with the city's overall objectives for growth and community well-being.
 - 8.1.2. The City Plan digital tool (CoADE) will be used to determine suitable locations for social infrastructure facilities based on factors such as accessibility, land availability, and integration with other land uses.
 - 8.2. Community Facilities Investment Plan (proposed Investment Plan). The proposed Investment Plan is a future stage of work. It will:
 - 8.2.1. Prioritise investment in the development, upgrade or consolidation of community facilities to meet current and future needs.
 - 8.2.2. Include details on population and floorspace benchmarks and elaborate on design guidelines based on the agreed principles.
 - 8.2.3. Discuss funding and investment mechanisms such as government funding, developer contributions, public/private partnerships and social impact investment.
 - 8.2.4. Inform the City of Adelaide's Long-term Financial Plan.
 - 8.3. Service Planning:
 - 8.3.1. Planning services to address community needs, recognising marginalised and vulnerable population groups benefit most from equitable access.
 - 8.3.2. Recognising that in a capital city context, the City of Adelaide provides services at a regional, district and local level.

Next Steps

- 9. Subject to Council decision on the draft Policy, public consultation will be undertaken in early 2025 to:
 - 9.1. Seek feedback on the draft Policy objectives and principles.
 - 9.2. Understand key stakeholders' priorities for social infrastructure asset planning and delivery.
- 10. A high-level Engagement Plan is provided in Attachment B.
- 11. Consultation feedback on the draft Policy will inform the development of a Community Facilities Investment Plan as a future stage of work which will be subject to a separate Council decision.
