EXECUTIVE SUMMARY

The purpose of this report is to seek Council approval for grant allocations over \$10,000 for Round Two of the Community Impact Grants. Recommendations under \$10,000 are determined by the Chief Executive Officer under delegated authority and the 2021/22 Round Two applications are included in this report for noting.

DISCUSSION

- 1. The guidelines for the new Community Impact Grants and Strategic Partnerships Program were approved by Council at its meeting on 8 June 2021.
- 2. The purpose of the Community Impact Grants & Strategic Partnerships Program is to provide financial support to eligible clubs, groups, educational institutions, organisations and residents to contribute to the outcomes of Council's Strategic Plan 2020-2024.
- 3. The Community Impact Grants and Strategic Partnerships program has a budget of \$746,000 split across the following four funding categories:

4. Previous to the new Community Impact and Strategic Partnerships Program there were 3, three-year (multiyear) major grants that had been funded and carried over from 2019/20 FY. The total value of these projects was \$121,734:

- 5. The Quick Response and Community Impact Grants program launched in August 2021:
 - 5.1. Council approved the funding recommendations of \$146,825 for Round One of the Community Impact Grants over \$10,000, at its meeting on 14 December 2021. In addition, \$56,366 of funding across Round One and Round Two has been approved by the Chief Executive Officer (CEO) through delegation for amounts under \$10,000.
 - 5.2. One recipient of \$25,000, Chinatown Adelaide of South Australia Inc had to postpone the 2022 Lunar New Year 2022 Street Party. No monies were paid to this applicant, but a commitment has been made to provide \$25,000 from the 2022/23 budget to support the event in February 2023.
 - 5.3. Up to the 5 April 2022, 33 Quick Response grants have been approved by CEO under delegation with \$49,725 of funding allocated.
 - 5.4. Council approved the funding recommendations of \$100,000 for Community Infrastructure Grants at its meeting on 8 March 2022.
 - 5.5. Strategic Partnerships to the value of \$154,250 were approved by the CEO under delegation on 1 March 2022.
- 6. Round Two of Community Impact Grants was open 9 February to 28 March 2022:
 - 6.1. 25 applications were received with requests totalling \$472,345. All applications were received through the new grants program Smarty Grants.
 - 6.2. Applications were initially assessed by the Grants Coordinator. Final recommendations were then agreed at an assessment panel consisting of the Manager of City Lifestyle and Team Leaders from Community Wellbeing, Community Lifestyle & City Planning & Heritage internally, as well as Wellbeing SA's Manager of Strategy & Wellbeing, as an external representative.
 - 6.3. 12 applications over \$10,000 were unsuccessful and not recommended for funding. A summary of these applications is provided at Link 2 view <u>here</u>.

- 6.4. Five applications are recommended for funding in this report (as listed in **Attachment A**). All grant agreements are for one year.
- 6.5. Four applications totalling \$23,315 under \$10,000 were approved through CEO delegation in April 2022, with a further four applications under \$10,000 not recommended for funding [Link 3 view here].
- 6.6. The table below presents a financial breakdown of all funding approvals and recommendations to date, for the Community Impact Grants & Strategic Partnerships Program:
