Councillor Couros will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

'That Council:

- 1. Notes the amazing work that Deputy of the City Council of Vinnytsia Andriy Pizhevsky is doing with the youth in Vinnytsia
- 2. Investigates a memorandum of understanding between the city of Adelaide and the city of Vinnytsia with regard to youth education and cultural offerings.'

ADMINISTRATION COMMENT

- 1. As part of Council's broader program of support for the Ukraine community, the Lord Mayor and the CEO extended an invitation to Mr Andriy Pizhevsky, Deputy of the City Council of Vinnytsia, Ukraine to meet with Council and our Executive during his visit to Adelaide in April 2022. Mr Pizhevsky shared insights into the City of Vinnytsia, its activities, and its vision for the future.
- 2. A review of the City of Adelaide's Sister Cities, Friendly Cities, and international partnerships has been conducted and was presented to Council at Item 10.6 Sister Cities Review at its 10 May 2022 meeting (the review).
- 3. The review identified that an assessment framework for international partnership opportunities is necessary. It is recommended that a draft framework be presented to Council by December 2022.
- 4. Entering a Memorandum of Understanding (MoU) is the preferred approach to establishing international partnerships.
- 5. If this motion is carried, administration will begin by considering the alignment of Vinnytsia's Strategic Plan with the City of Adelaide Strategic plan, before assessing an MoU against any framework adopted by Council.
- 6. If strategic alignment is found, and the opportunity is favourably assessed against the new framework, then we would also seek to engage and connect relevant organisations, focused on youth education and cultural offerings, as part of any MoU between the two cities.
- 7. It is important to note that any future opportunities which are investigated and proceed to the point of entering an arrangement will need to be reported through the Commonwealth Government's Foreign Arrangements Scheme for approval by the Minister.
